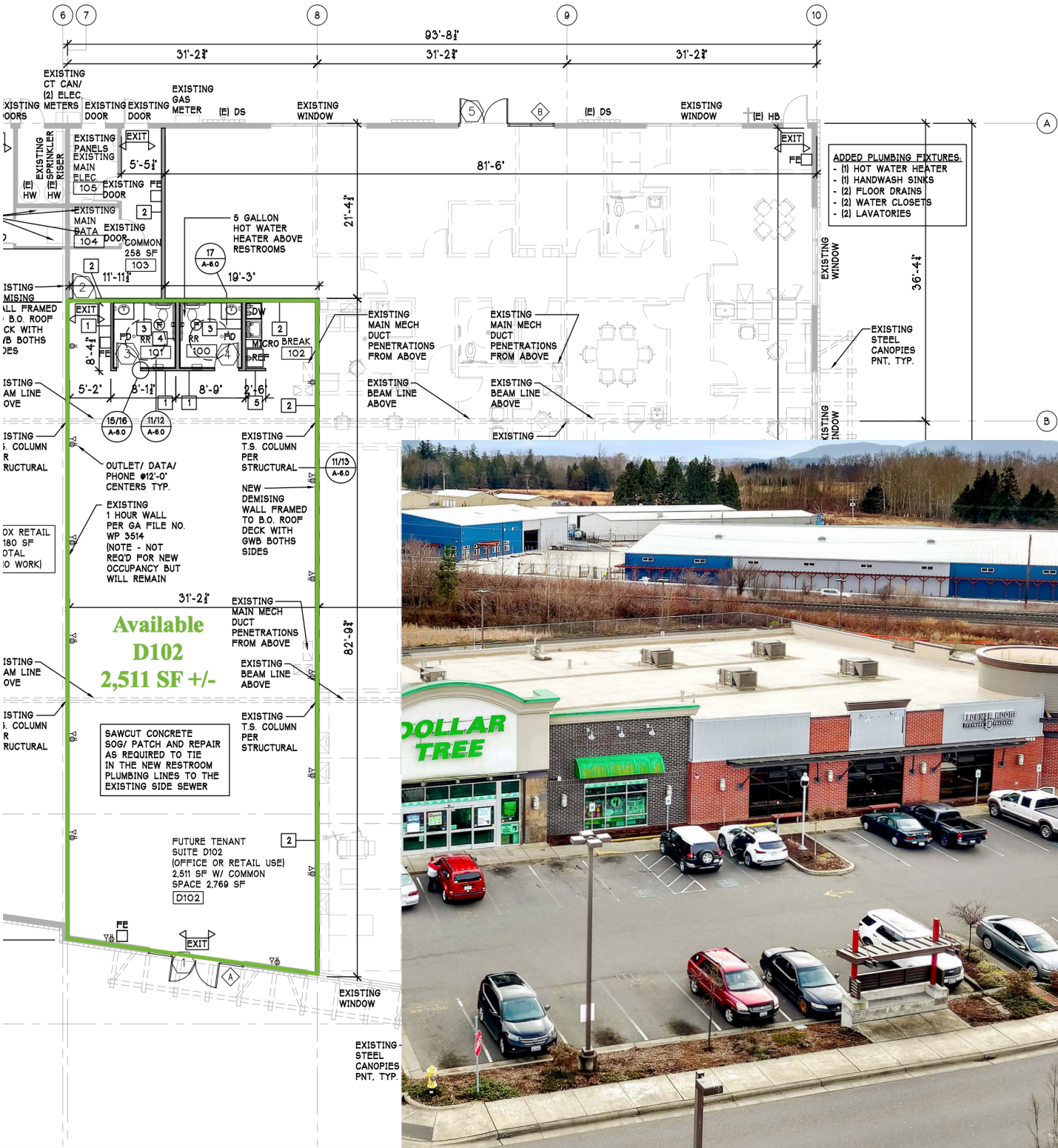

Ferndale is located near the Nooksack River in Whatcom County, approximately 6 miles north of Bellingham and 13 miles south of the Canadian Border. Ferndale is one of the fastest growing cities in the Northwest.
