

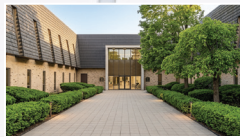

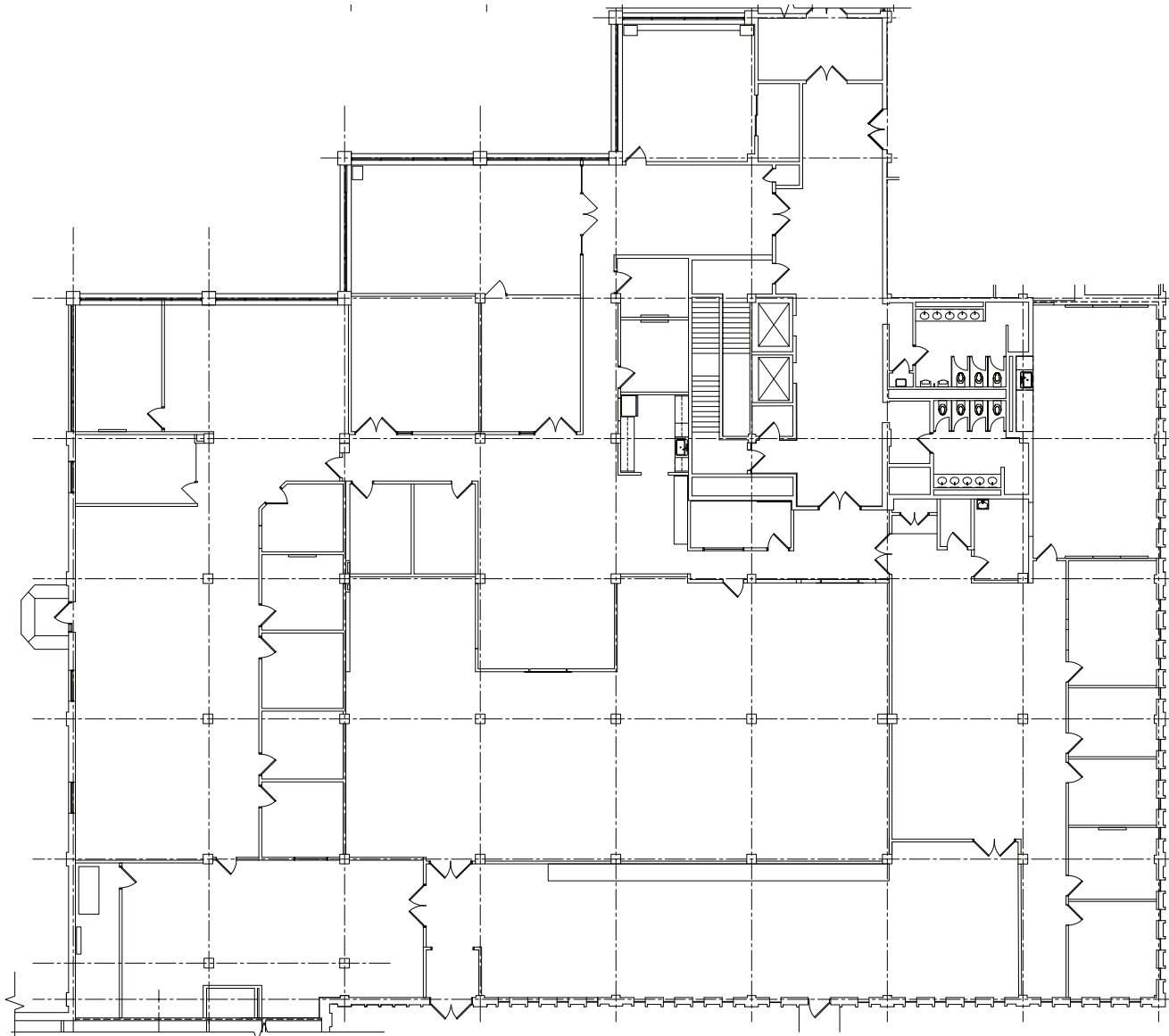

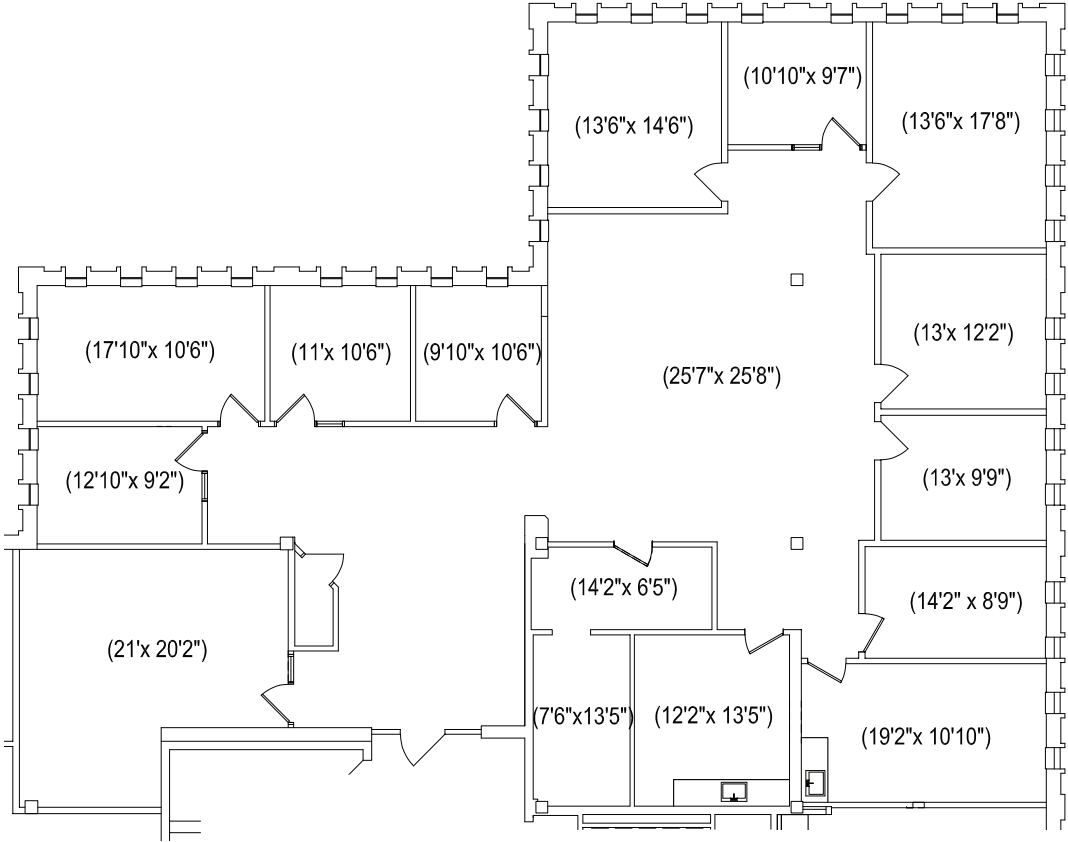


**Suite 100 Floor Plan**

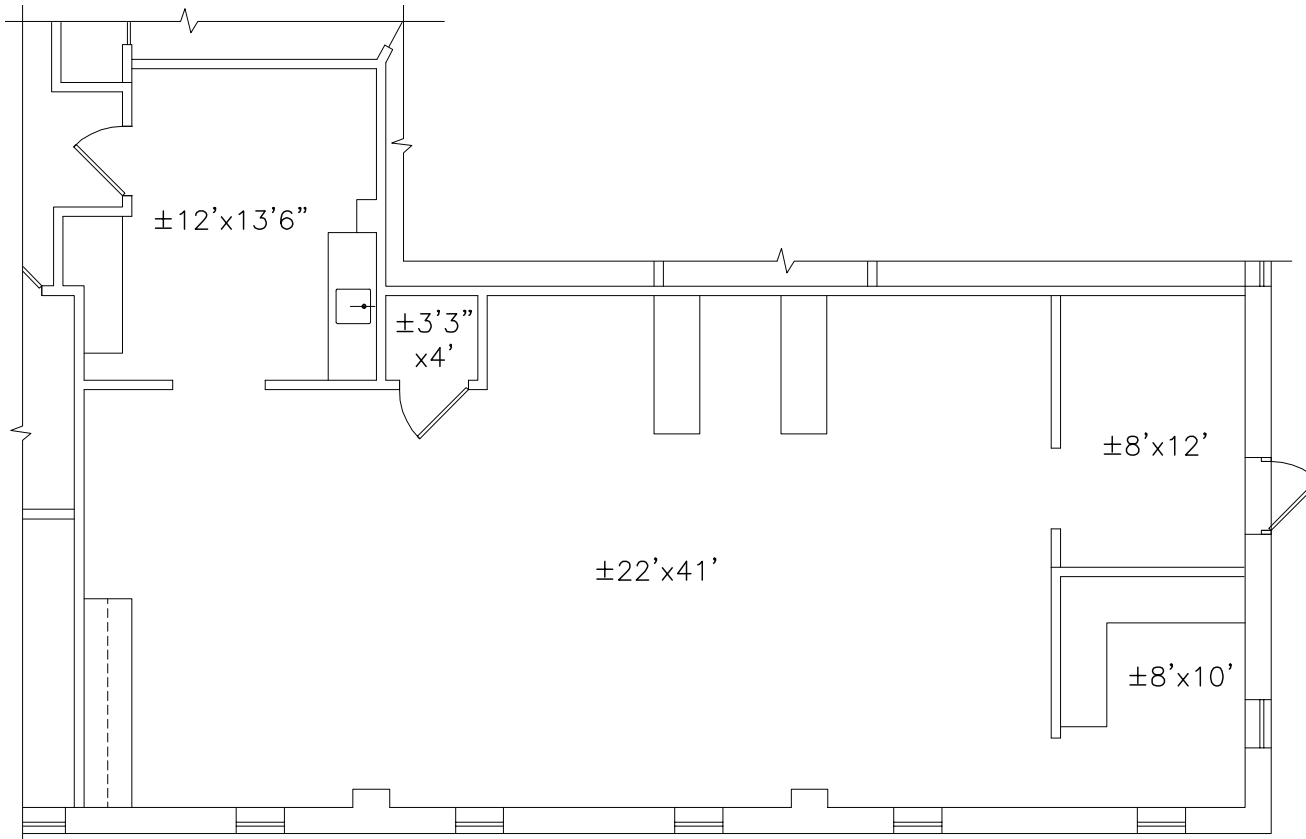

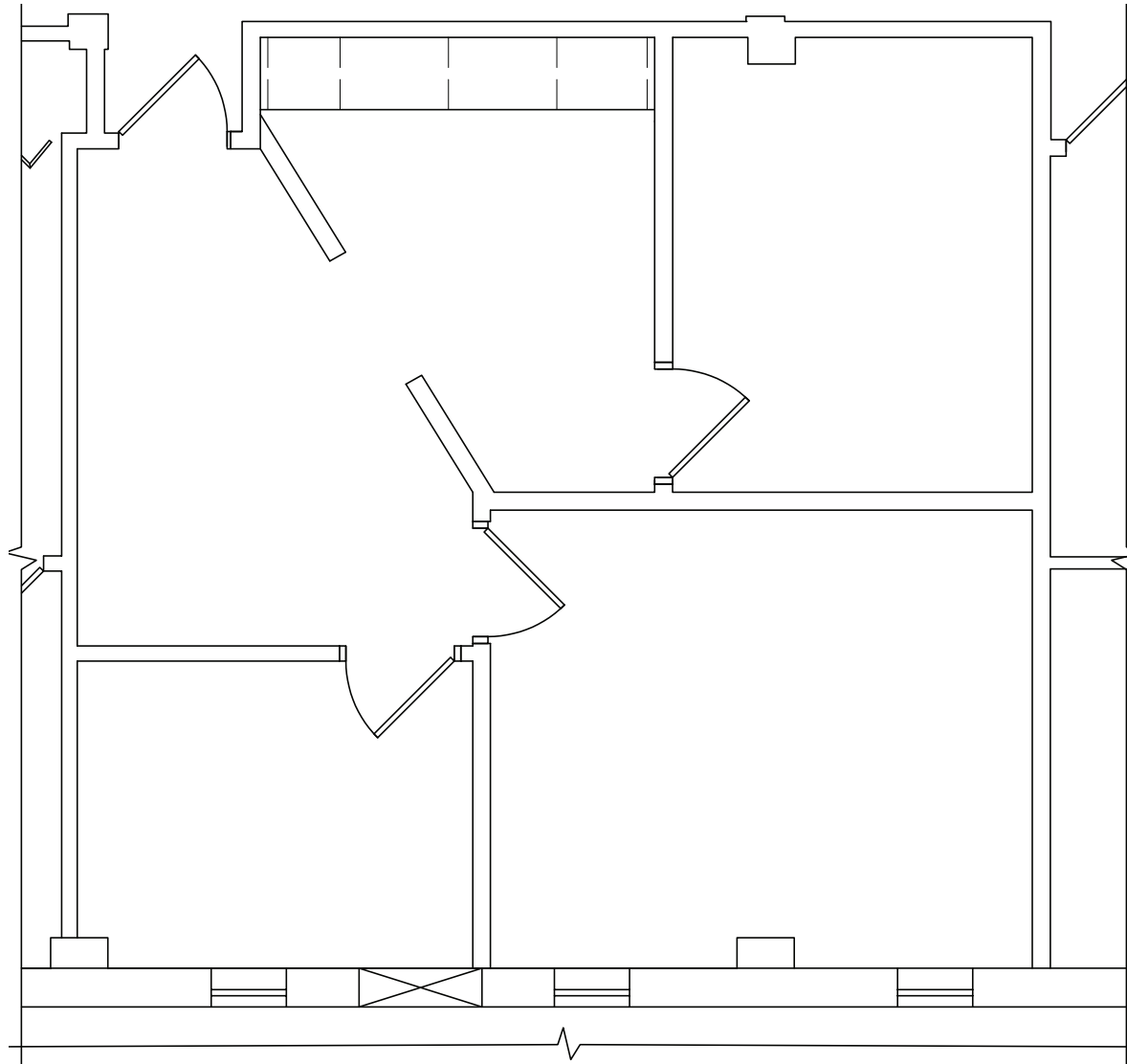


**Suite 104 Floor Plan

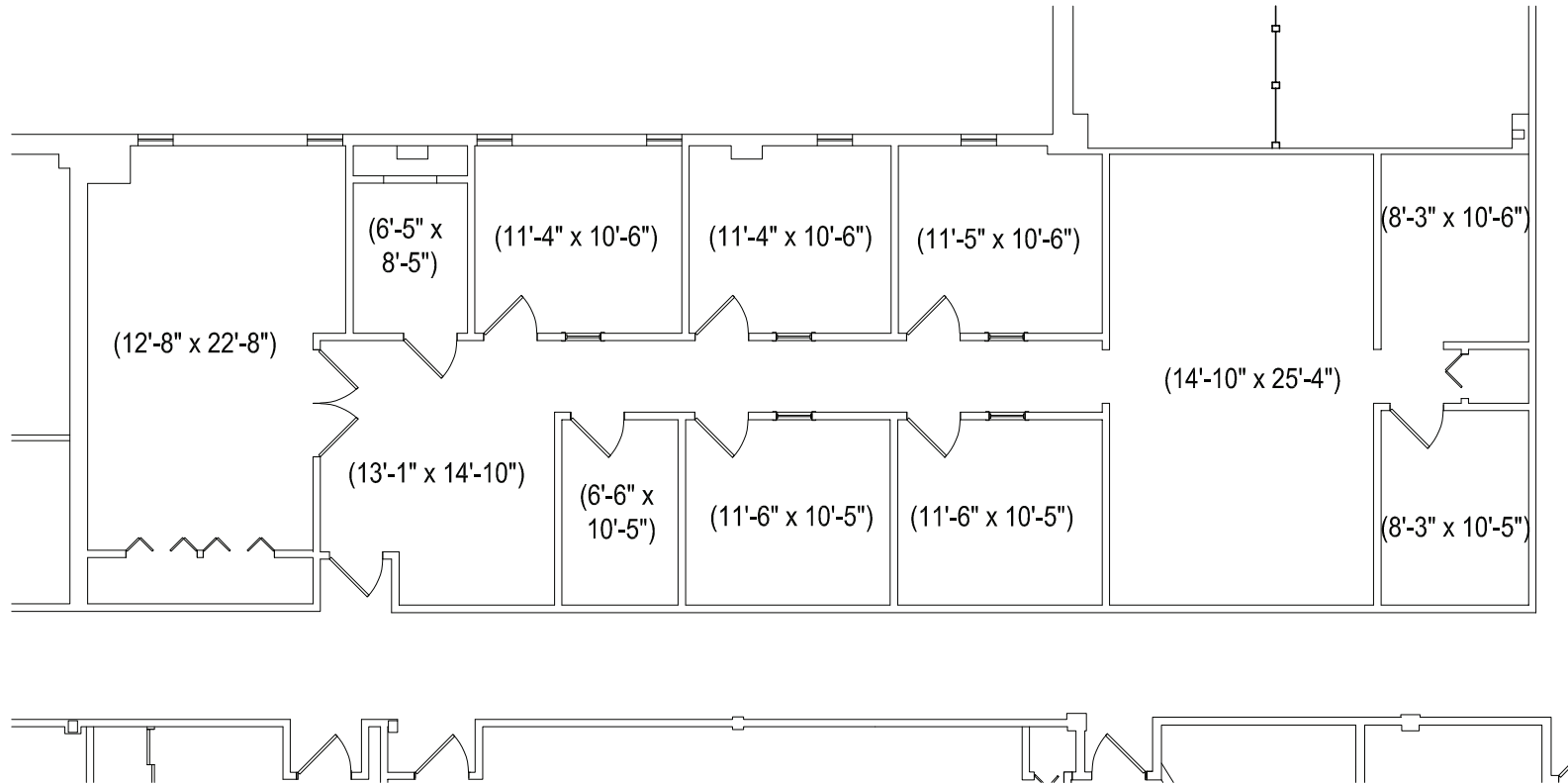

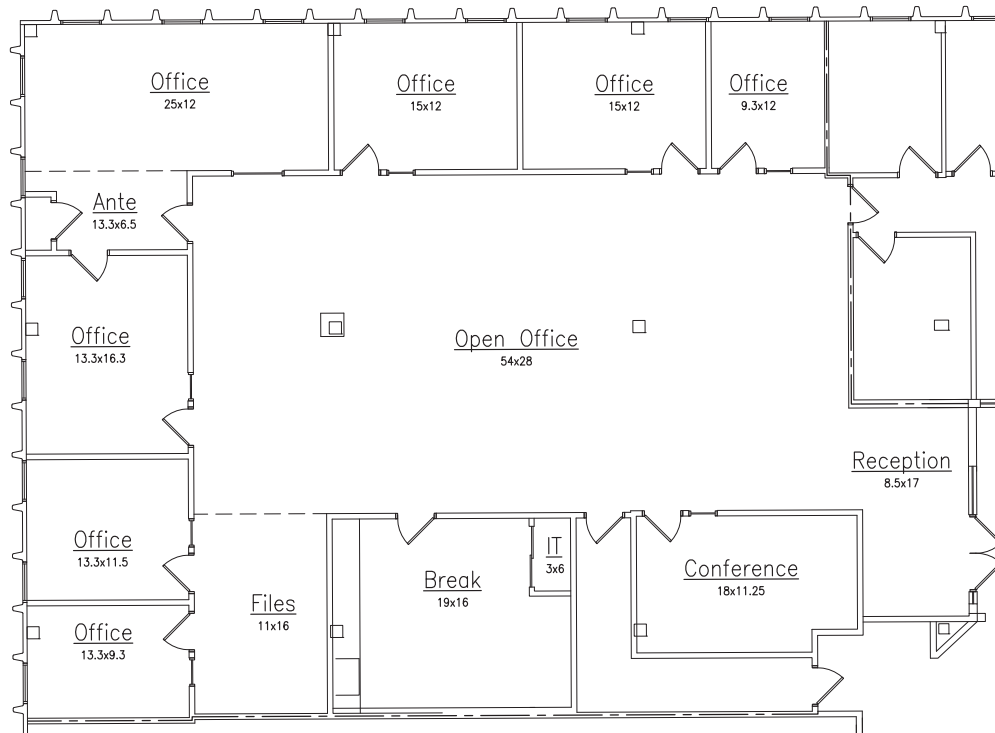

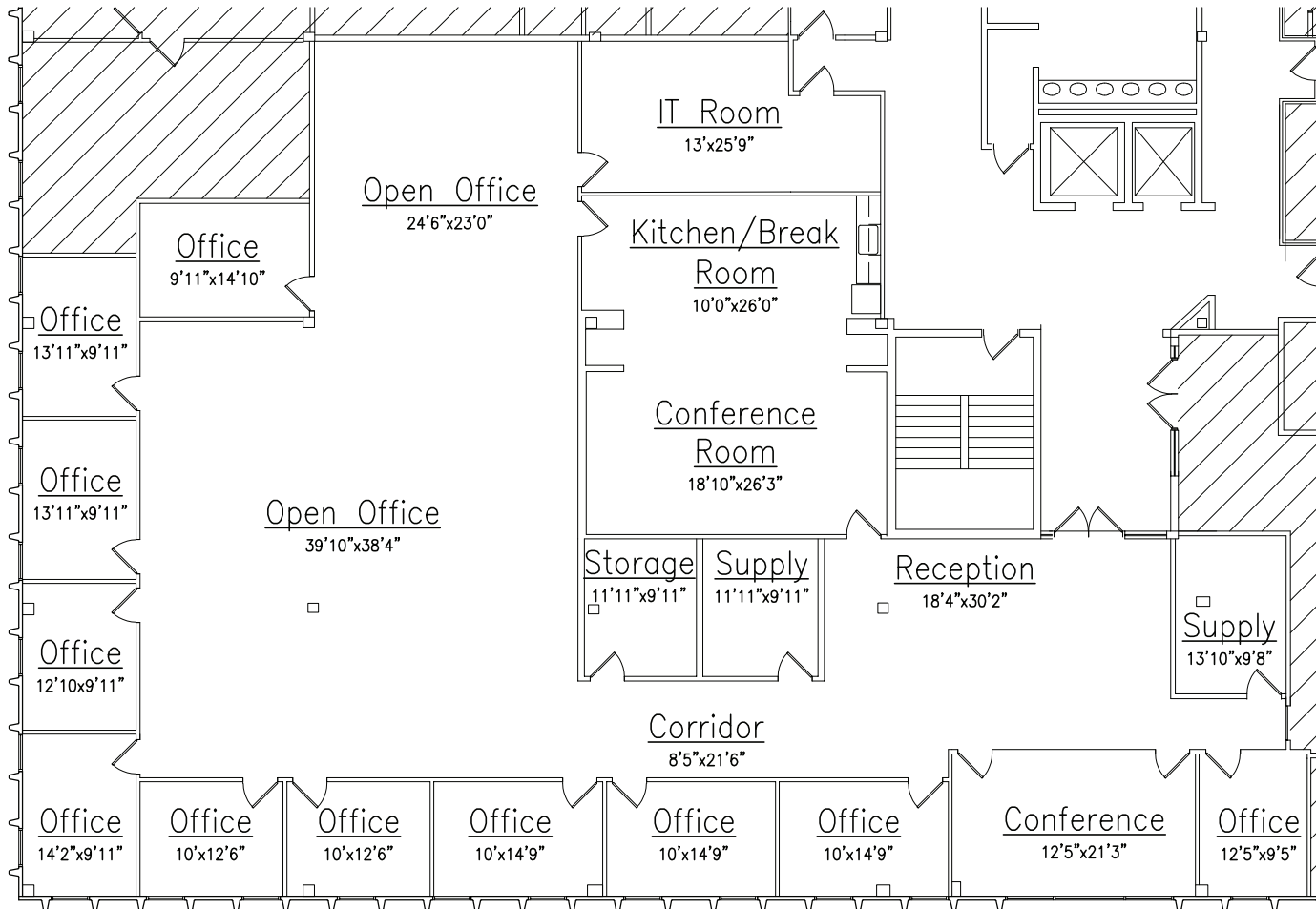


**Suite 259 Floor Plan

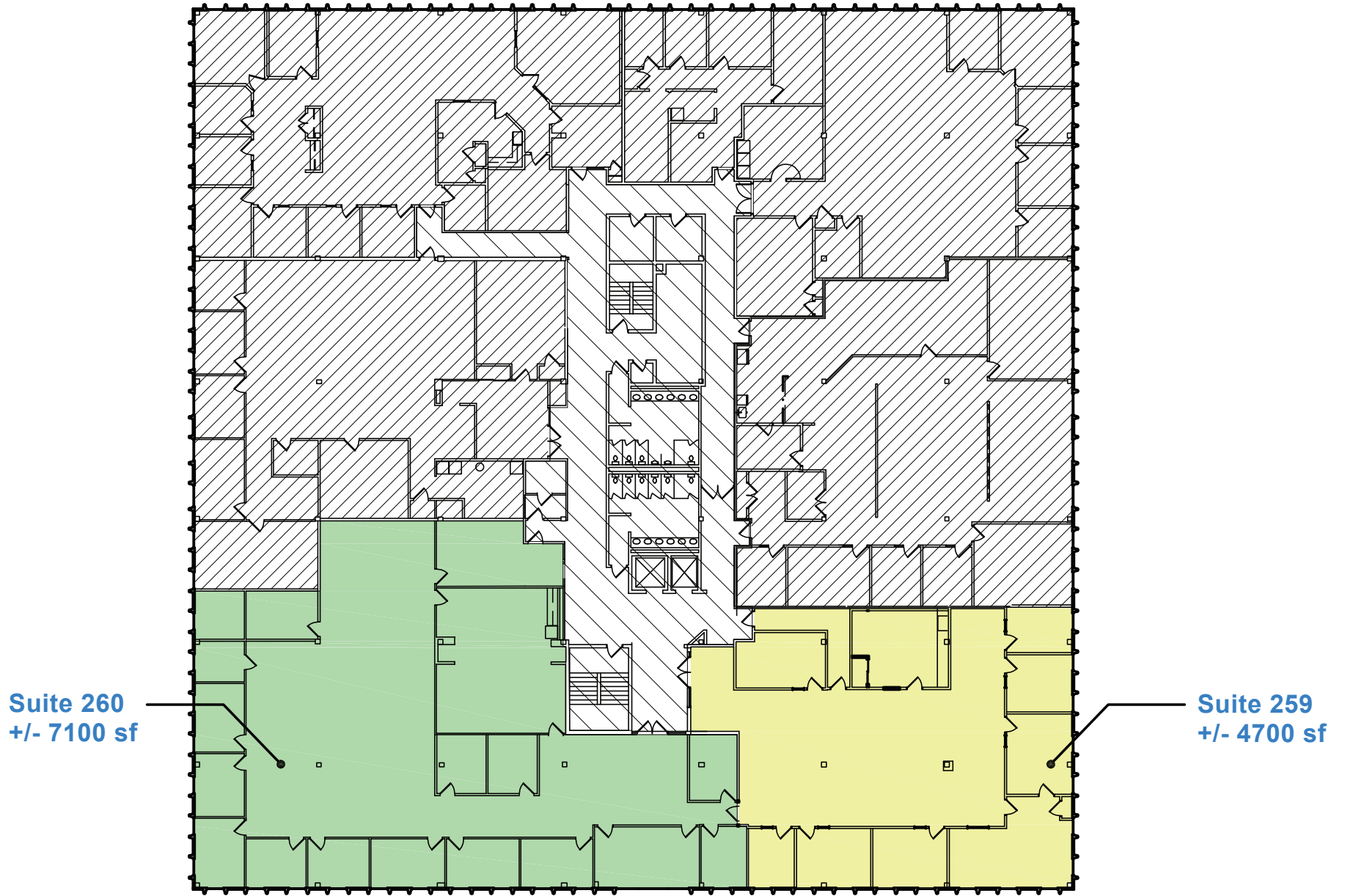

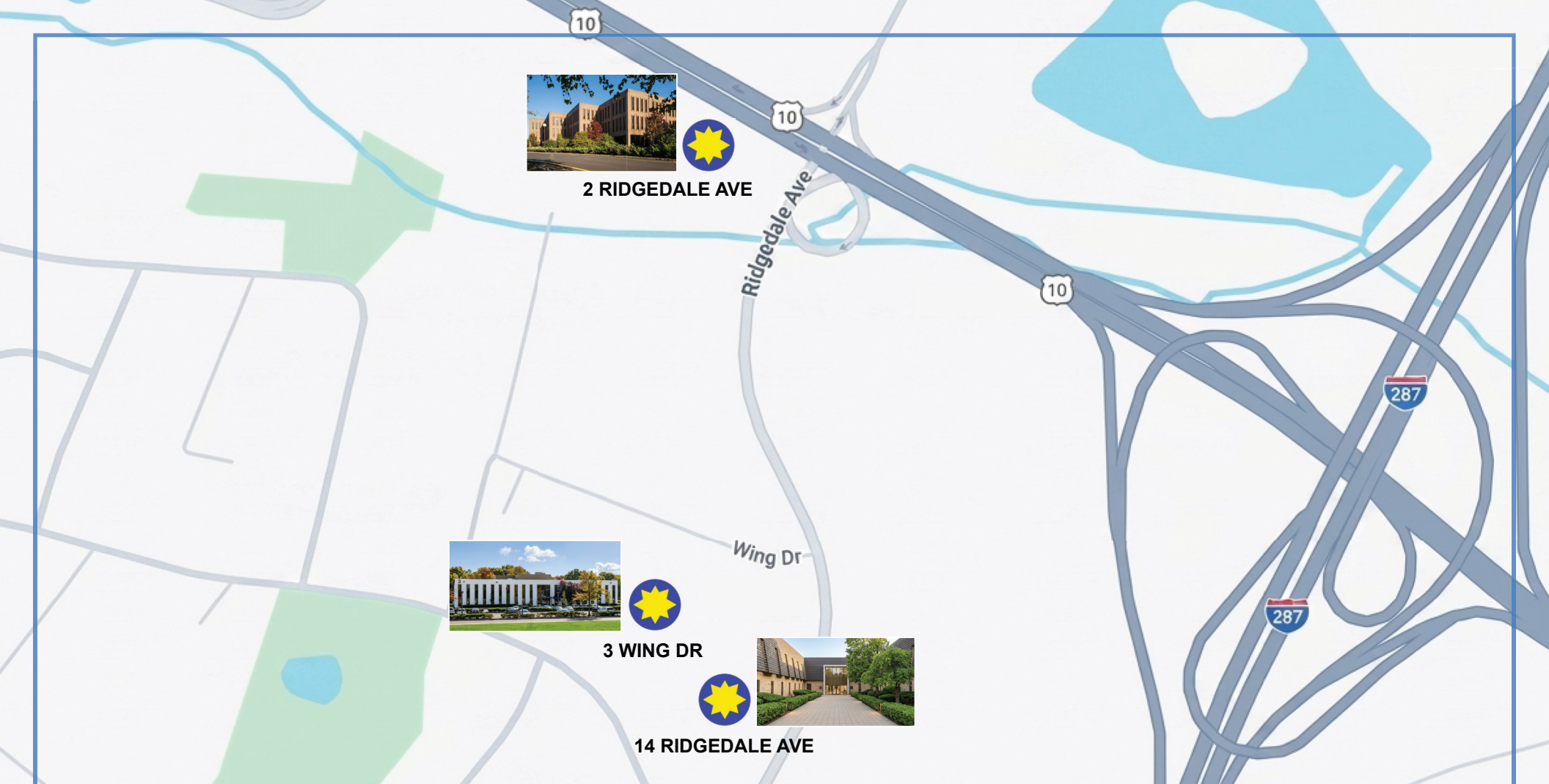
