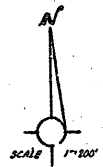
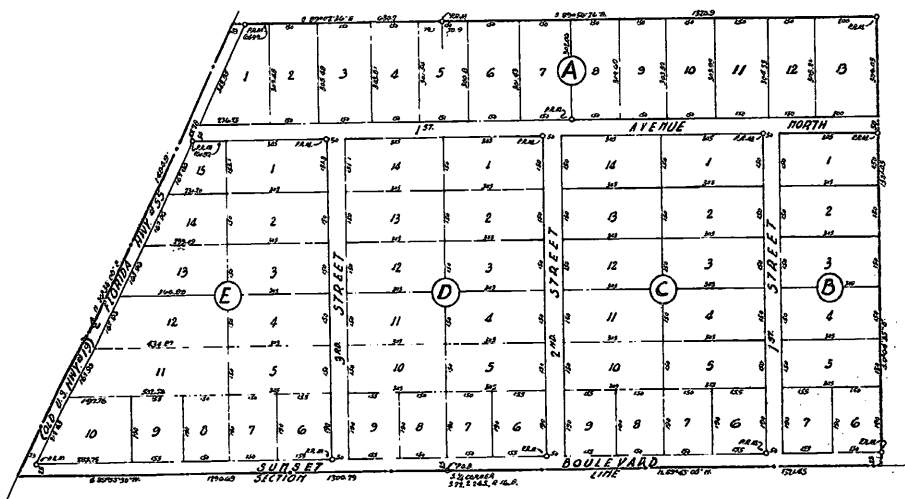


GULF SIDE ACRES

DESCRIPTION: FROM THE SOUTH ONE QUARTER CORNER OF SECTION 22, TOWNSHIP 24 SOUTH, RANGE 16 EAST, PASCO COUNTY, FLORIDA AS A POINT OF BEGINNING, RUN SOUTH 89°57'30" WEST, 1296.60 FEET TO CENTER LINE OF FLORIDA HIGHWAY NO. 55, THENCE NORTH 29°36'00" EAST, 164.9 FEET, ALONG SAID CENTER LINE, THENCE SOUTH 89°57'30" EAST, 634.7 FEET TO PARTIAL ACRE CORNER; THENCE SOUTH 89°56'16" EAST, 634.0 FEET, THENCE SOUTH 0°04'35" EAST, 131.05 FEET, THENCE NORTH 85°45'00" WEST, 131.45 FEET TO POINT OF BEGINNING.
