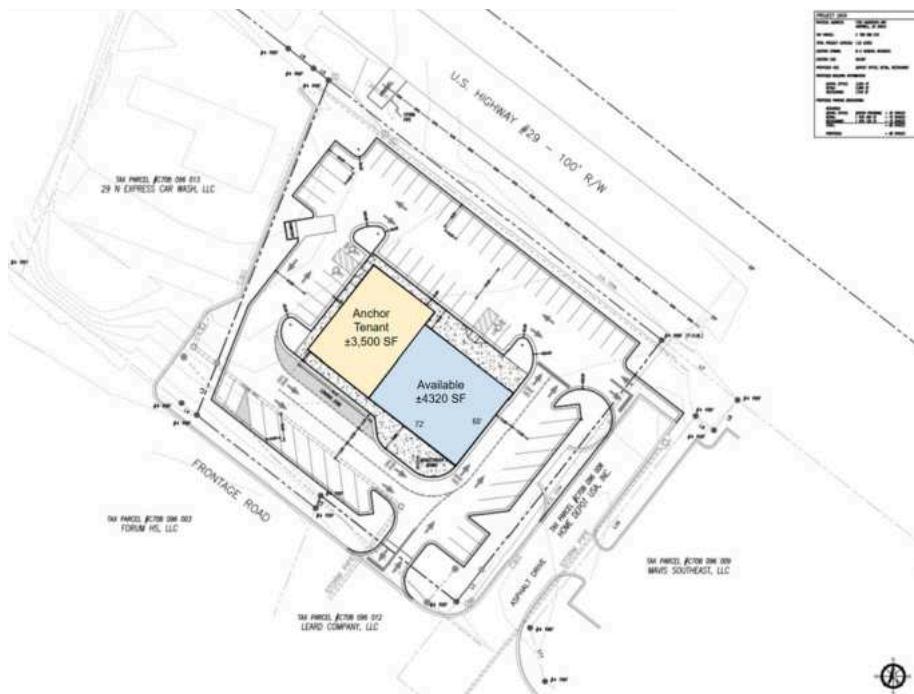

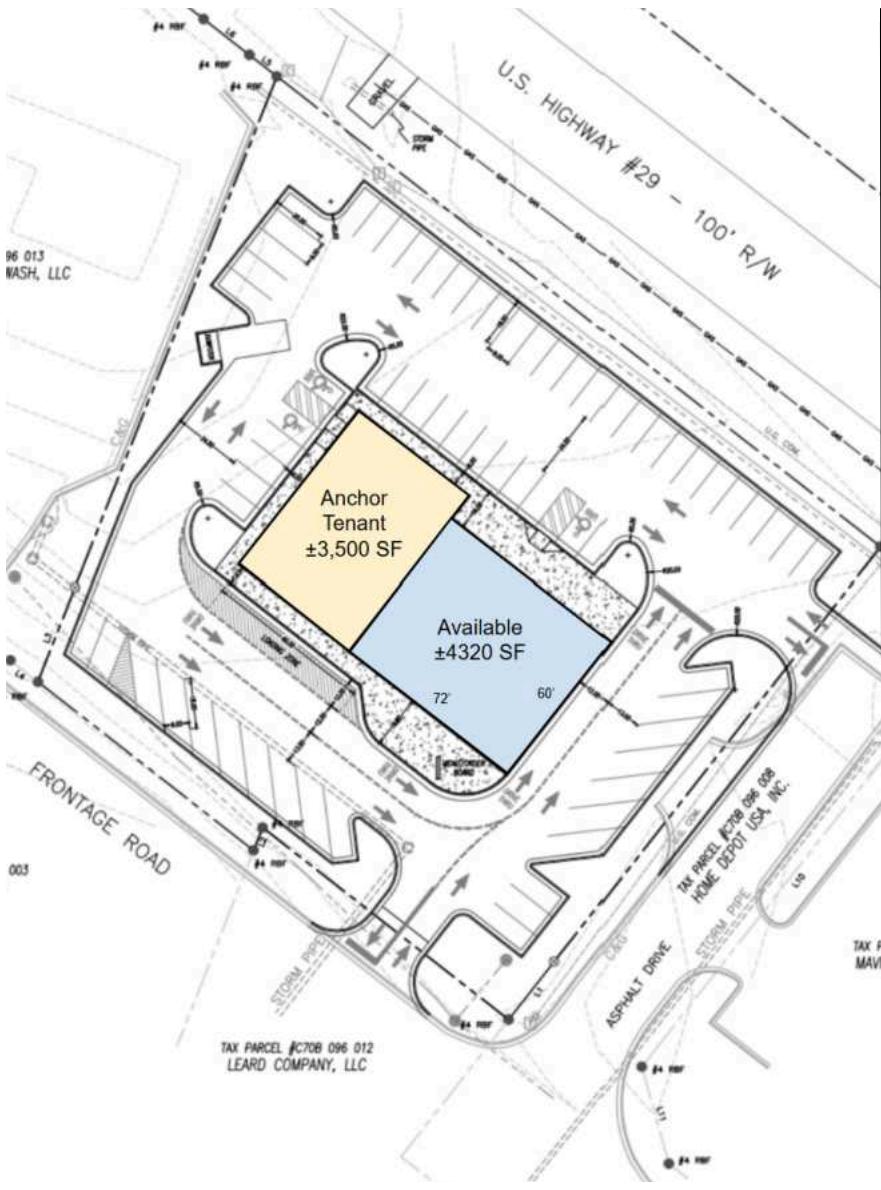
EXECUTIVE SUMMARY

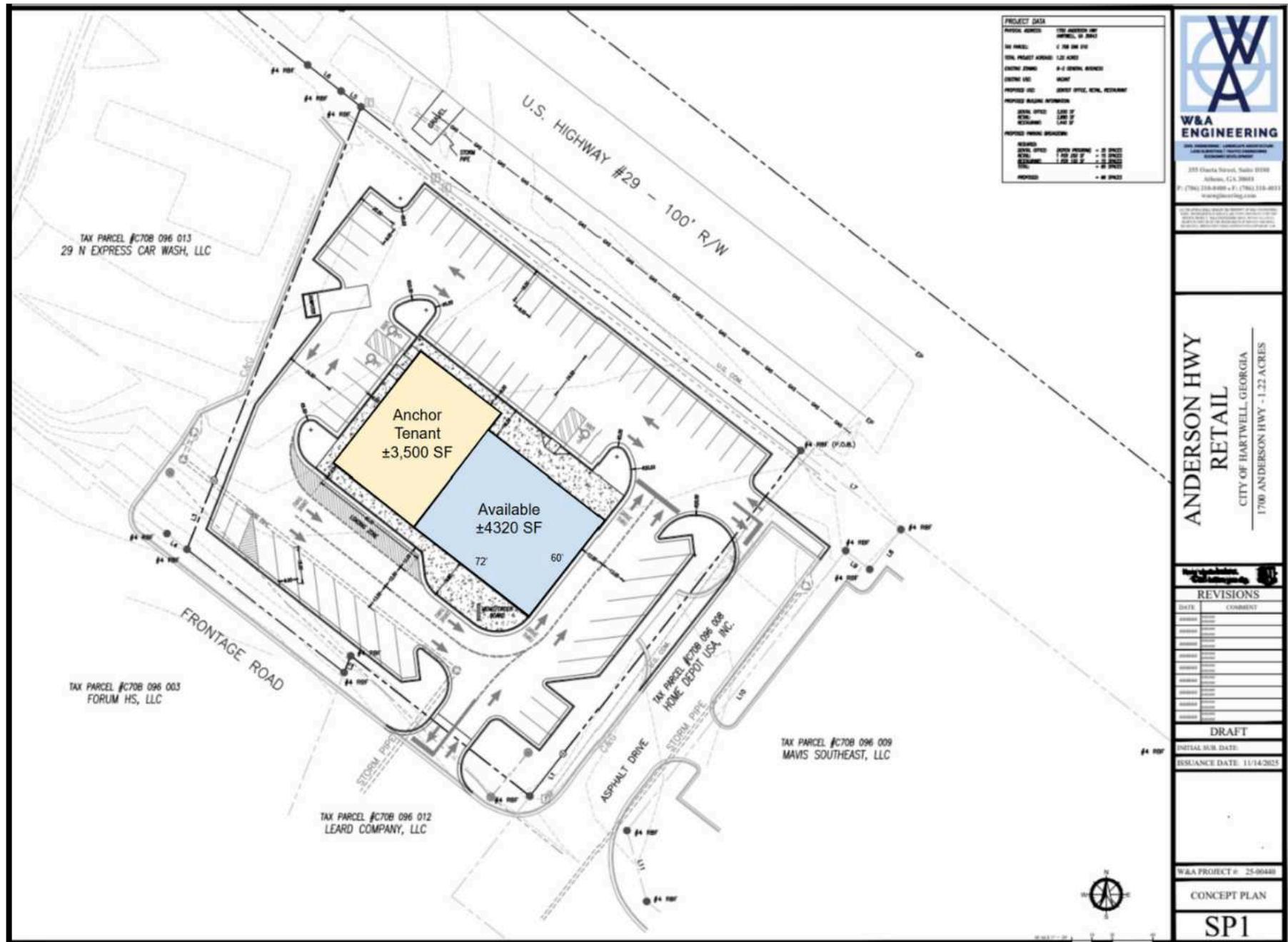

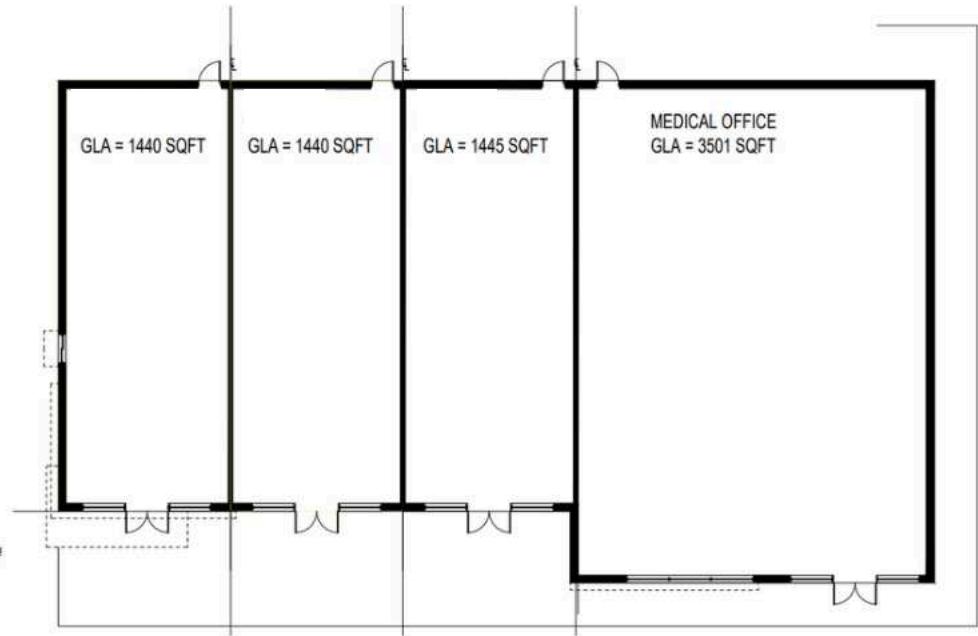
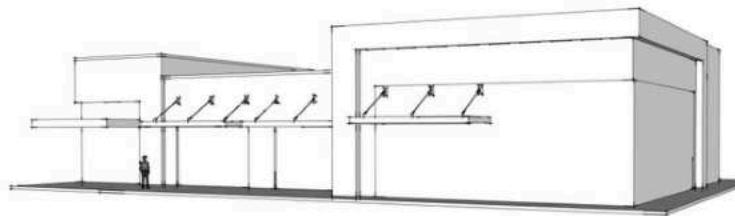
SITE PLAN

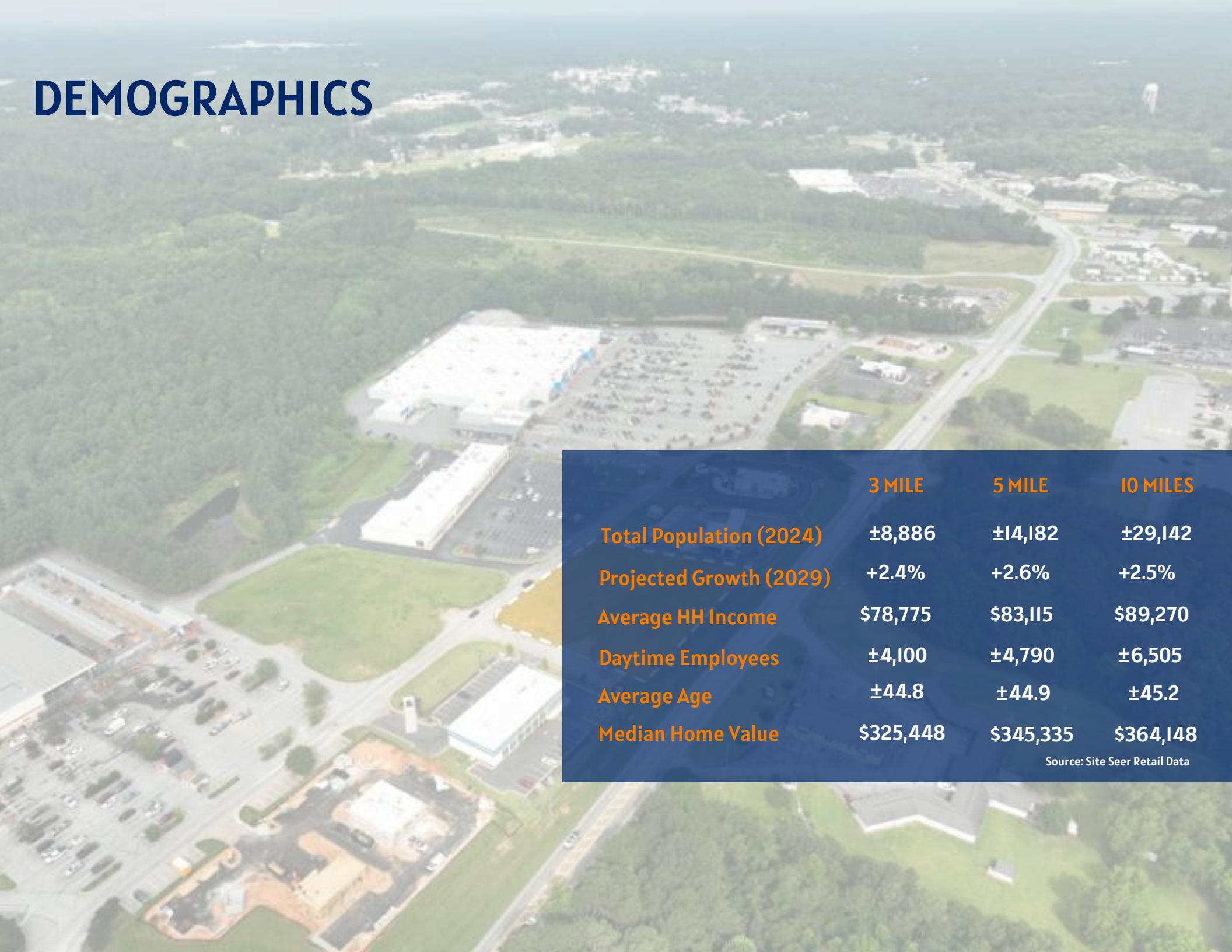

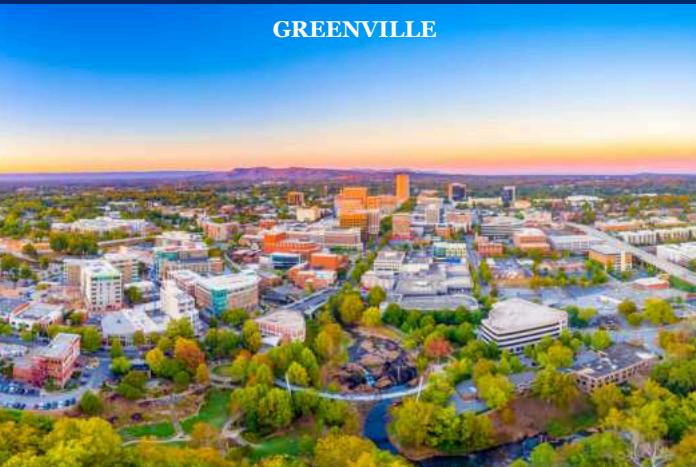
