



DESCRIPTION:

A parcel of land being a portion of those lands described in Official Records Book 9491, Page 314, Public Records of Pasco County, Florida, lying within Sections 2 and 3, Township 24 South, Range 20 East, Pasco County, Florida, being more particularly described as follows: For a POINT OF BEGINNING, commence at the Northeast corner of said Northwest 1/4 of Section 2; thence run S.00°34'17"W., along the East boundary of said Northwest 1/4, a distance of 2,821.85 feet to the Southeast corner of said Northwest 1/4; thence N.89°47'33"W., along the South boundary of said Northwest 1/4, 573.06 feet to the Western boundary of the D.O.T. Borrow Pit No. 20 as described in O.R. Book 324, Page 132, public records of Pasco County, Florida, said point also being a point on a curve concave to the Northwest, said curve having a chord of 1,477.51 feet, chord bearing of S.25°26'01"W. and a radius of 3,314.79 feet; thence run along said Westerly boundary and arc of said curve, 1,490.02 feet to the South boundary of the Northeast 1/4 of the Southwest 1/4; thence N.89°53'55"W., along said boundary, 123.25 feet to the East boundary of the West 1/2 of the Southwest 1/4; thence S.00°36'48"W., along said East boundary, 820.44 feet; thence N.89°59'49"W., a distance of 1,345.38 feet to the East right-of-way line of Interstate No. 75; thence along said right-of-way the following eleven (11) courses: 1) N.61°08'08"E., a distance of, 416.24 feet to to a non-tangent point of curvature; 2) Northeasterly 308.43 feet along the arc of a curve to the left, said curve having a radius of 3,012.79 feet, a central angle of 05°51'56", and a chord bearing and distance of N.58°09'15"E., 308.30 feet; 3) N.33°13'00"W., a distance of 29.74 feet to a non-tangent point of curvature; 4) Northeasterly 1,821.27 feet along the arc of a curve to the left, said curve having a radius of 2,982.79 feet, a central angle of 34°59'04", and a chord bearing and distance of N.37*44'58"E., 1,793.11 feet; 5), S.69*54'52"E., a distance of 29.54 feet to a non-tangent point of curvature; 6) Northerly 1,031.02 feet along the arc of a curve to the left, said curve having a radius of 3,012.79 feet, a central angle of 19°36'27", and a chord bearing and distance of N.10°26'31"E., 1,026.00 feet; 7) N.00°42'12"E., a distance of 503.05 feet; 8) N.89°17'48"W., a distance of 20.00 feet; 9) N.00°42'12"E., a distance of 1,198.90 feet; 10) N.89°17'48"W., a distance of 10.00 feet; 11) N.00°42'12"E., a distance of 479.36 feet to the North boundary of said Northwest 1/4; thence S.89°05'27"E., along said North boundary, a distance of 794.89 feet to the POINT OF BEGINNING.
