Notes: The above described parcel is subject to an overhead utility easement and a water line easement extending from the City of South Pittsburg leading to the water tank at the top of the mountain. This property is also subject to the rights (if any) of the Old Dietzen's Bridge Road as well as the rights to an easement leading to the Southeastern Cave Conservancy property. Included with the above described parcel is a 50' easement running along the northern property line of the Jerry Walker property.
