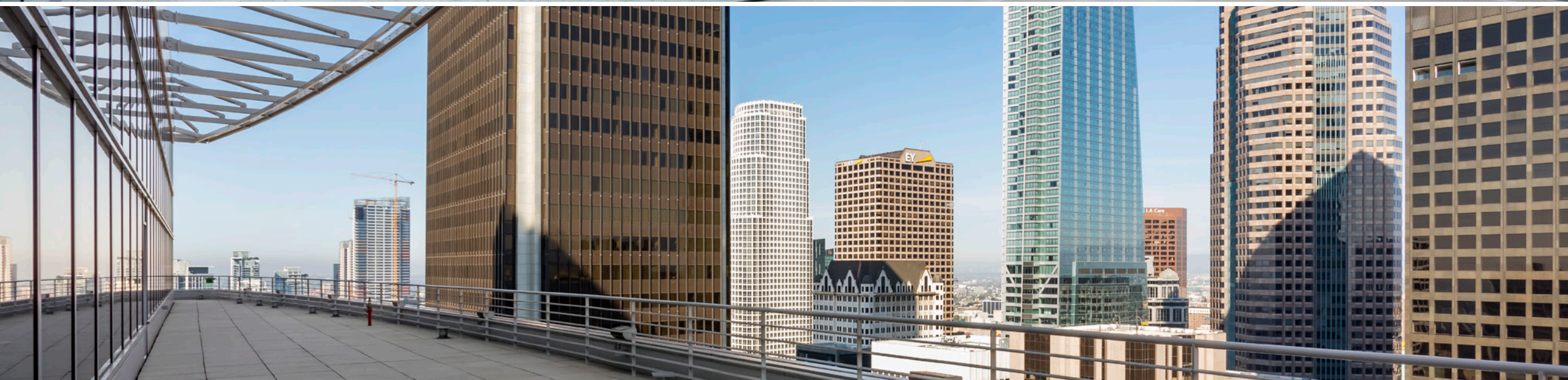

Renovations are currently underway for the lobby, tenant lounge, conference center, and outdoor terrace. The re-envisioned lobby will feature an expansive media wall, sleek seating areas with landscaping, and a coffee kiosk. Improvements to the tenant lounge will include glass sliding doors to create an indoor/outdoor feel with the adjacent terrace. The interior of the lounge will be upgraded to have a boutique hospitality feel, with a variety of seating options and a conference room. The outdoor terrace will feature new landscaping, lighting, and areas to work, meet, or host an event.
