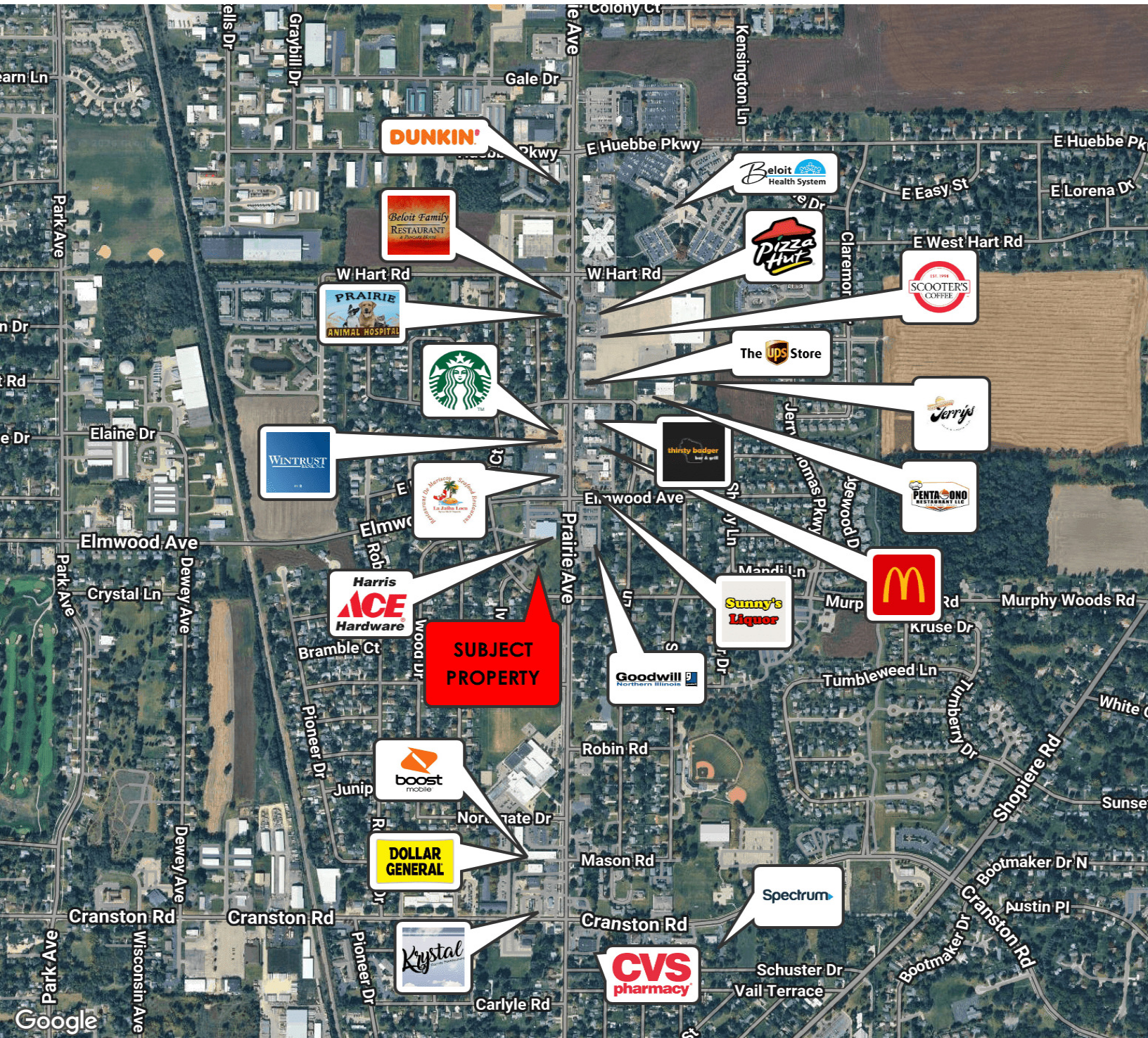

RETAILER MAP | +/- 5,867 SF SPECIAL PURPOSE PROPERTY FOR SALE



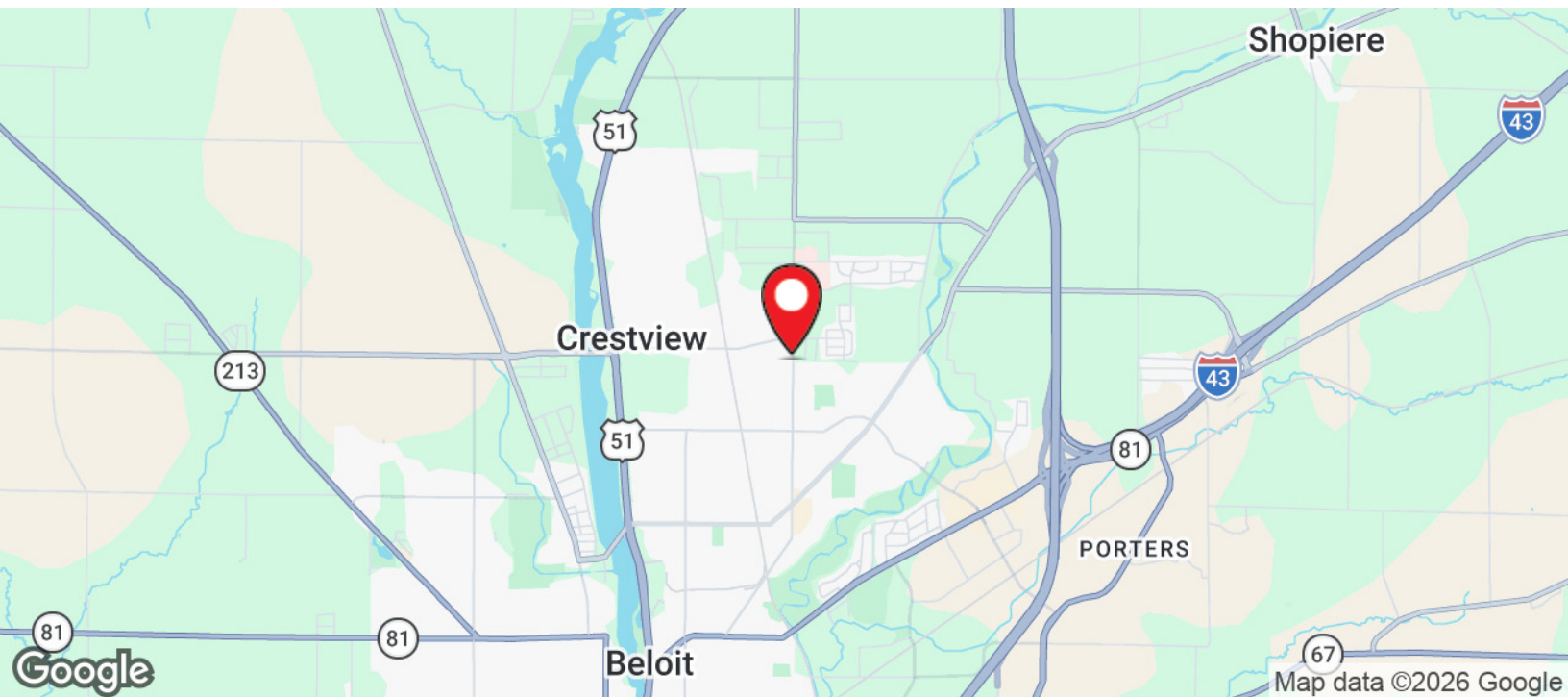
