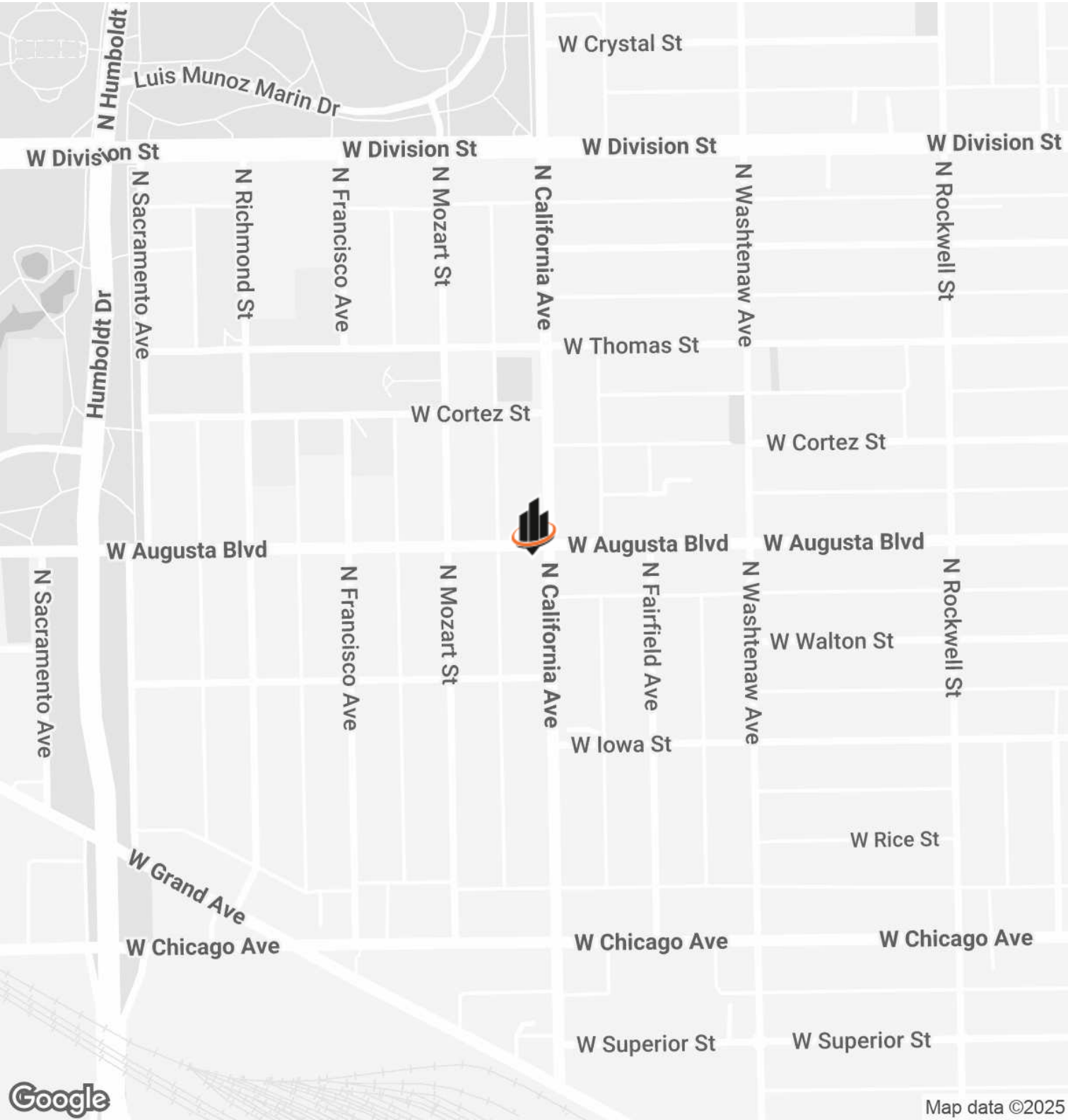

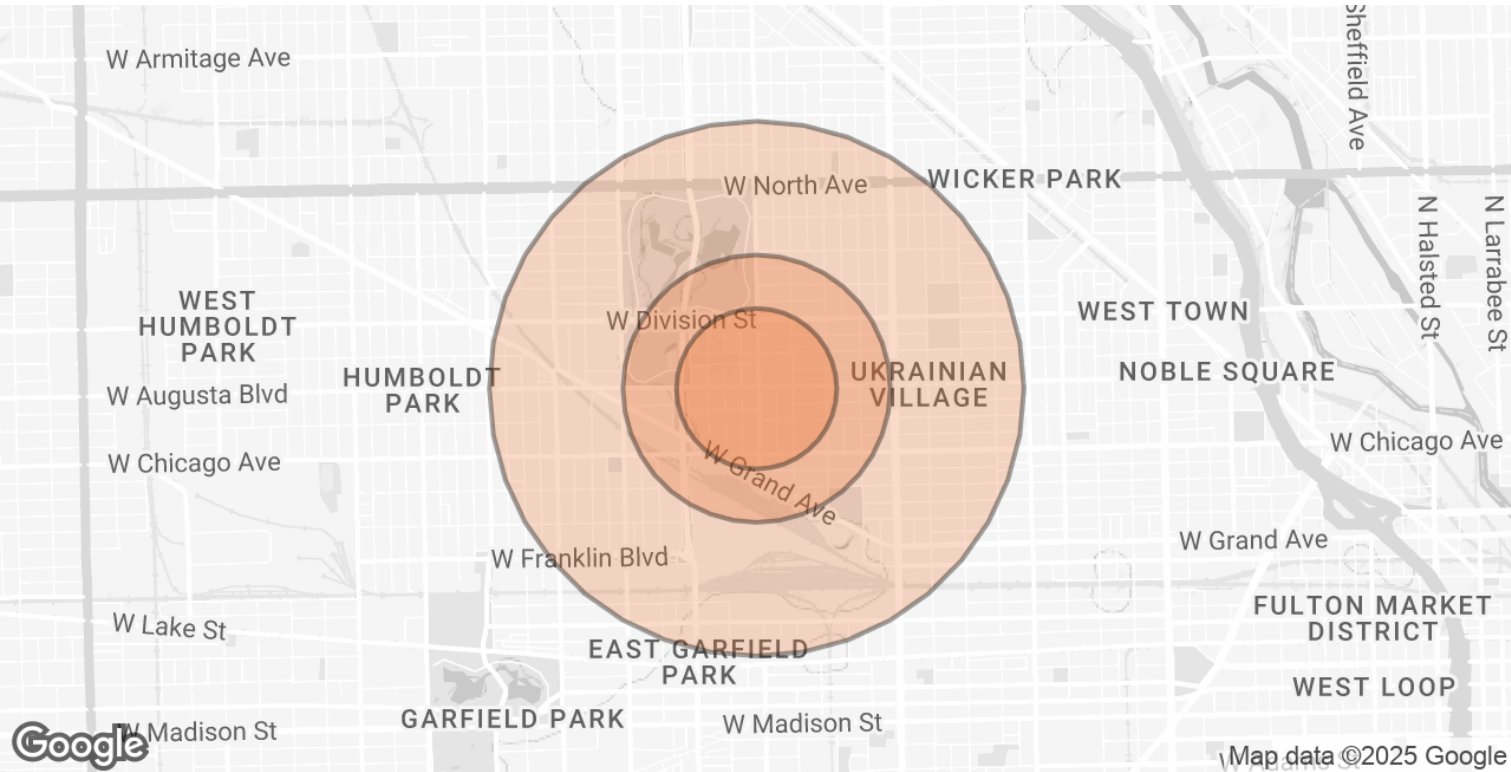
LOCATION MAP
