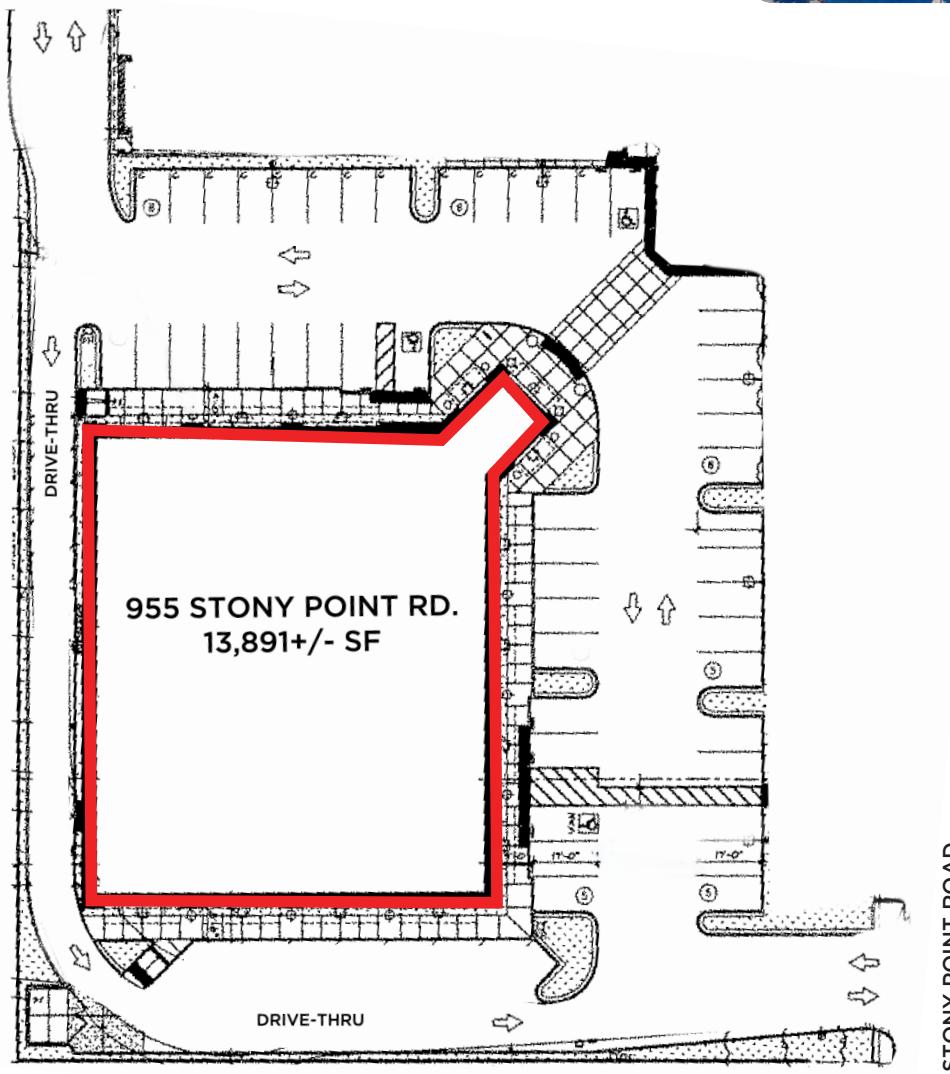
SITE PLAN

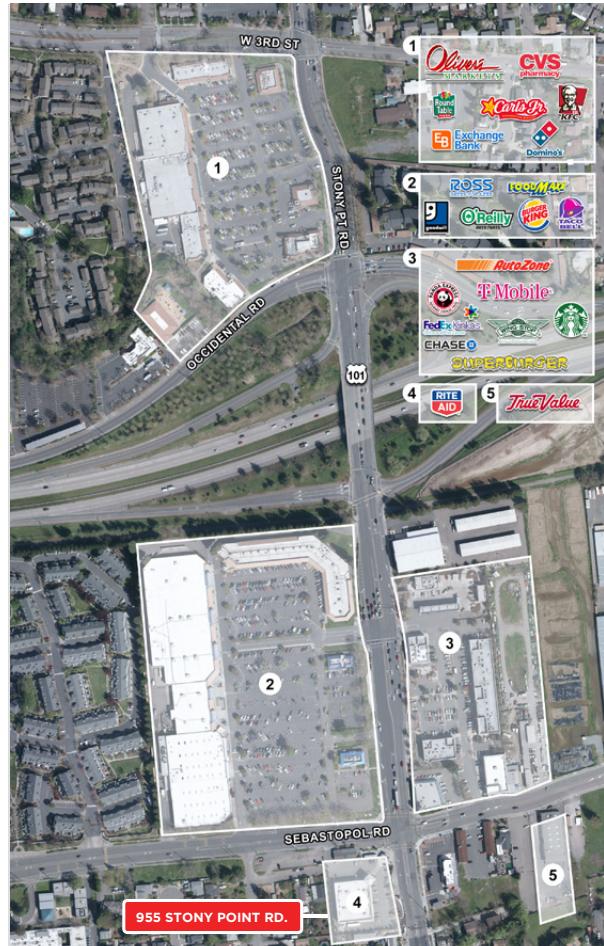
