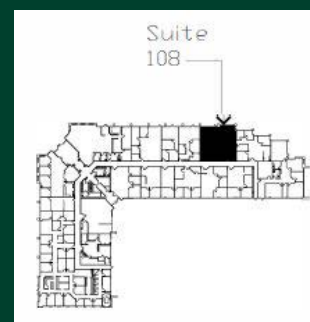
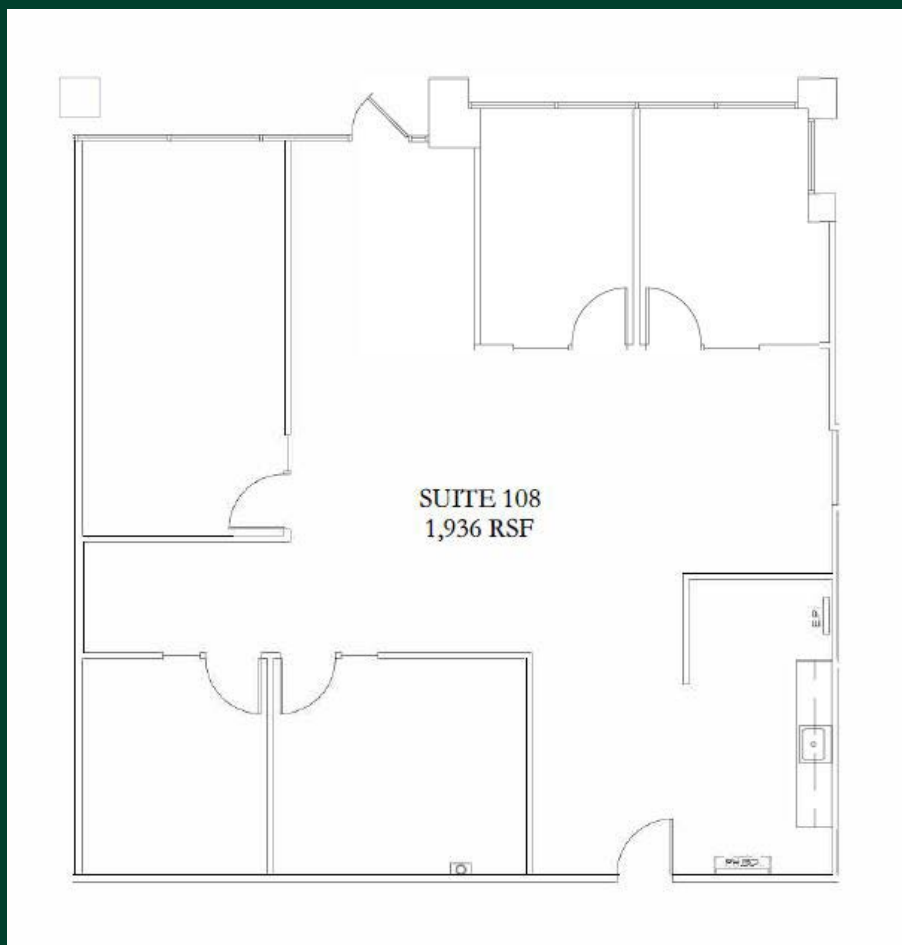


Floor Plan

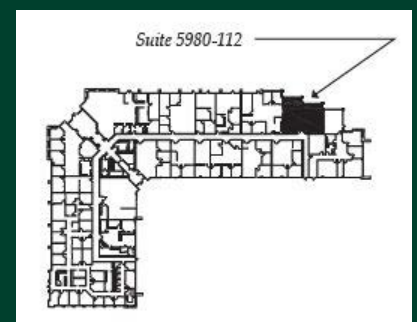

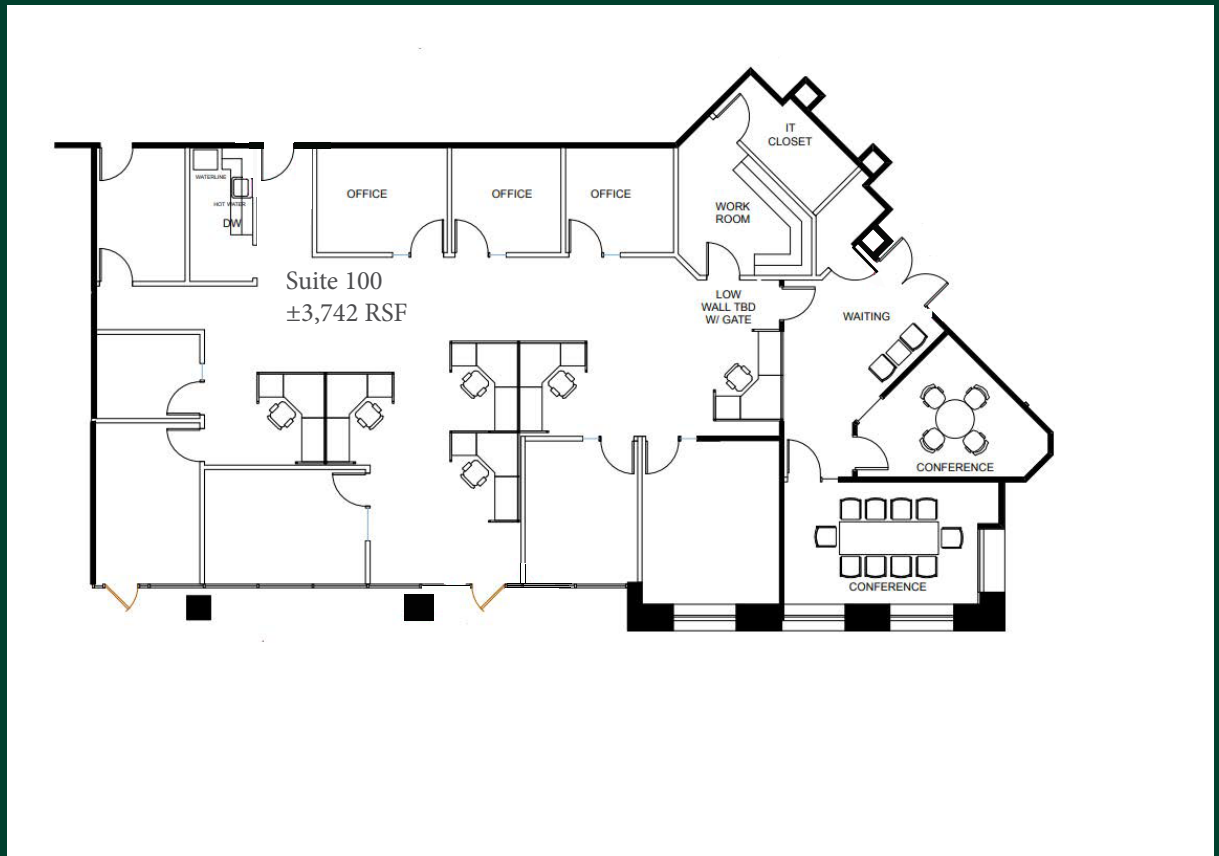

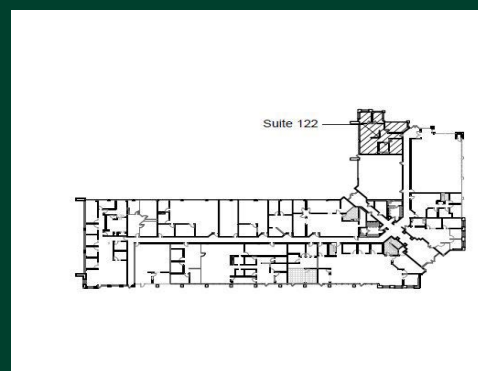

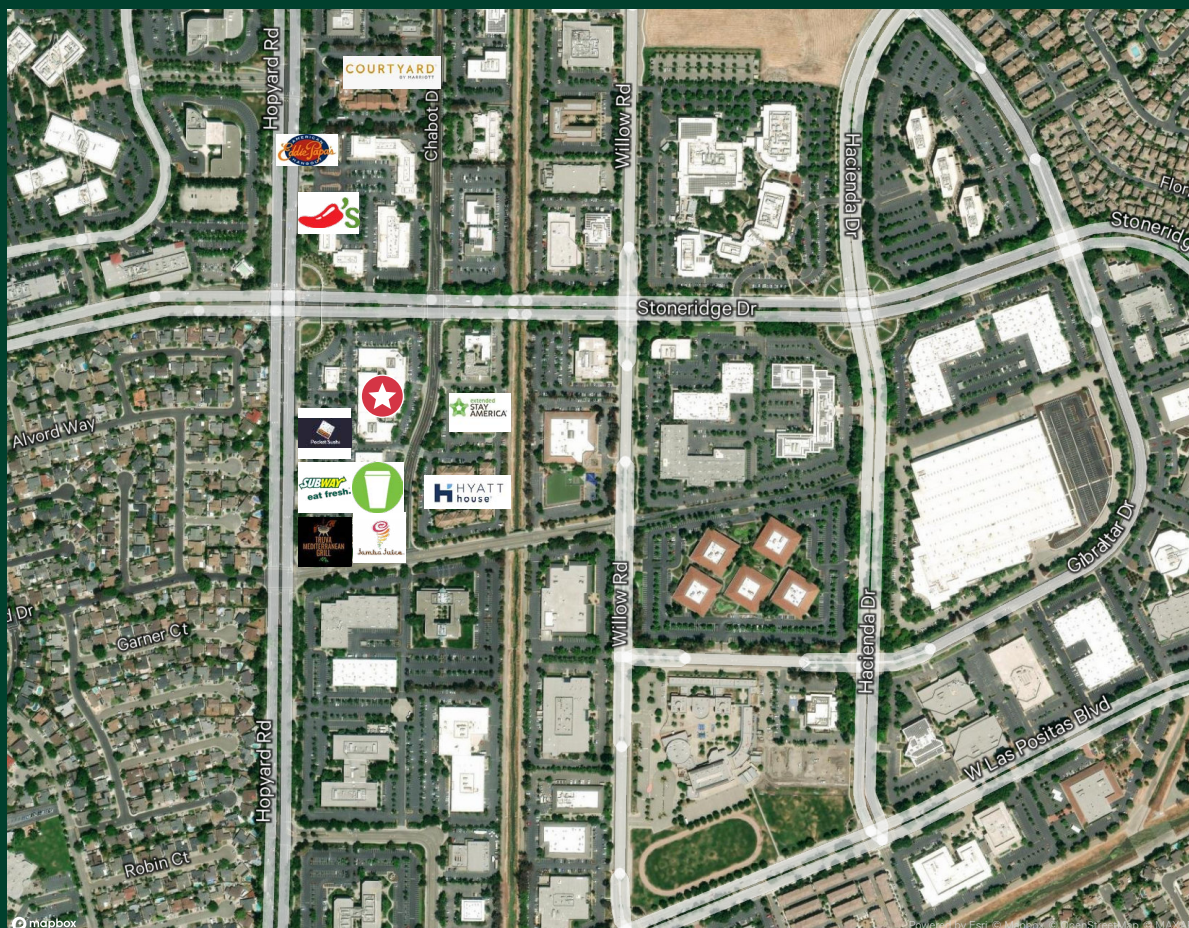

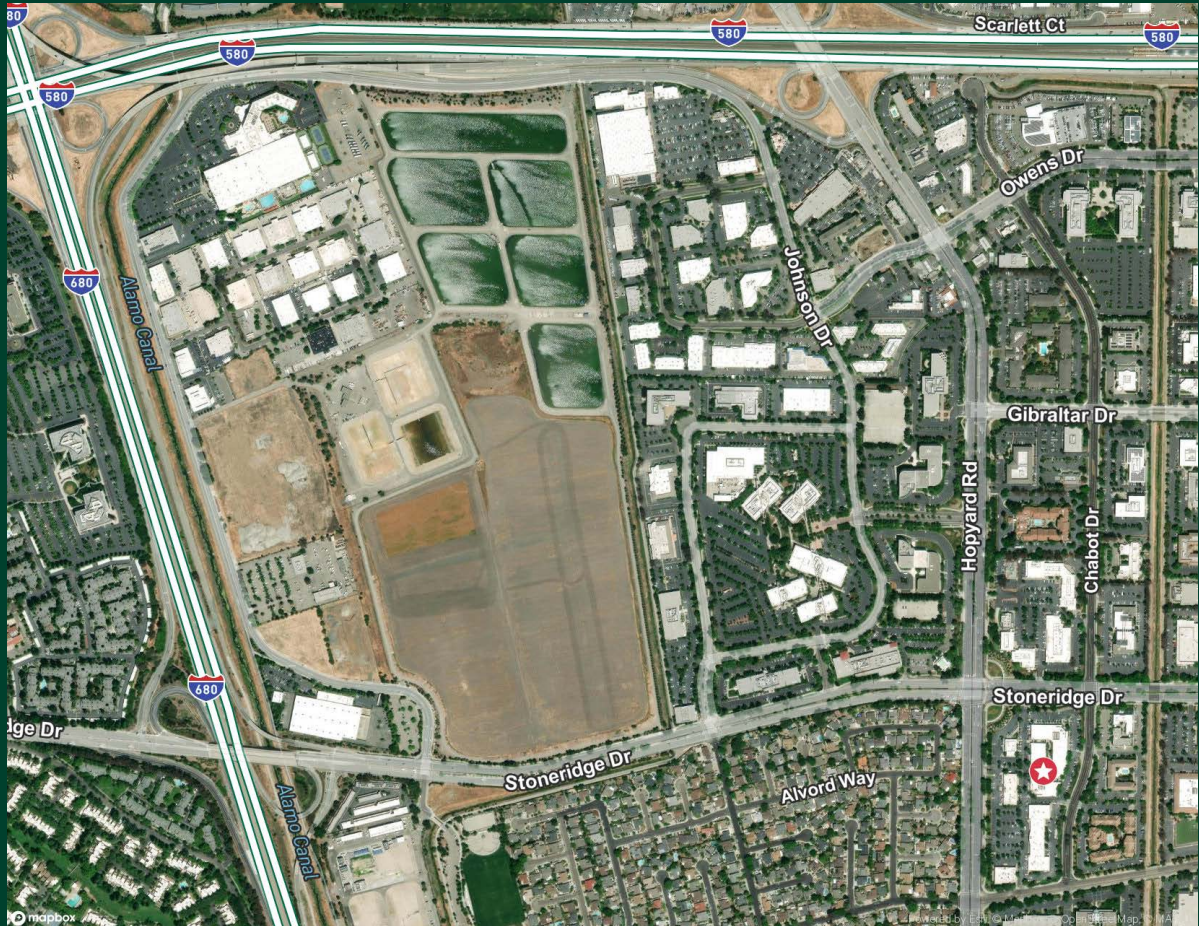
