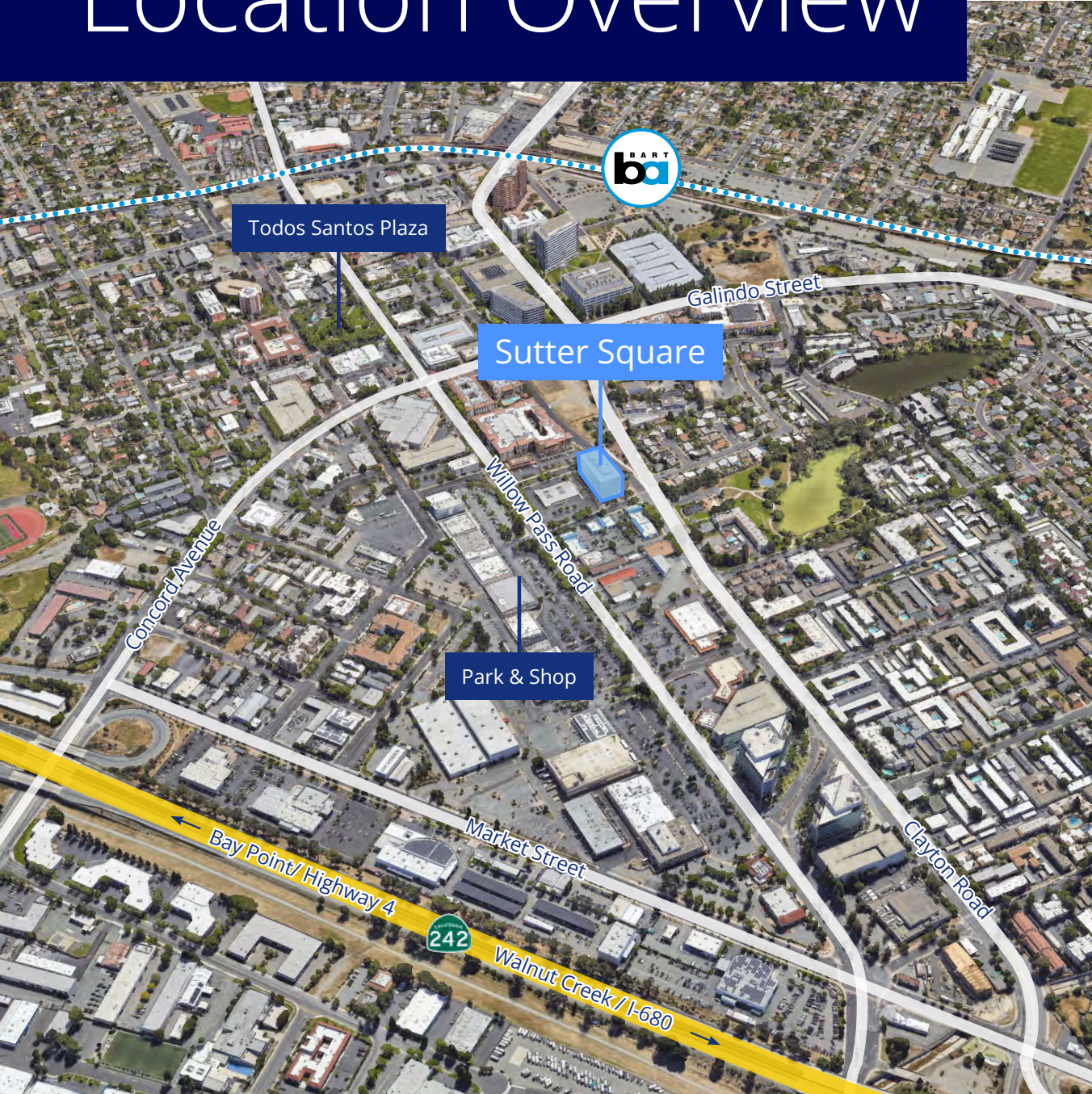
The building contains 9 floors of office space and 6 levels of private subterranean parking. The 2-story marble atrium is considered one of the most impressive in Northern California.
