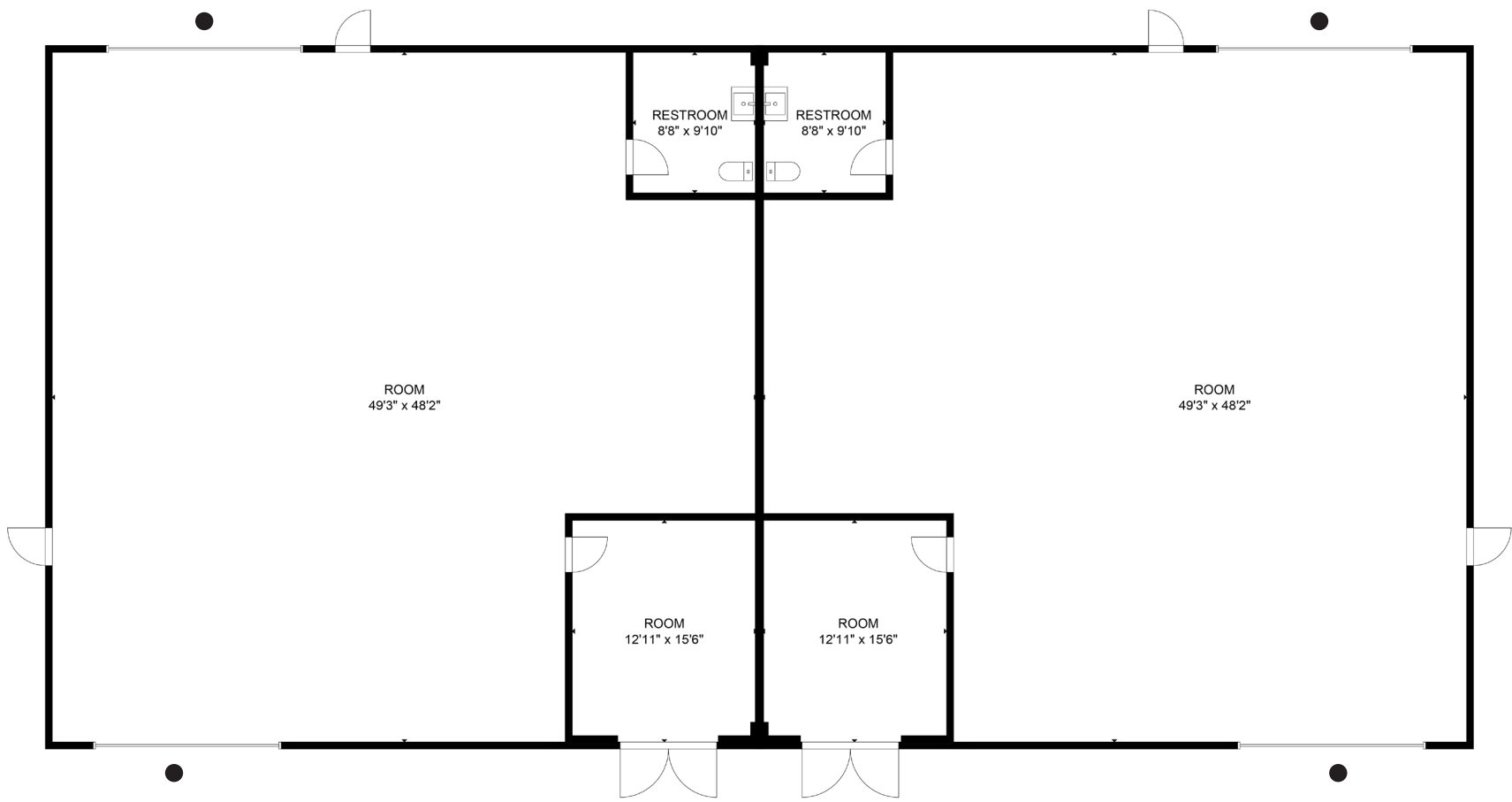


# AREA MAP

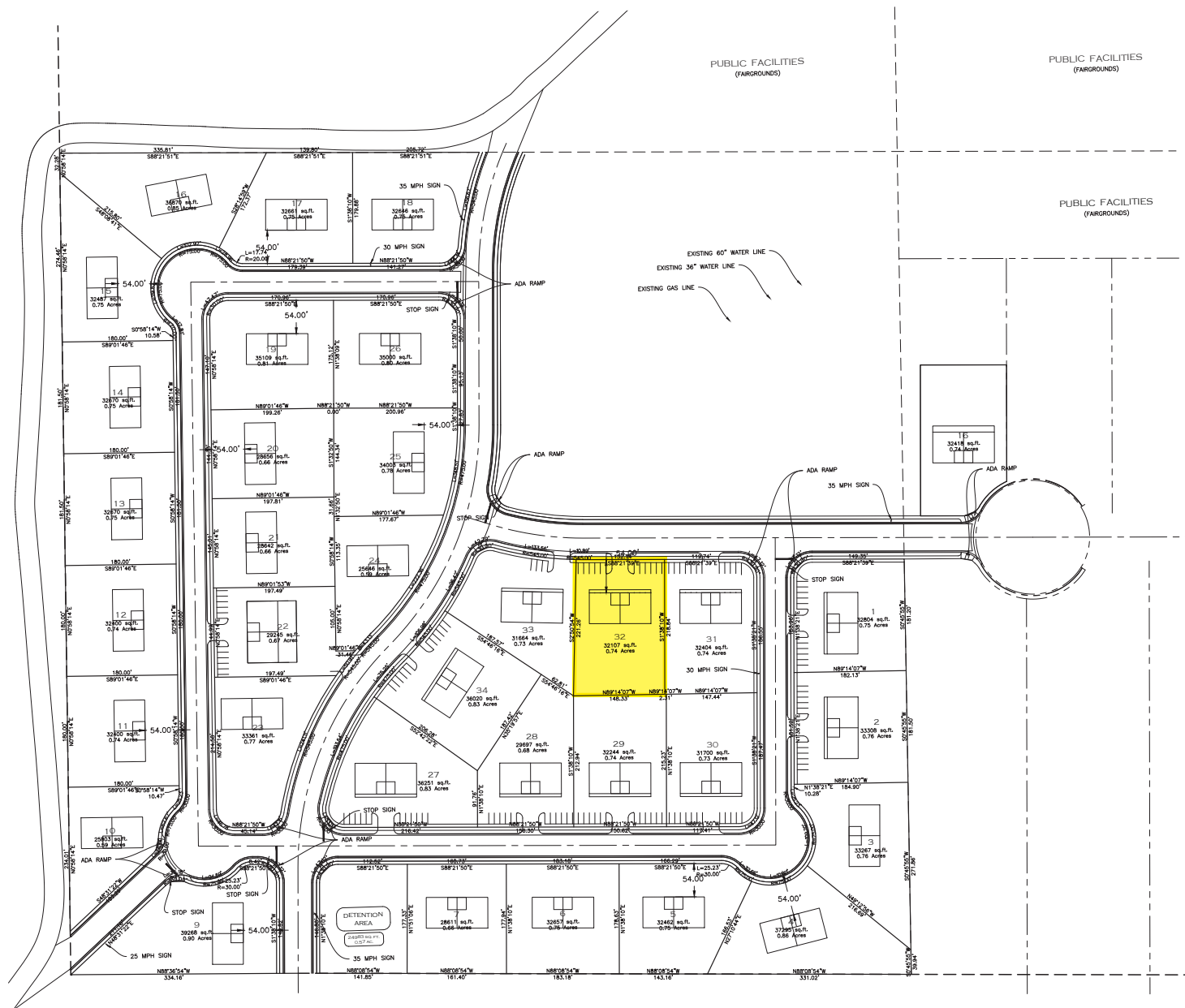

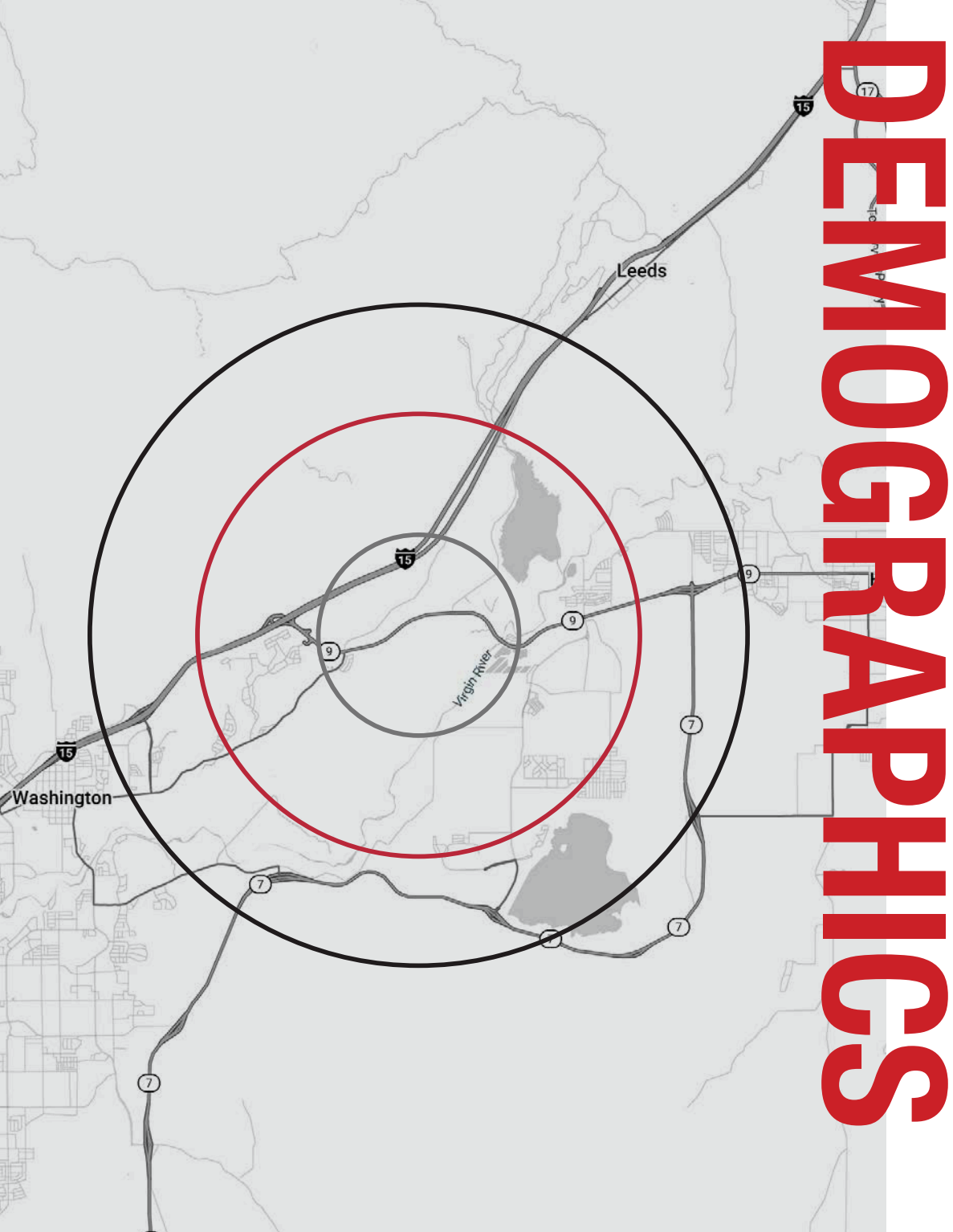
