A RESOLUTION TO VACATE SEVERAL SMALL PORTIONS OF BUCKLEY STREET EAST OF STATE TRUNK HIGHWAY 36/83 AS DEDICATED ON CSM 2651 IN ORDER TO REALIGN BUCKLEY STREET ACCORDING TO DEPARTMENT OF TRANSPORTATION SPECIFICATIONS, WITH REVERSION OF TITLE TO SUCH LAND TO THE ABUTTING PROPERTY OWNERS; AND TO AMEND THE OFFICIAL MAP OF THE CITY OF BURLINGTON TO SHOW THE SAME

WHEREAS the Common Council of the City of Burlington has the power to discontinue the whole or any part of any street within the corporate limits of the City pursuant to Wis. Stat. § 66.1003 when the public interest requires it; and

WHEREAS the discontinuance of a public highway results in reversion of title to the owners of the adjoining lands pursuant to Wis. Stat. § 66.1005; and

WHEREAS the Common Council of the City of Burlington has the power to amend the official map of the City of Burlington pursuant to Wis. Stat. § 62.23(6); and

WHEREAS Buckley Street lying East of State Trunk Highway 36/83 was dedicated on Certified Survey Map 2651, but the State of Wisconsin Department of Transportation is requiring the realignment of the dedicated roadway, which will result in the vacation of some portions of the existing roadway (and the dedication of additional portions of roadway by separate document); and

WHEREAS the Common Council of the City of Burlington has considered whether such vacation would be in the public interest, and hereby determines that it is in the public interest to vacate, abandon and discontinue portions of said dedicated street in furtherance of the DOT requirements, and as much land as is feasible should be returned to the tax rolls:

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Burlington, pursuant to Wis. Stat. § 66.1003, that:

Those parts of Buckley Street, as dedicated on Certified Survey Map No. 2651, recorded in Volume 8 of Certified Survey Maps on page 378 as Document No. 1993947 by the Racine County Register of Deeds, described as follows:

Commencing at the Northwest corner of the Southwest 1/4 of Section 22, Township 3 North, Range 19 East; Thence S 01°52'37" E, 706.56 feet along the west line of said Southwest 1/4 Section to the southwesterly line of Buckley Street and the Point of Beginning of this description; Thence N 01°52'37" W, 6.22 feet; Thence N 51°35'55" E, 66.48 feet, Thence S 83°24'05" E, 7.07 feet; Thence S 51°35'55" W, 75.18 feet to the Point of Beginning. Containing 354 square feet of land, more or less (Detail "B" on Exhibit); and

Commencing at the Northwest corner of the Southwest 1/4 of Section 22, Township 3 North, Range 19 East; Thence S 01°52'37" E, 452.71 feet along the west line of said Southwest 1/4 Section; Thence N 51°35'55" E, 33.00 feet to the easterly line of Buckley Street and the Point of Beginning of this description; Thence S 38°24'05" E, 113.91 feet; Thence N 83°24'05" W, 5.91

feet; Thence N 38°24'05" W, 108.00 feet; Thence N 51°35'55" E, 5.91 feet to the Point of Beginning. Containing 655 square feet of land, more or less (Detail "C" on Exhibit); and

Commencing at the Northwest corner of the Southwest 1/4 of Section 22, Township 3 North, Range 19 East; Thence S 01°52'37" E, 452.71 feet along the west line of said Southwest 1/4 Section; Thence N 51°35'55" E, 33.00 feet; Thence S 38°24'05" E, 133.00 feet; Thence N 51°35'55" W, 112.00 feet to the easterly line of Buckley Street and the Point of Beginning of this description; thence S 38°24'05" E, 96.96 feet; Thence southwesterly 264.74 feet along the arc of a curve deflecting to the right, having a chord bearing and distance of S 03°02'31" W, 242.25 feet and a radius of 183.00 feet; Thence S 44°29'08" W, 23.08 feet; Thence northeasterly 265.08 feet along the arc of a curve deflecting to the left, having a chord bearing and distance of N 03°02'31" E, 242.25 feet and a radius of 181.95 feet; Thence N 38°24'05" W, 74.65 feet; Thence N 03°54'19" E, 34.03 feet to the Point of Beginning. Containing 5605 square feet of land, more or less (Detail "F" on Exhibit); and

Commencing at the Northwest corner of the Southwest 1/4 of Section 22, Township 3 North, Range 19 East; Thence S 01°52'37" E, 452.71 feet along the west line of said Southwest 1/4 Section; Thence N 51°35'55" E, 33.00 feet; Thence S 38°24'05" E, 133.00 feet; Thence N 51°35'55" E, 19.10 feet to the Point of beginning of this description; Thence N 51°35'55" E, 92.90 feet, Thence S 38°24'05" E, 66.00 feet; Thence S 51°35'55" W, 92.90 feet; thence N 38°24'05" W, 66.00 feet to the Point of Beginning. Containing 6131 square feet of land, more or less ("To be vacated" on Exhibit),

as reflected on the Exhibit attached hereto and made a part hereof, are hereby vacated and discontinued as required by the public interest pursuant to Wis. Stat. § 66.1003.

BE IT FURTHER RESOLVED that reversion of title to such land shall hereby be made pursuant to Wis. Stat. § 66.1005 to the owner of the adjoining lands.

BE IT FURTHER RESOLVED that the Official Map of the City of Burlington is hereby amended pursuant to the above and Wis. Stat. § 62.23(6).

BE IT FURTHER RESOLVED that the City Clerk shall file a certified copy of this Resolution with the Register of Deeds for Racine County.
