Inside, high ceilings and open layouts create flexible options for warehouse, showroom, and office use. The second floor is uniquely accented with antique collectibles and custom design details, adding warmth, charm, and personality rarely found in commercial spaces. This thoughtful blend of utility and artistry reflects its origins as the headquarters for one of Hawaii's most iconic lifestyle brands.
