

11-8A-7: USES

- A. In the following list of uses:
 - 1. Uses designated with a "P" are permitted uses;
 - Use designated with a "C" shall be conditional uses, which shall not be established or maintained unless authorized by a conditional use permit as described in CCNO 11-14; and
 - 3. Uses designated with an "N" shall not be permitted in the zone.
- B. No list of specific uses can be complete. Therefore decisions regarding whether a specific use is included in one of the categories of use in the following list as a permitted use or a conditional use will be made by the planning commission, with an appeal to the city council.
- C. Uses not included in the following categories of uses are prohibited. If the city council desires to allow such a use as a permitted or conditional use, it must amend this title as described in CCNO 11-1-4. If the amendment is made, the use will only be allowed as provided by the city council.
