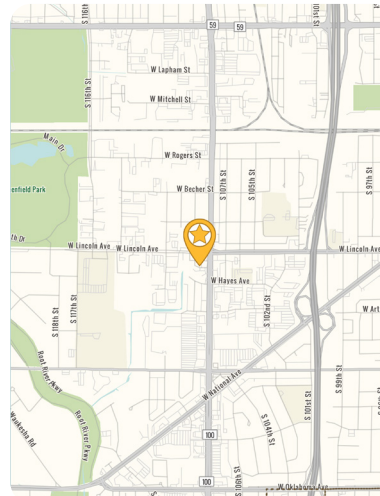

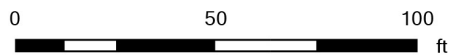
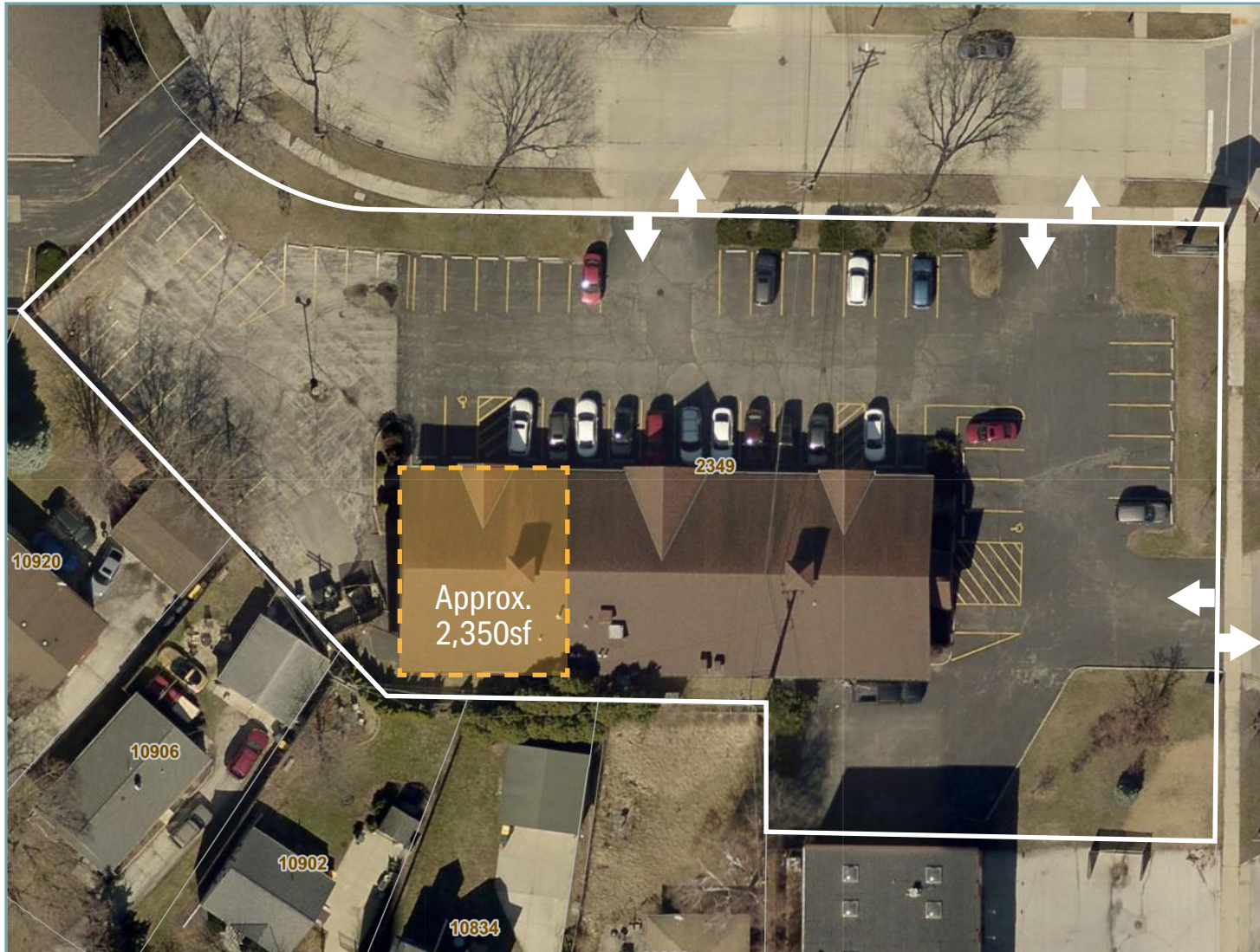


ADDITIONAL INFORMATION
