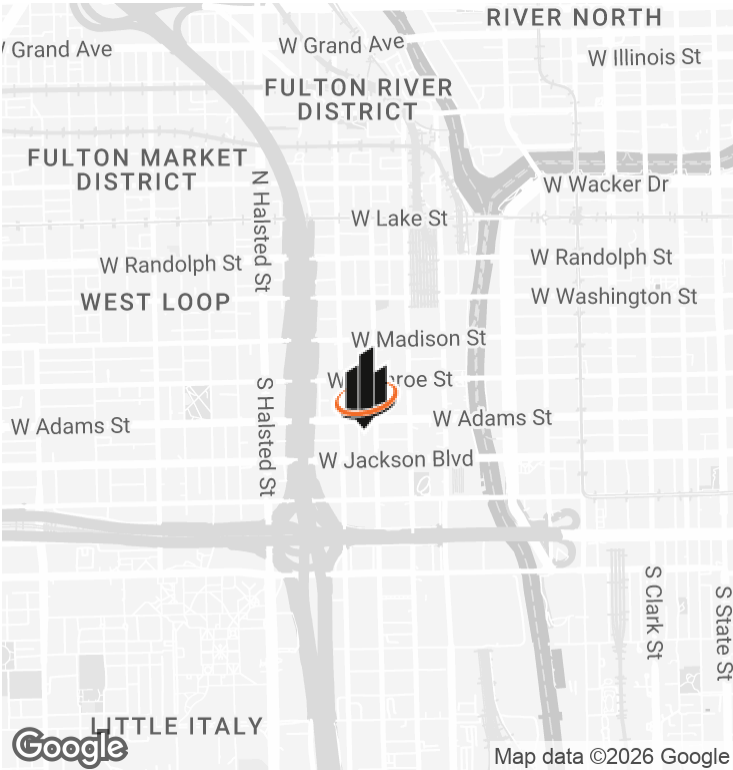

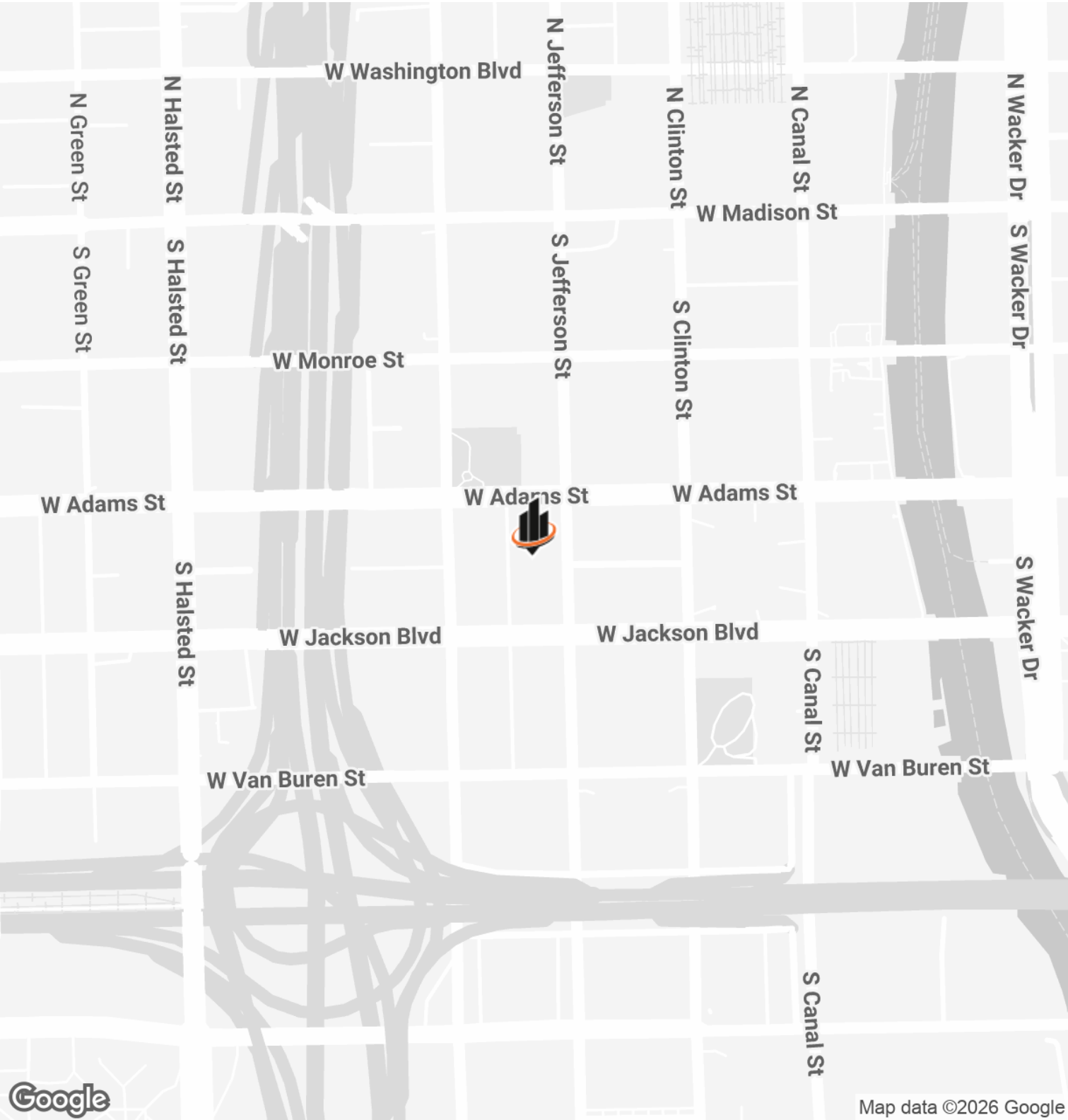

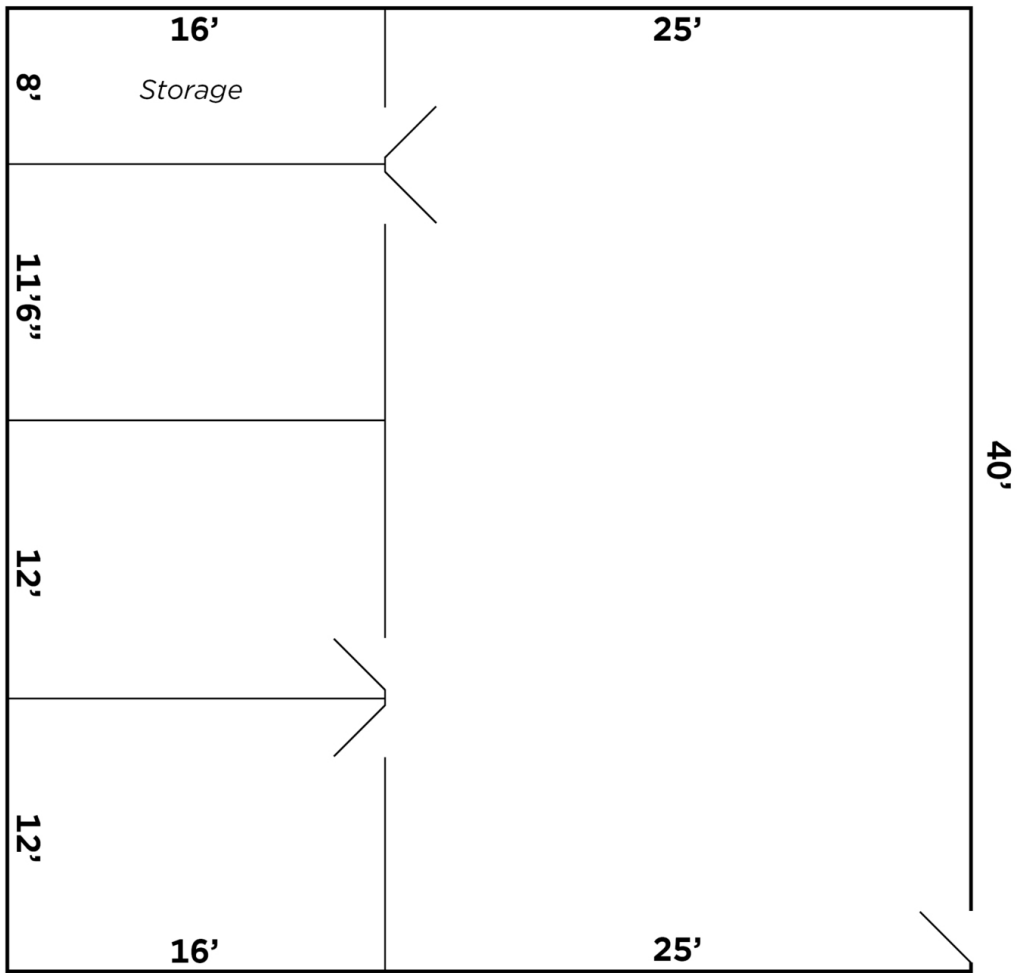
LOCATION MAP
