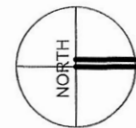


FLOOR PLAN



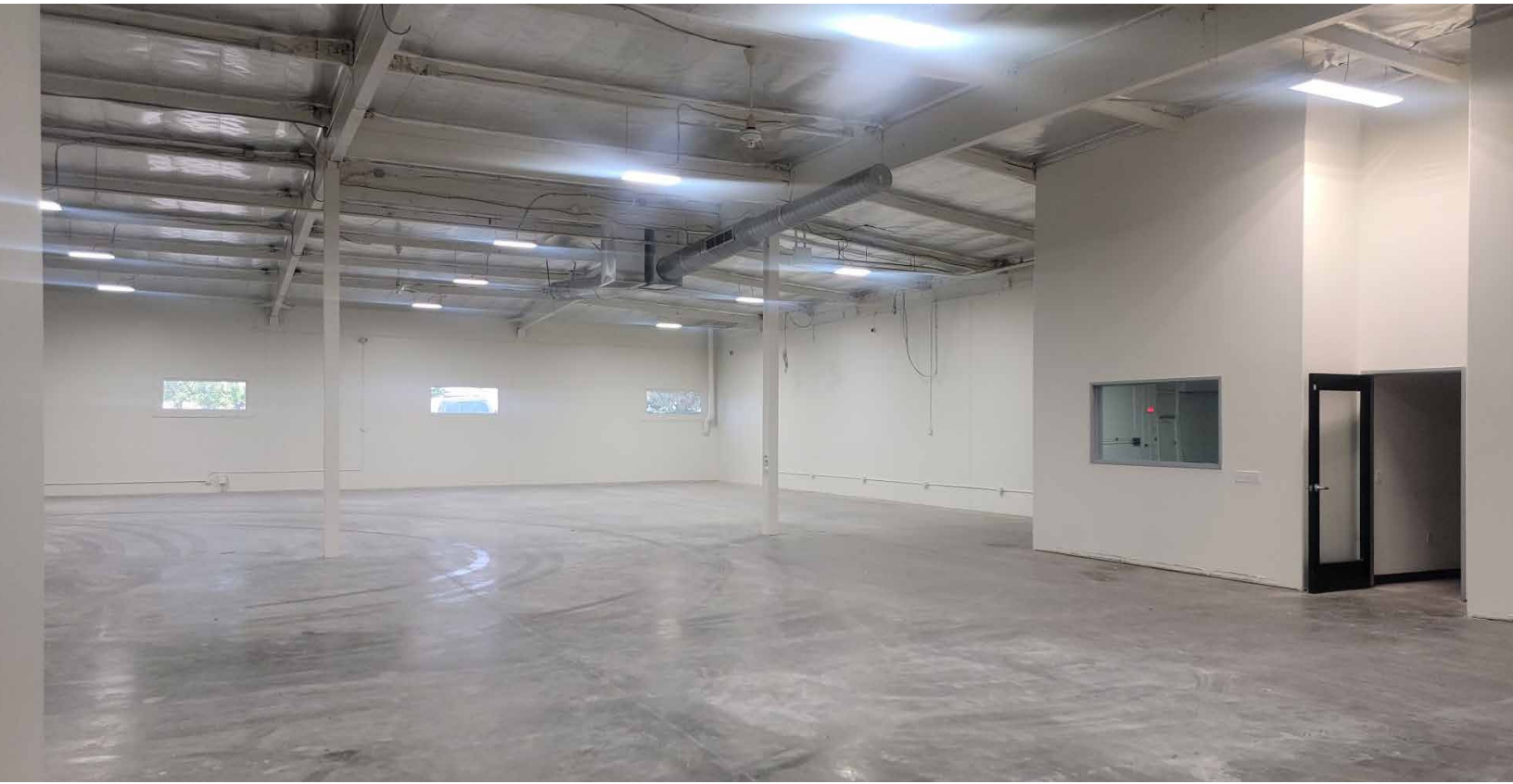
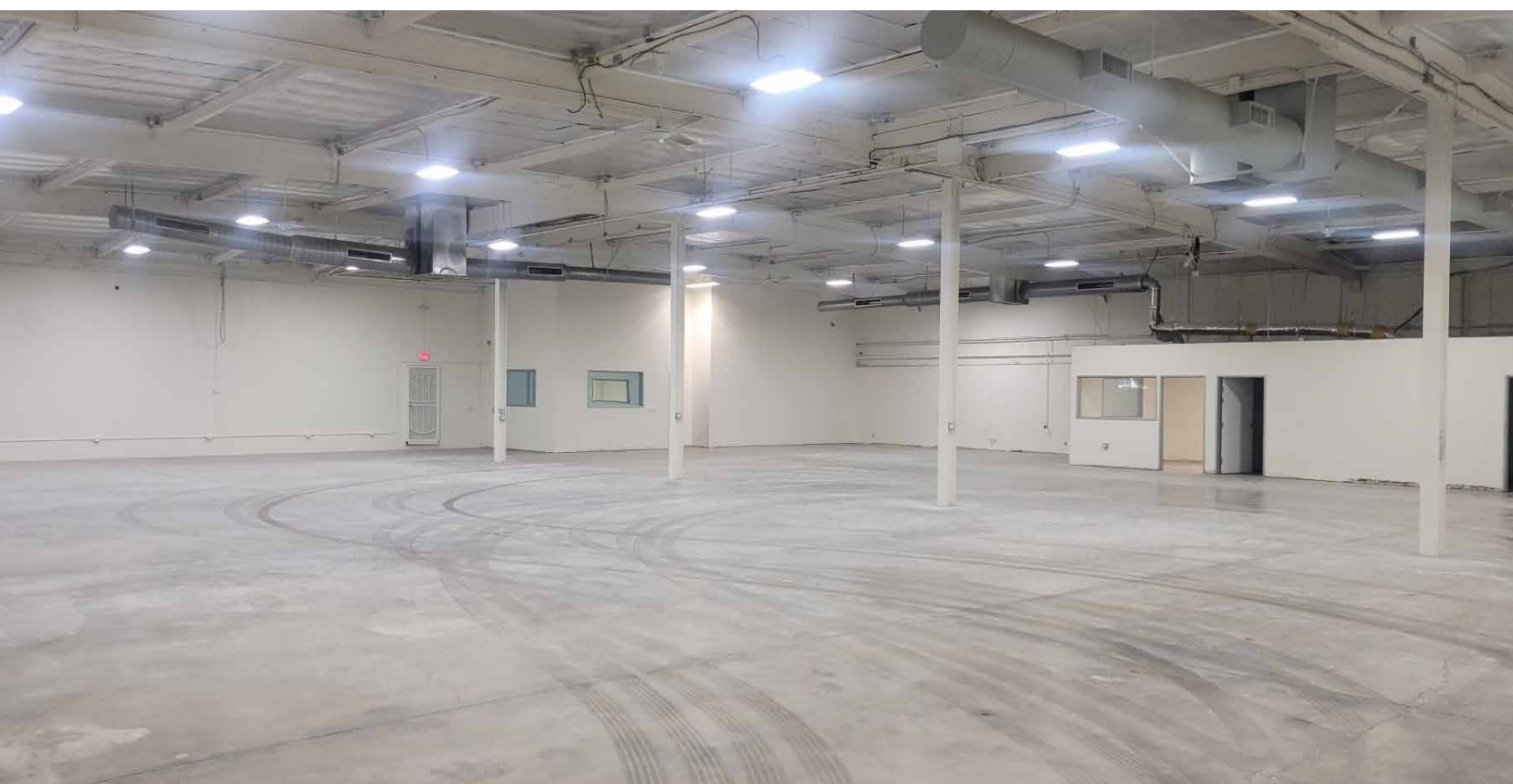

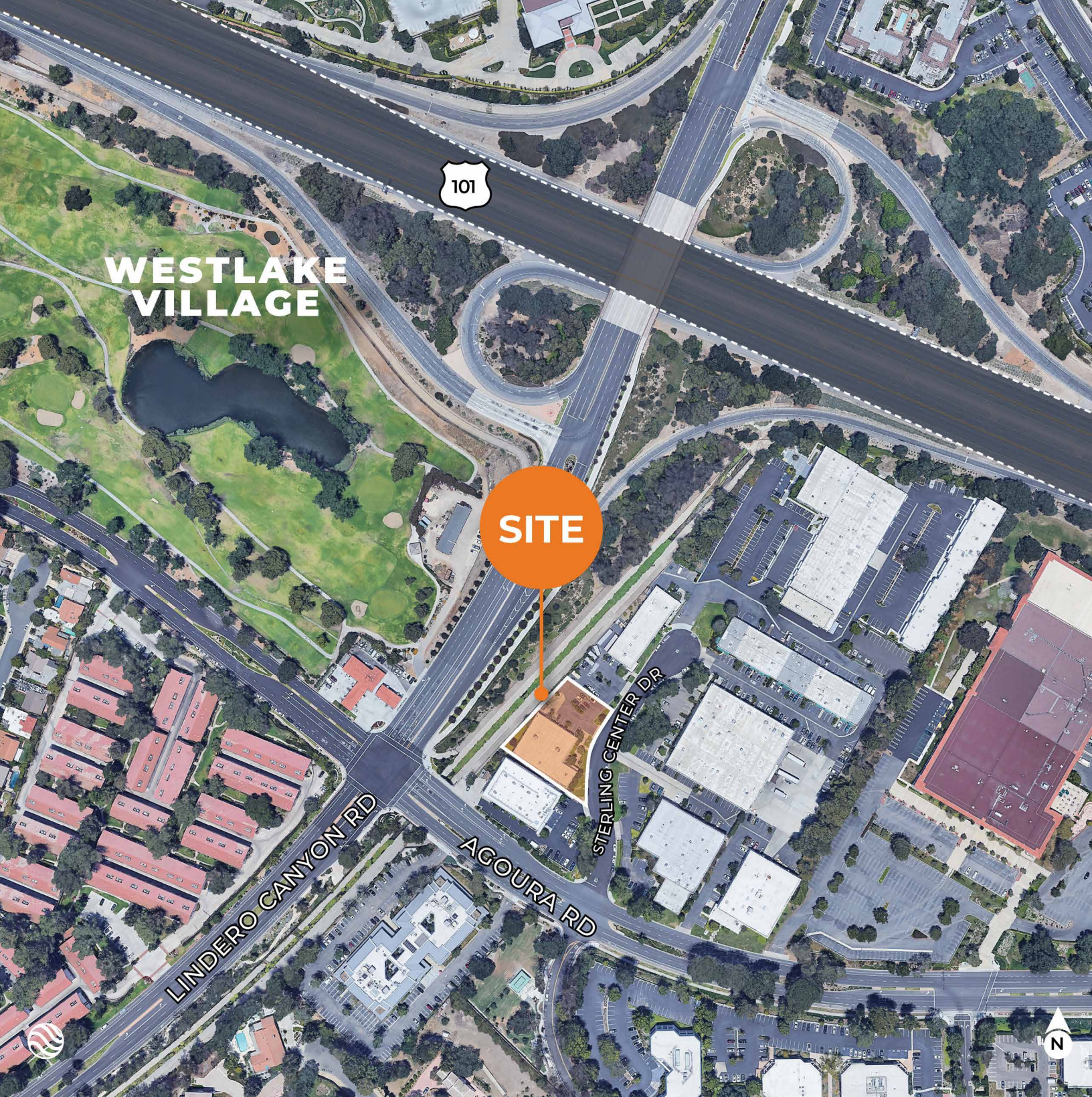


PLOT PLAN
