888 Fourth Street, known as the Marin Masonic Building, is a historic two-story office and retail property located at the corner of Fourth Street and Lootens Place in the heart of downtown San Rafael. Built in 1924, the building features ground-floor retail storefronts facing Fourth Street along with a first-floor auditorium space available for meetings and events. A secure main lobby provides entry to the upper floors, where an elevator serves a collection of small private office suites on the second floor, complemented by shared restrooms and convenient stairway access to Lootens Place. Tenants benefit from the building's classic character, high ceilings, and central downtown location within walking distance of restaurants, services, and Highway 101 access.

Location Description:

888 Fourth Street is located in the heart of downtown San Rafael at the corner of Fourth Street and Lootens Place, along the city's primary commercial corridor. The property sits within walking distance of numerous restaurants, cafés, retail shops, and professional services that line Fourth Street, making it one of the most active business districts in Marin County. Its central location provides convenient access to Highway 101, the San Rafael Transit Center, and nearby civic destinations including the Marin County Civic Center, courthouse, and municipal offices. Positioned between Lincoln Avenue and the core downtown retail district, the building benefits from strong pedestrian activity, excellent visibility, and immediate proximity to the amenities and services that define downtown San Rafael.
