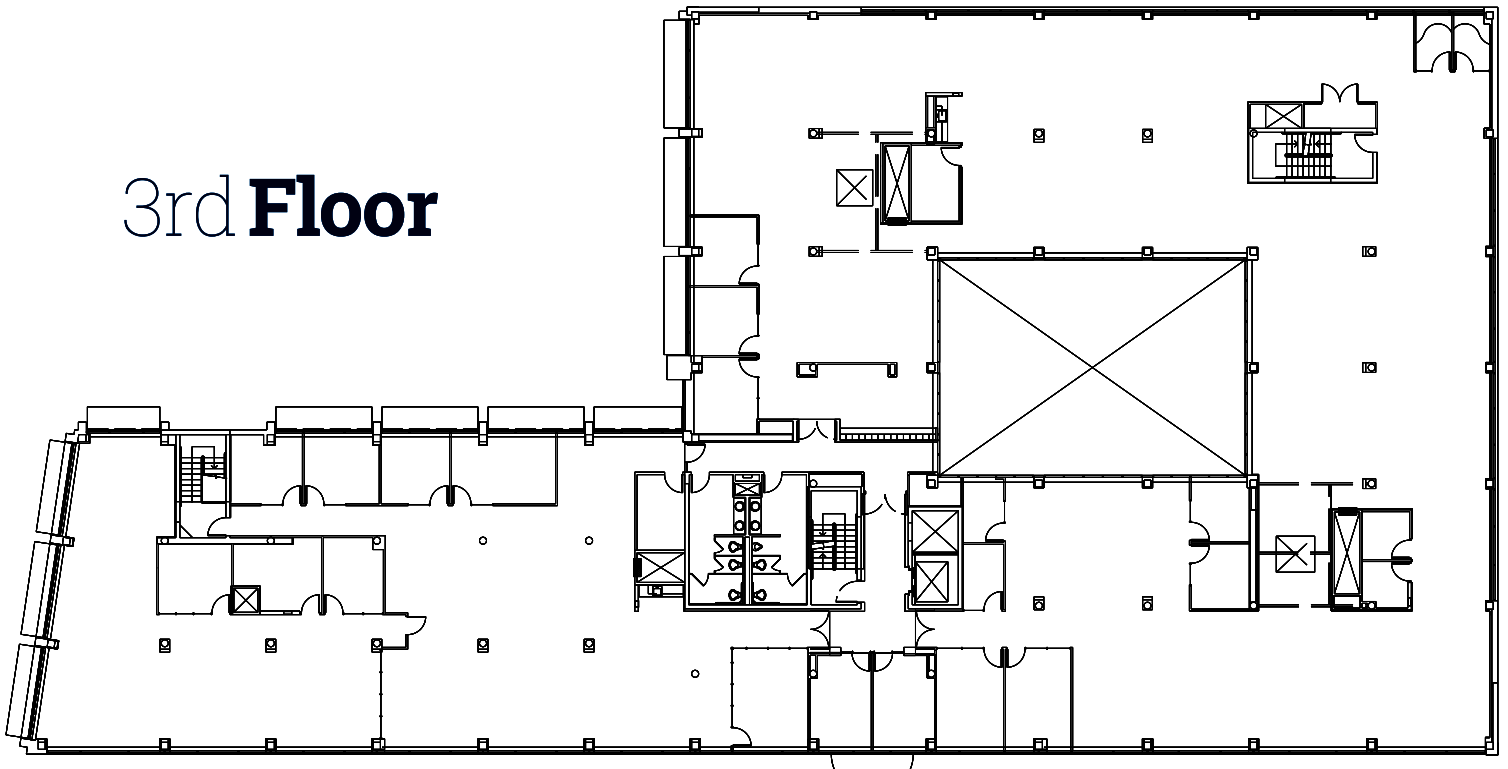


FLOOR PLANS
