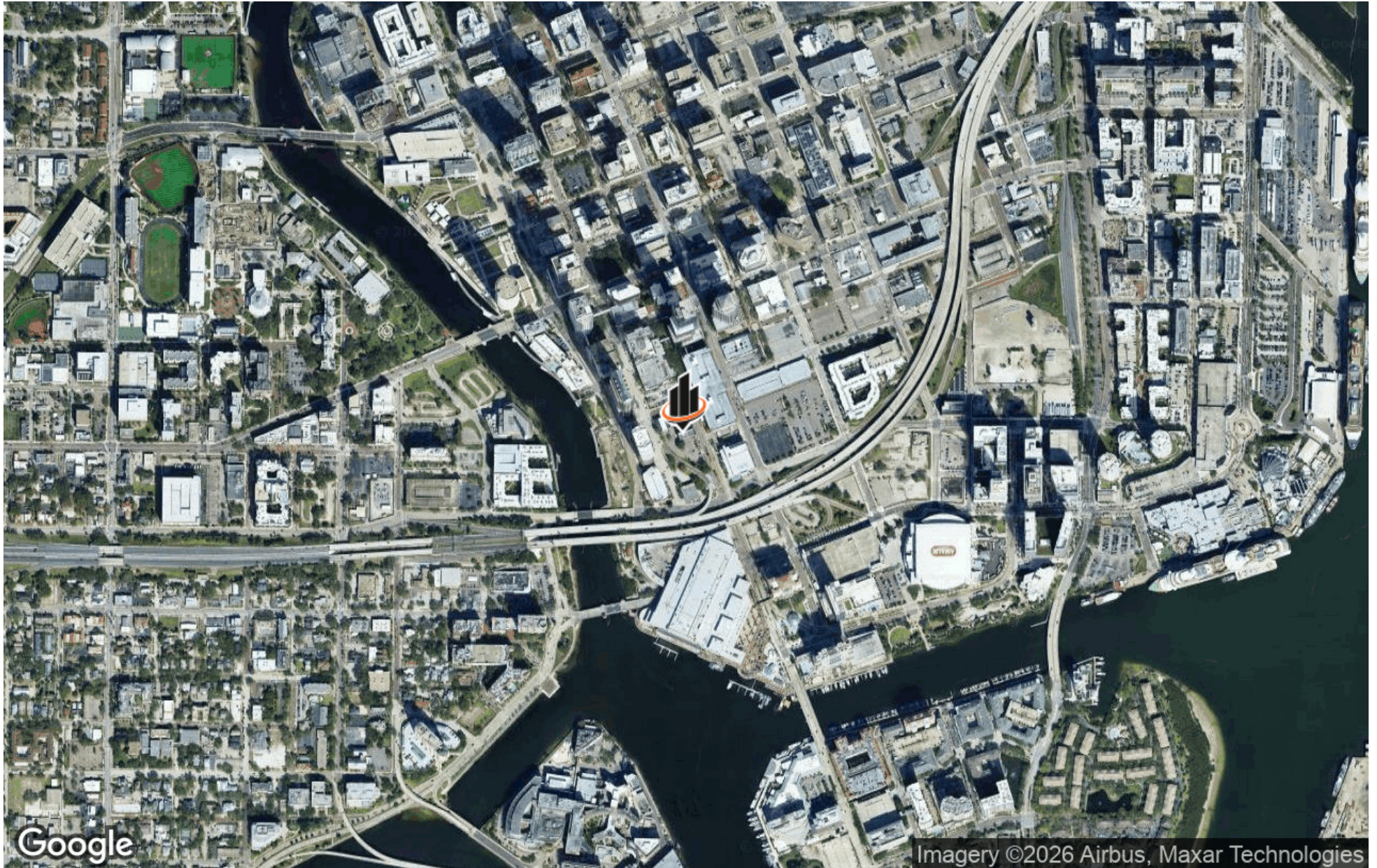


Location Information
