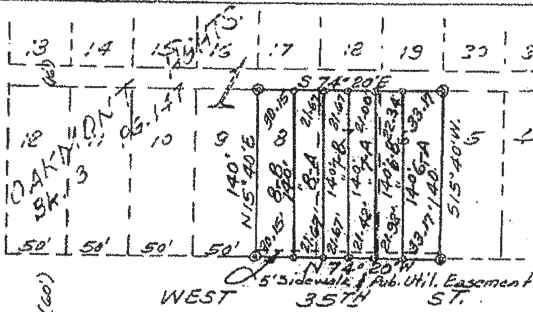

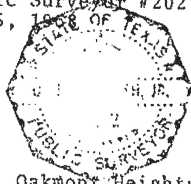
NORMAN DUMBLE
