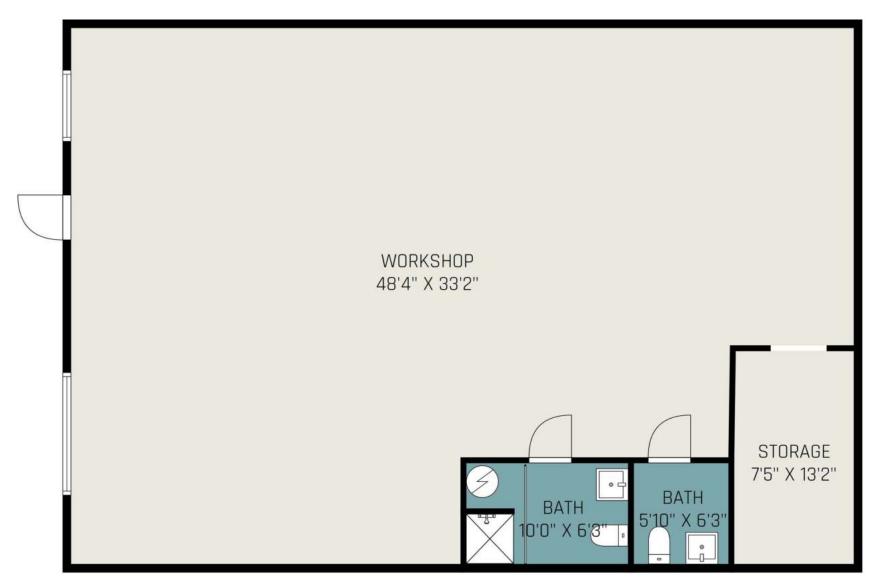

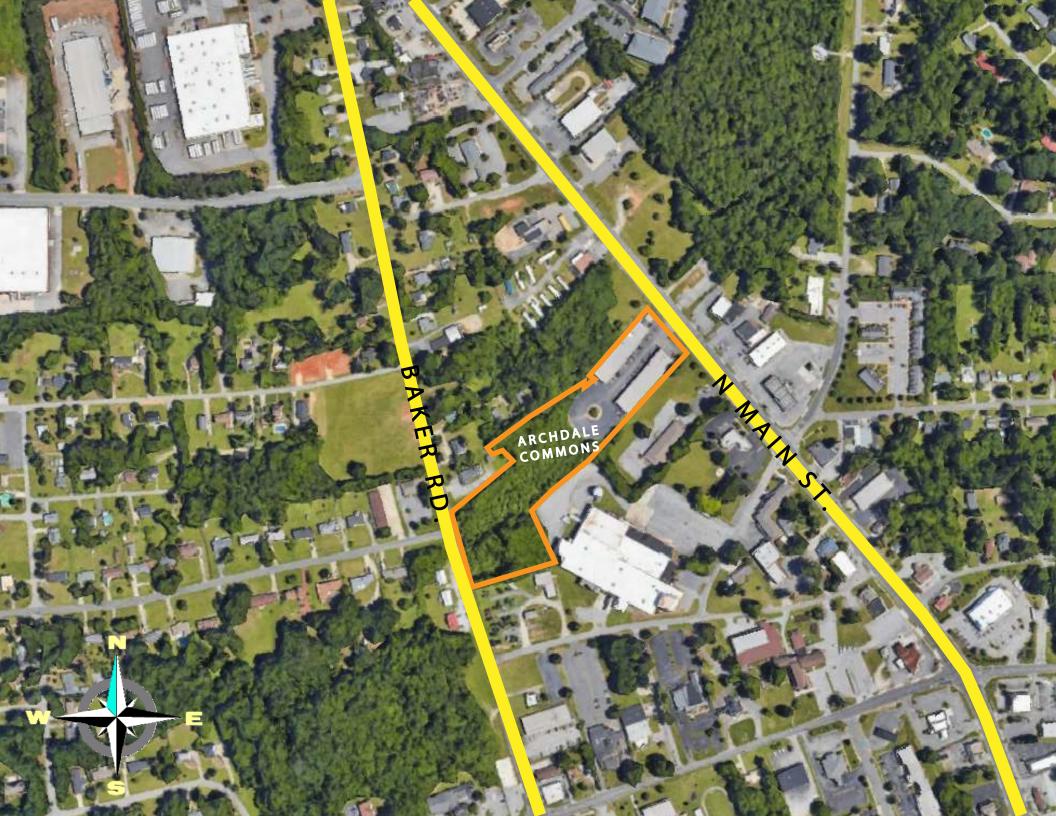


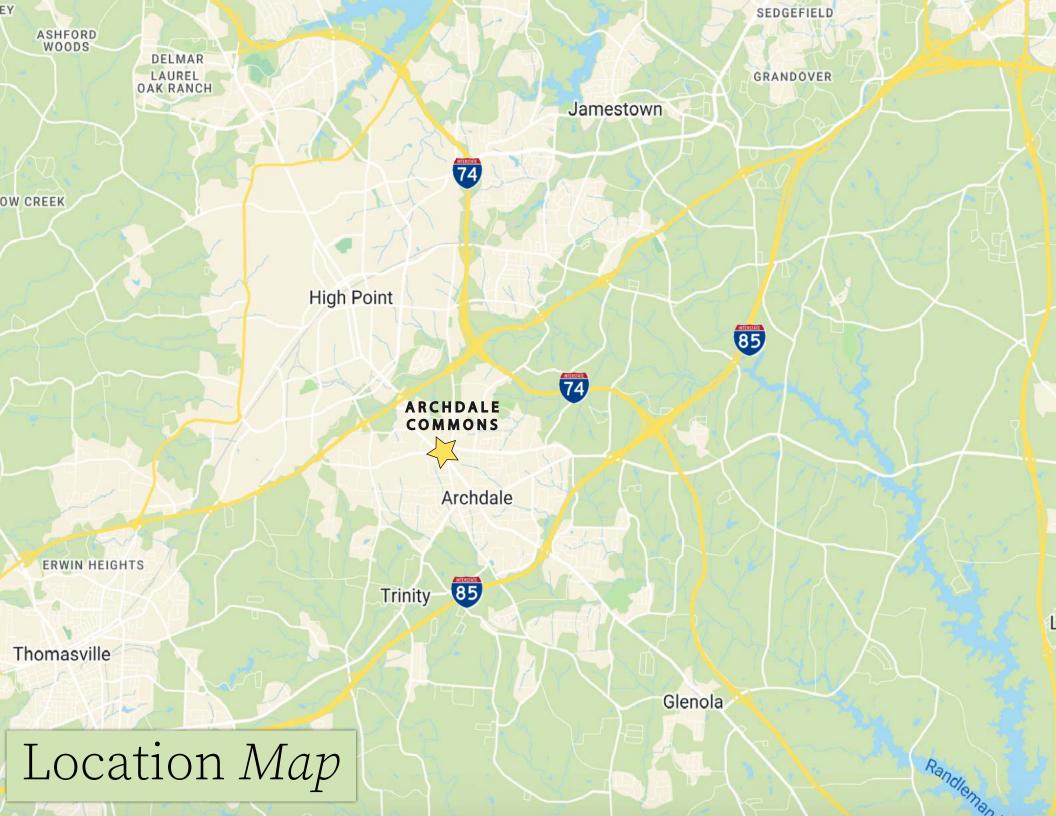




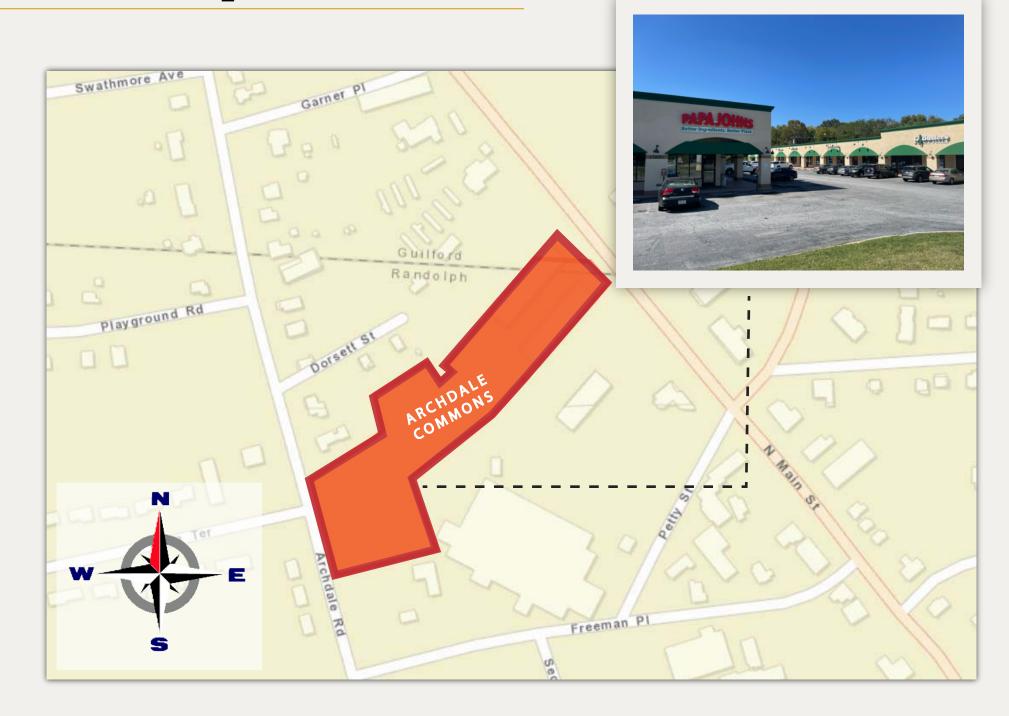








Parcel Map

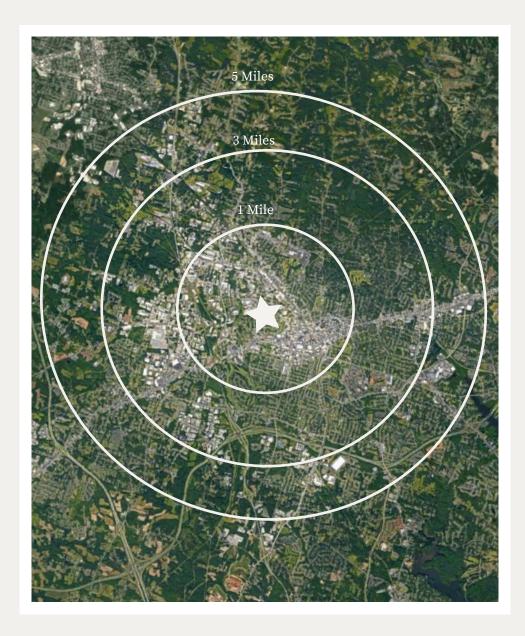
