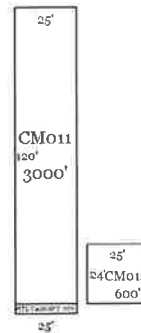

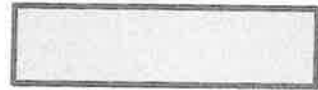


Basic Land Sales Valuation Improvements Parcel Boundary 9
