PROPERTY DETAILS

7737 Burnet Ave was originally constructed in 1955 as an approximate ±9,200 sq. ft. “horse shoe” shaped building. In later years, an approximate ±3,300 sq. ft. structure plus a ±2,000 sq. ft. office mezzanine was constructed in the center portion of the property to form an approximately ±14,200 sq. ft. building.

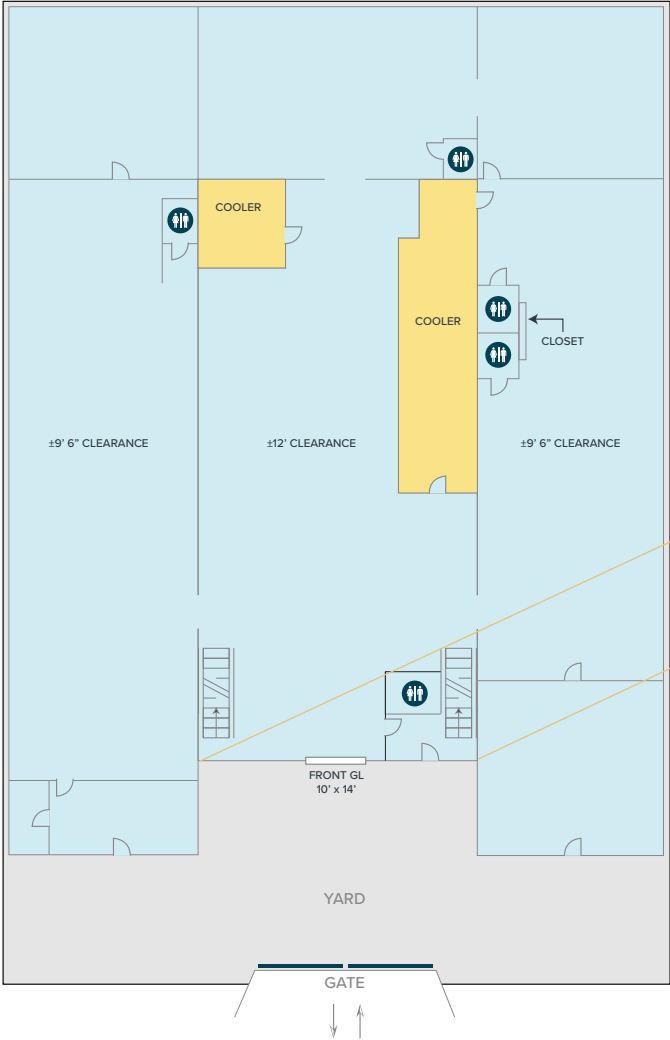
There are coolers inside the building left by previous tenant. The building has a fire sprinkler system and an approximately 12’ x 12’ ground loading door.

There is a concrete fenced yard for parking and loading. The Property is well located in a homogeneous industrial area, less than one mile from the 405 Fwy on/ off ramp at Sherman Way. The property is ranked 806/1,000 (“Very High” rating) for its overall location.

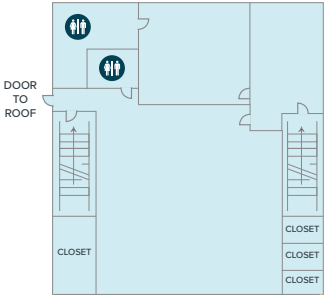


SITE PLAN

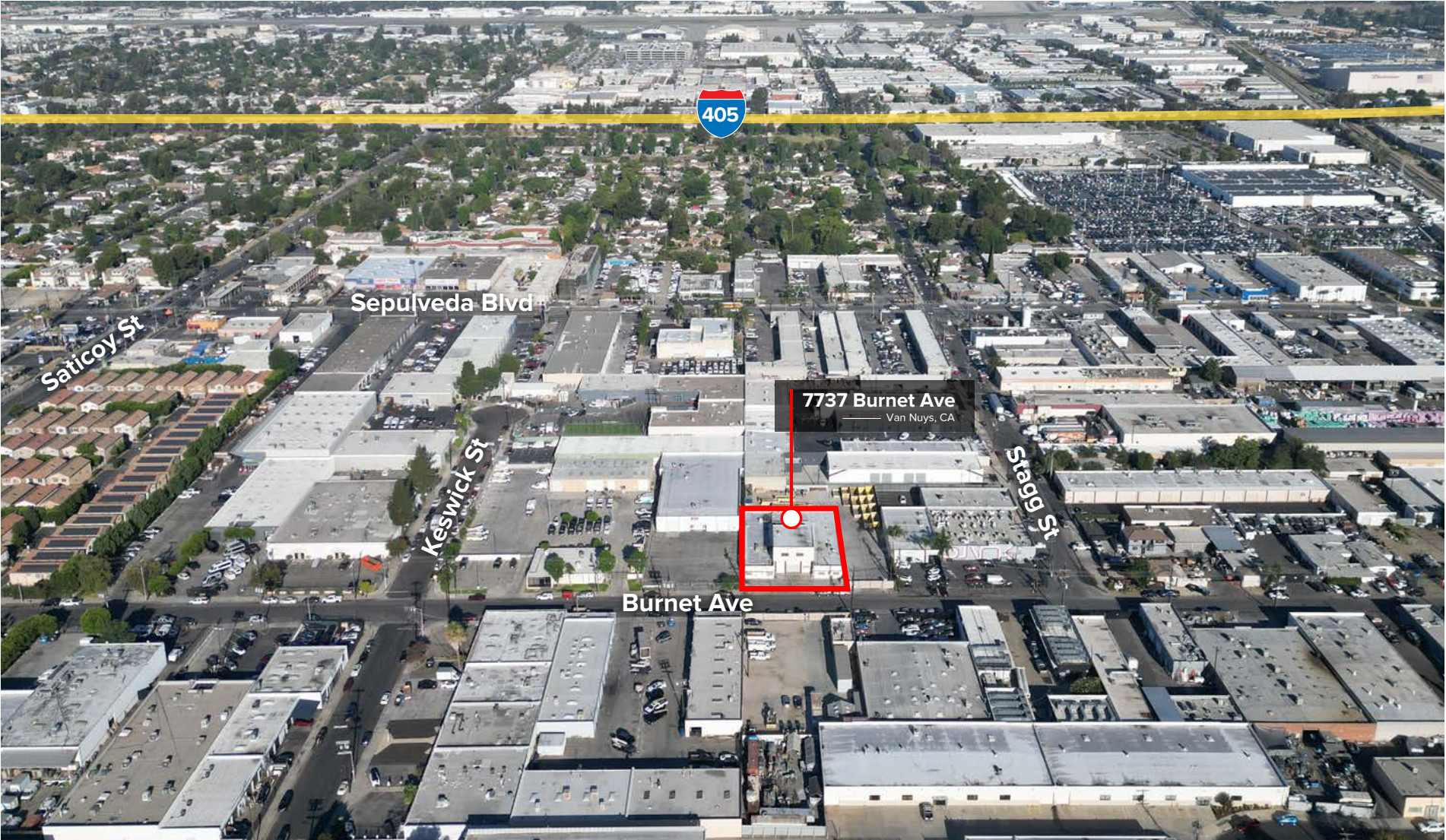

PROPERTY AERIAL

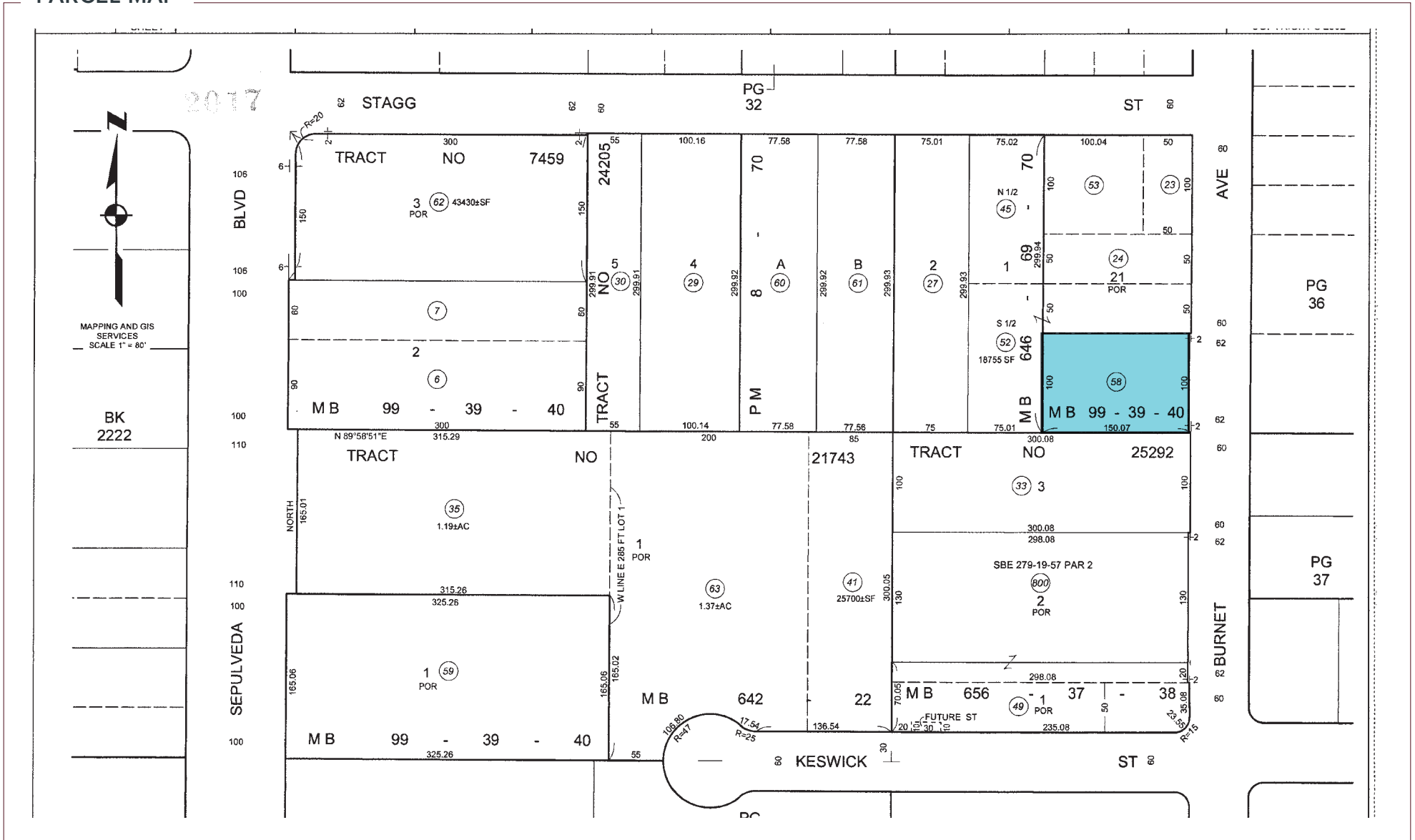

PROPERTY AERIAL

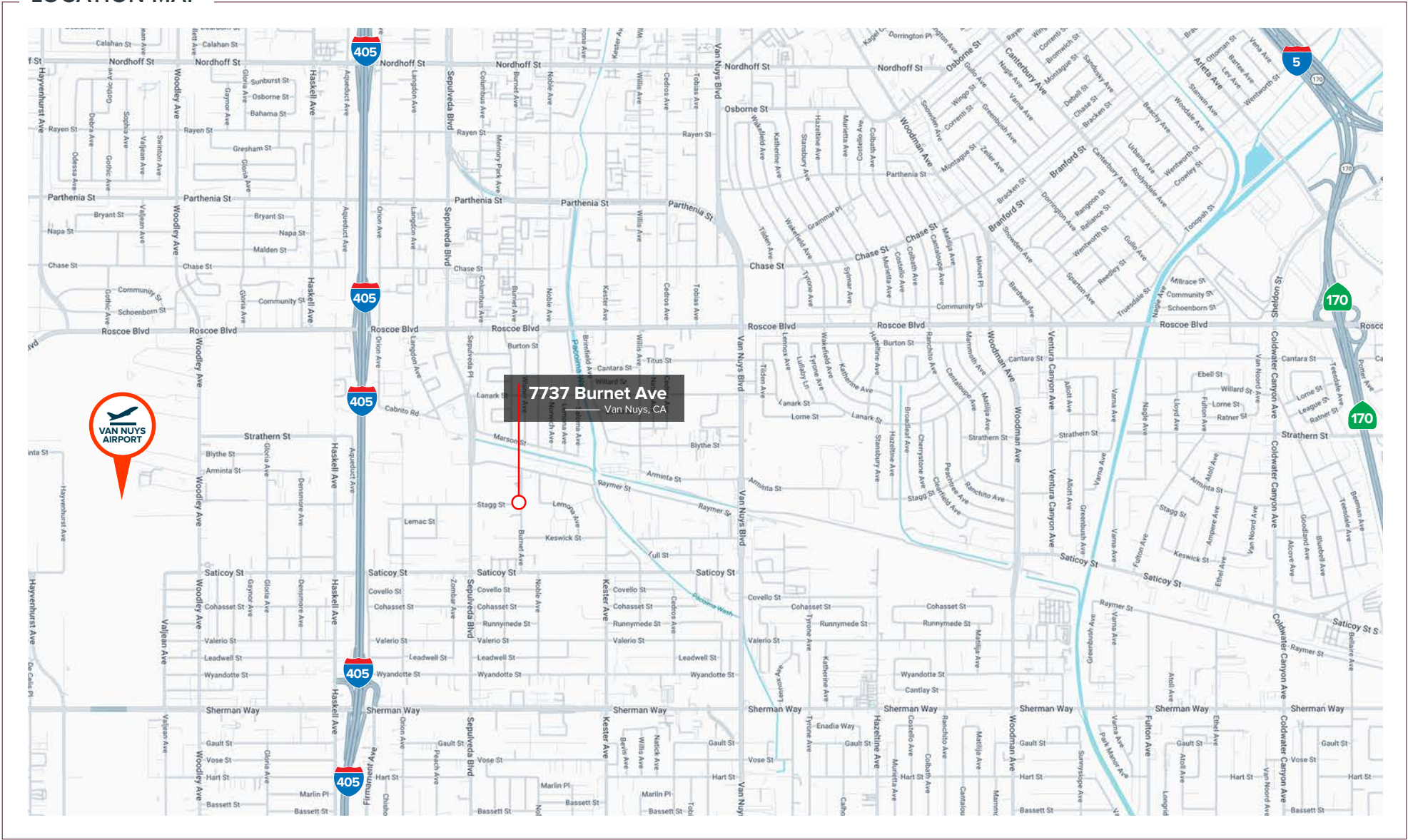


PARCEL MAP
