THIS DEED, made this 2nd day of September, 2020, by Debra Magrann and husband, Ronald Magrann, of Port St. Lucie, FL; Donna Napolitano, unmarried, of Oak Park, IL; and Janet Morgano, unmarried, of Lake Worth, FL, parties of the first part; to Samuel W. Harris and wife, Janet H. Harris, PO Box 100, Macon, NC 27551, parties of the second part,

# WITNESSETH:

THAT, for and in consideration of the sum of TEN DOLLARS (\$10.00) and other valuable considerations paid by the parties of the second part to the parties of the first part, the receipt of which is hereby acknowledged, the parties of the first part have bargained, granted, sold and conveyed and by these presents do hereby bargain, grant, sell and convey to and unto the parties of the second part, as tenants by the entirety, the following described land in Sixpound Township, Warren County, North Carolina:

# Parcel One:

BEGINNING at an iron pin, corner for the Macon Colored Community Club in Ida Fitts line; thence along the line of said Club S. 0 deg. 42' E. 246 feet to an iron pin in the line of Thornton's Hunt Tract; thence along Thornton's line N. 85 deg. W. 205 feet to an iron pin, corner for the Hunt Tract in the line of the heirs of Rebecca E. Thornton; thence along the Thornton line N. 5 deg. 18' E. 169 feet to an iron pipe, Fitts corner in Thornton's line; thence along Fitts line N. 72 deg. E. 197 feet to the place of beginning, containing 91/100 acre, according to survey of J. C. Shearin, C. Stegall, Registered Engineer of Norlina, North Carolina, Dated December 6, 1969. This is the identical land conveyed by Willie H. Fitts et al to Curtis Ellis by deed dated February 2, 1970 and recorded in said Registry in Book 241, page 165.

The above described property is the identical property conveyed to Louis P.
