Current average household income is \$51,243 in this area, compared to \$74,699 for all U.S. households. Average household income is projected to be \$57,029 in five years, compared to \$84,910 for all U.S. households

Current per capita income is \$22,371 in the area, compared to the U.S. per capita income of \$28,597. The per capita income is projected to be \$24,980 in five years, compared to \$32,501 for all U.S. households

Currently, 43.9% of the 134,673 housing units in the area are owner occupied; 46.2%, renter occupied; and 9.9% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 132,914 housing units in the area - 46.1% owner occupied, 45.4% renter occupied, and 8.6% vacant. The annual rate of change in housing units since 2010 is 0.59%. Median home value in the area is \$114,211, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 2.55% annually to \$129,544.
