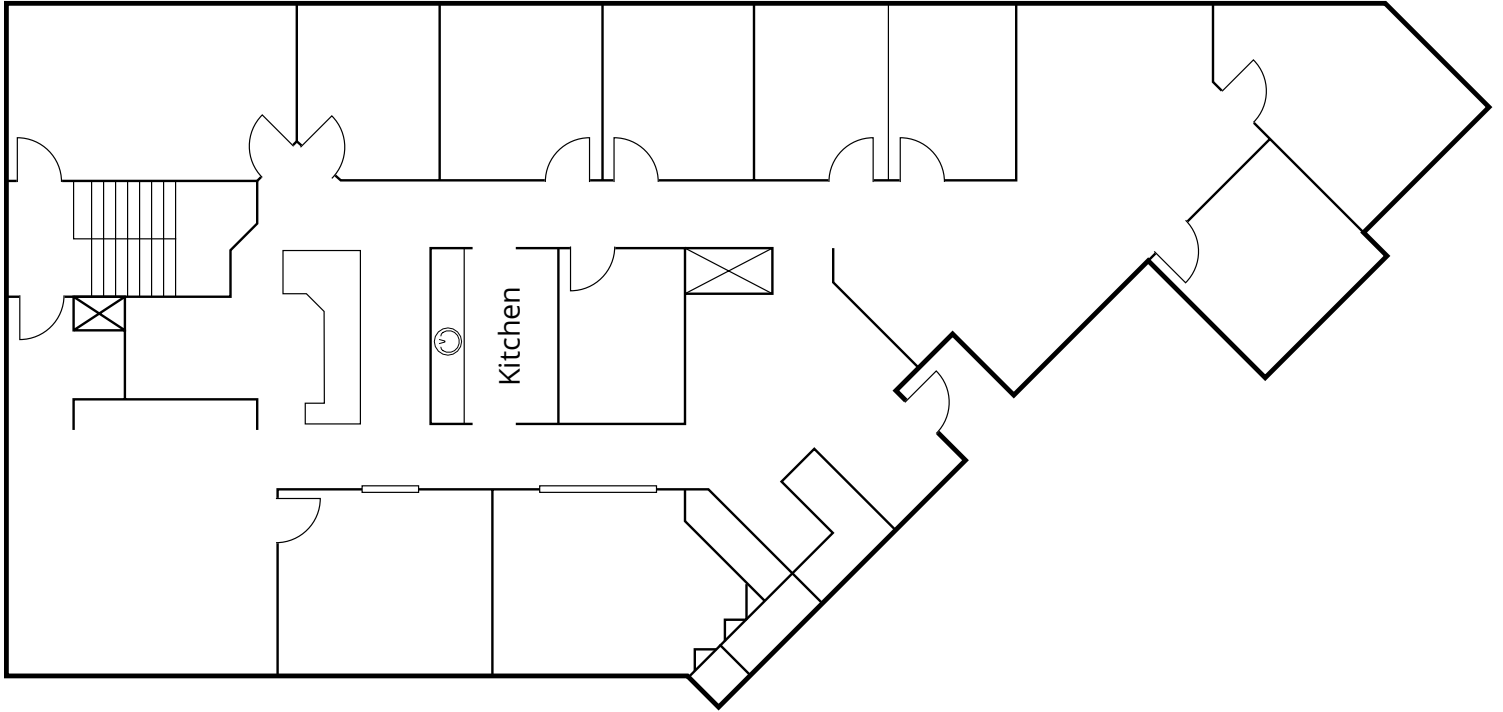

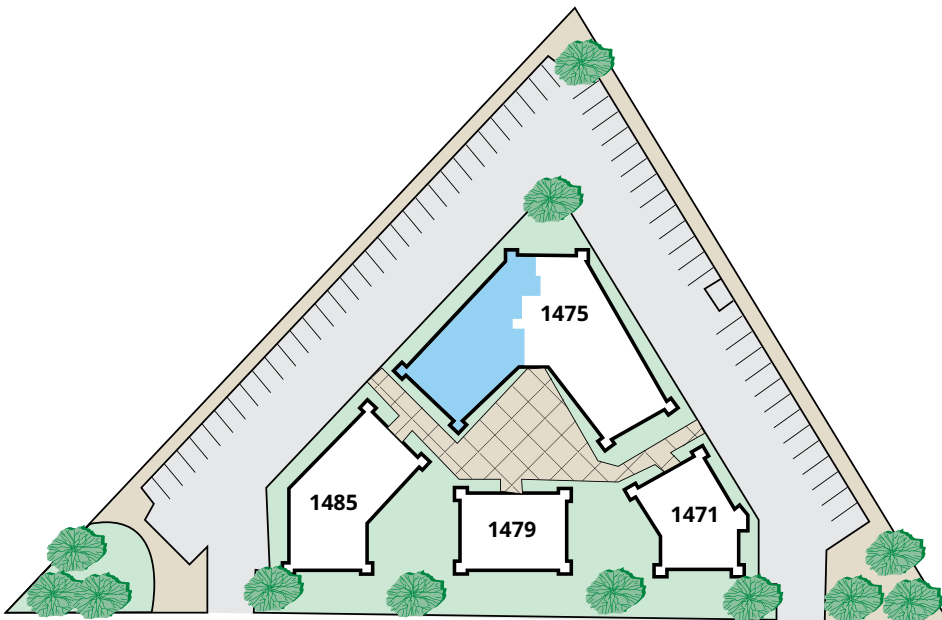

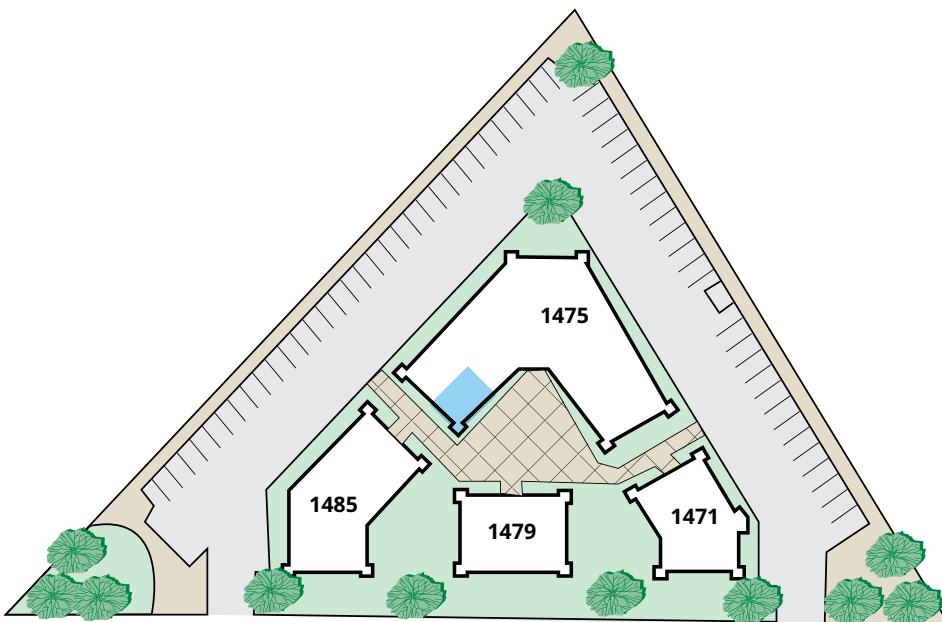

Site Plan



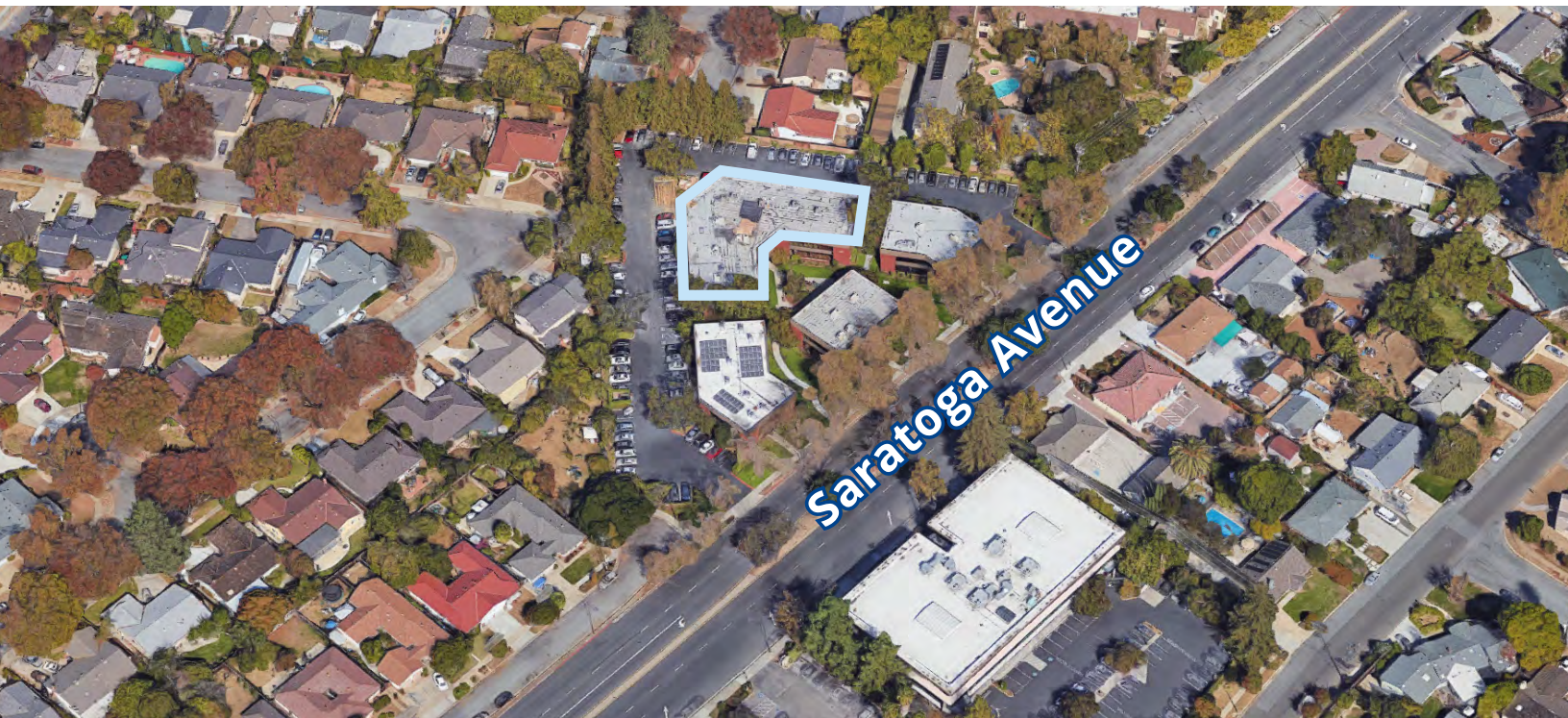

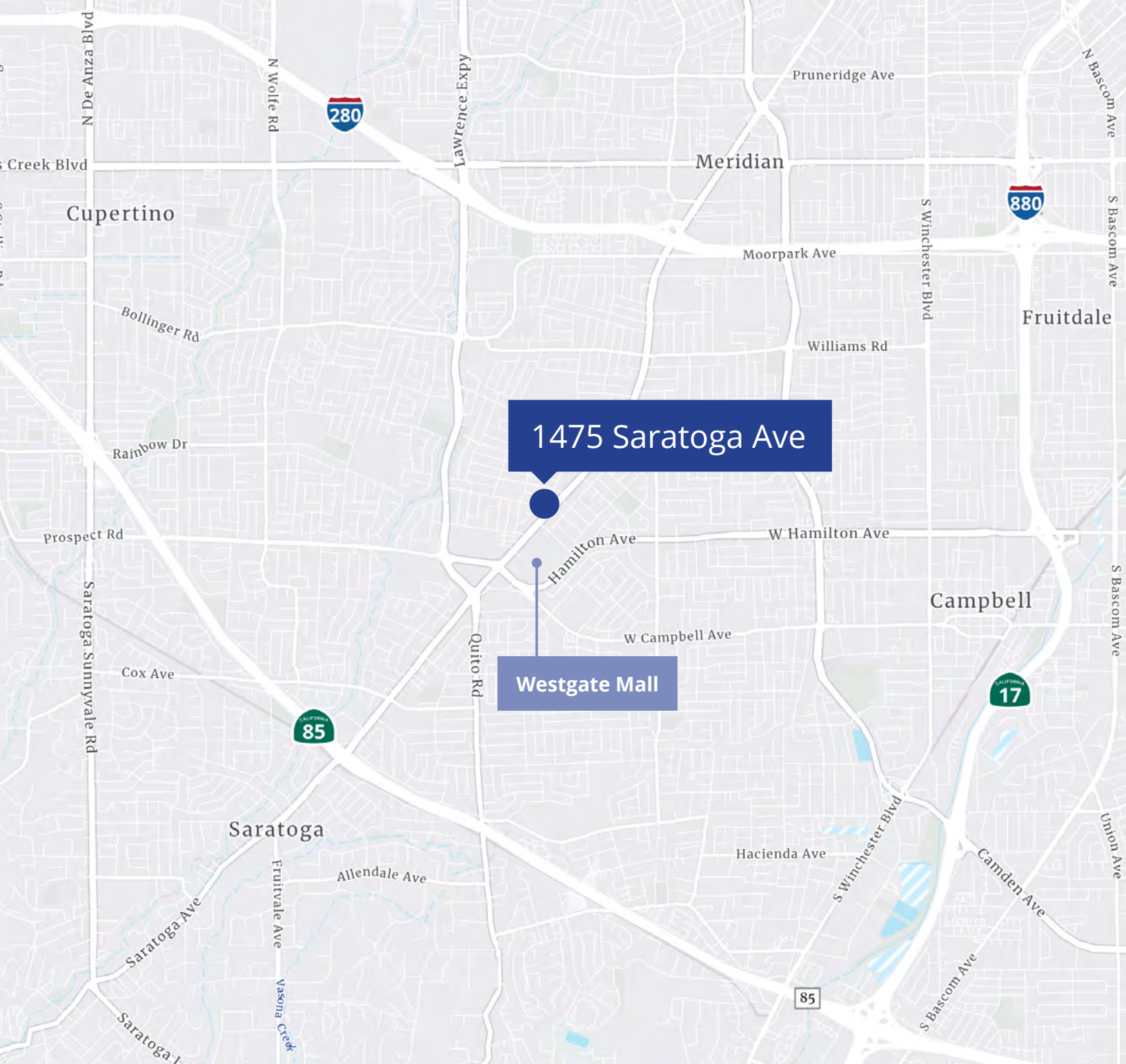
