

The subject is formerly the Marana Community Correctional Treatment Facility (MCCTF), which was one of 13 prison facilities in Arizona housing prisoners of the Arizona Department of Corrections (ADC). The facility is a secure, minimum custody private prison that was under contract with the Arizona Department of Corrections to provide custody and substance abuse treatment for 450 adult male offenders who have demonstrated a need for substance or alcohol abuse intervention. The facility opened on October 7, 1994 and was operated and managed by Management and Training Corporation of Utah. The facility was closed at the end of 2023.




