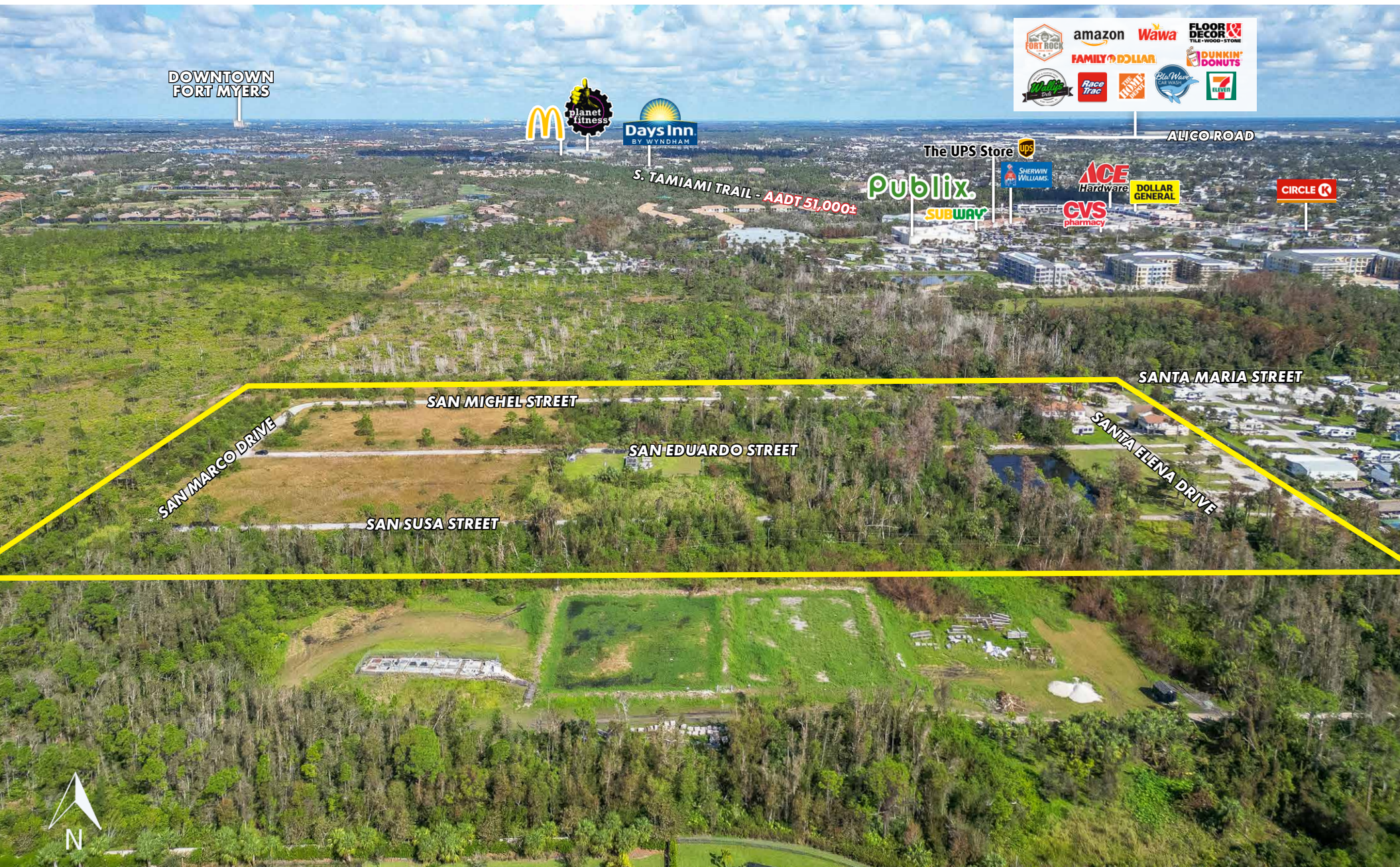
EXECUTIVE SUMMARY

Calusa Cove Mobile Home & RV Park is a 20.1± acre RV park located off US-41 in Fort Myers, FL. It consists of 131 separately plotted lots, ranging from 0.11± to 0.22± acres. The in-place zoning (MH-1) allows for a mobile home/RV park to be revitalized here. The park has County water and a functioning on-site sewer treatment plant. Easements are in place to draw public sewers to the site for future redevelopment if needed.

Located in South Lee County, Calusa Cove offers close connectivity to the beaches of Fort Myers and Bonita Springs and the Village of Estero. The property is situated in one of the core commercial/retail corridors in Fort Myers, providing a host of amenities and attractions to its residents. With direct but secluded access to US-41, this site offers privacy and tranquility to its guests, while also being in close proximity to a range of essentials like a Publix supermarket, pharmacies, restaurants and multiple employment centers.



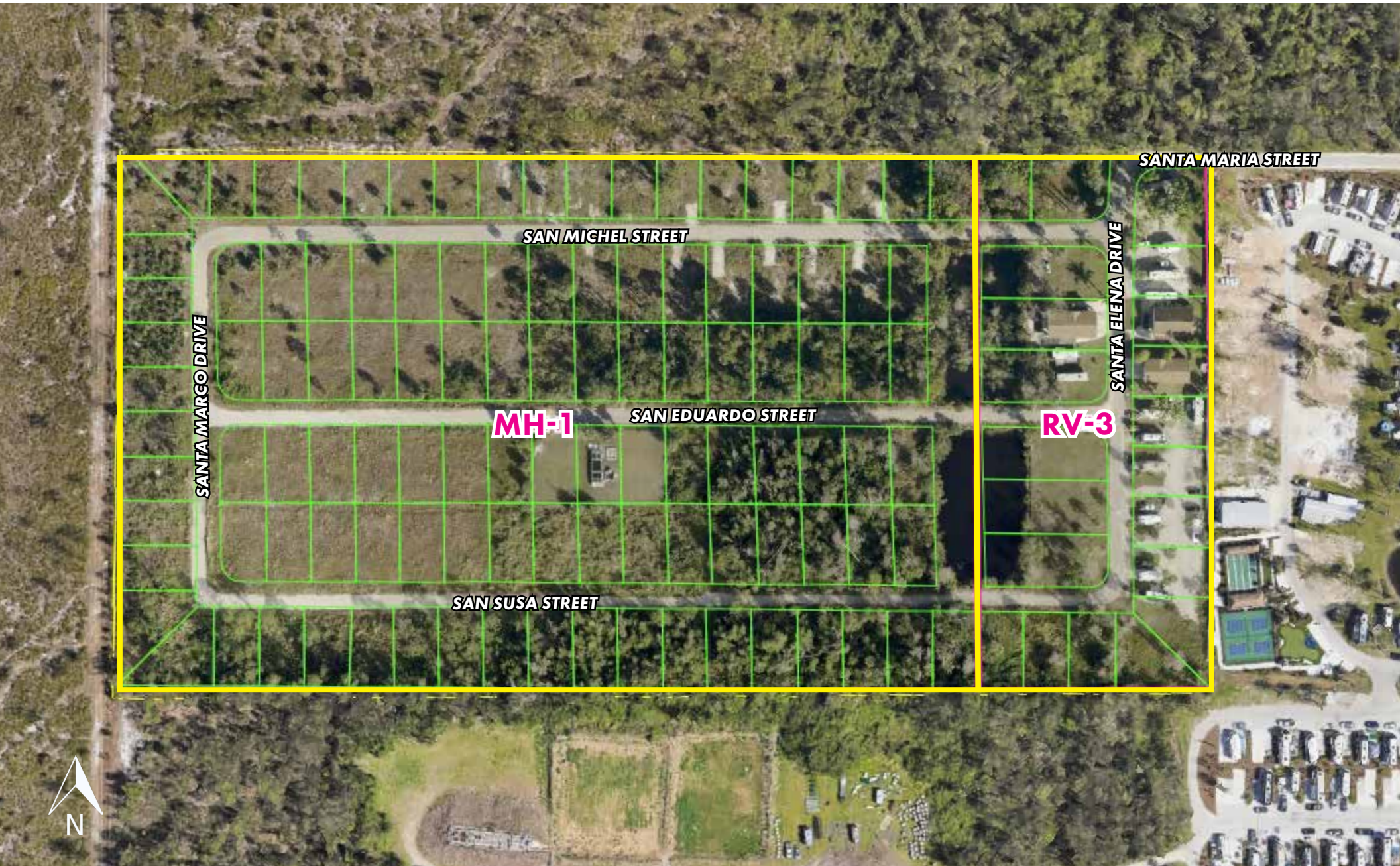

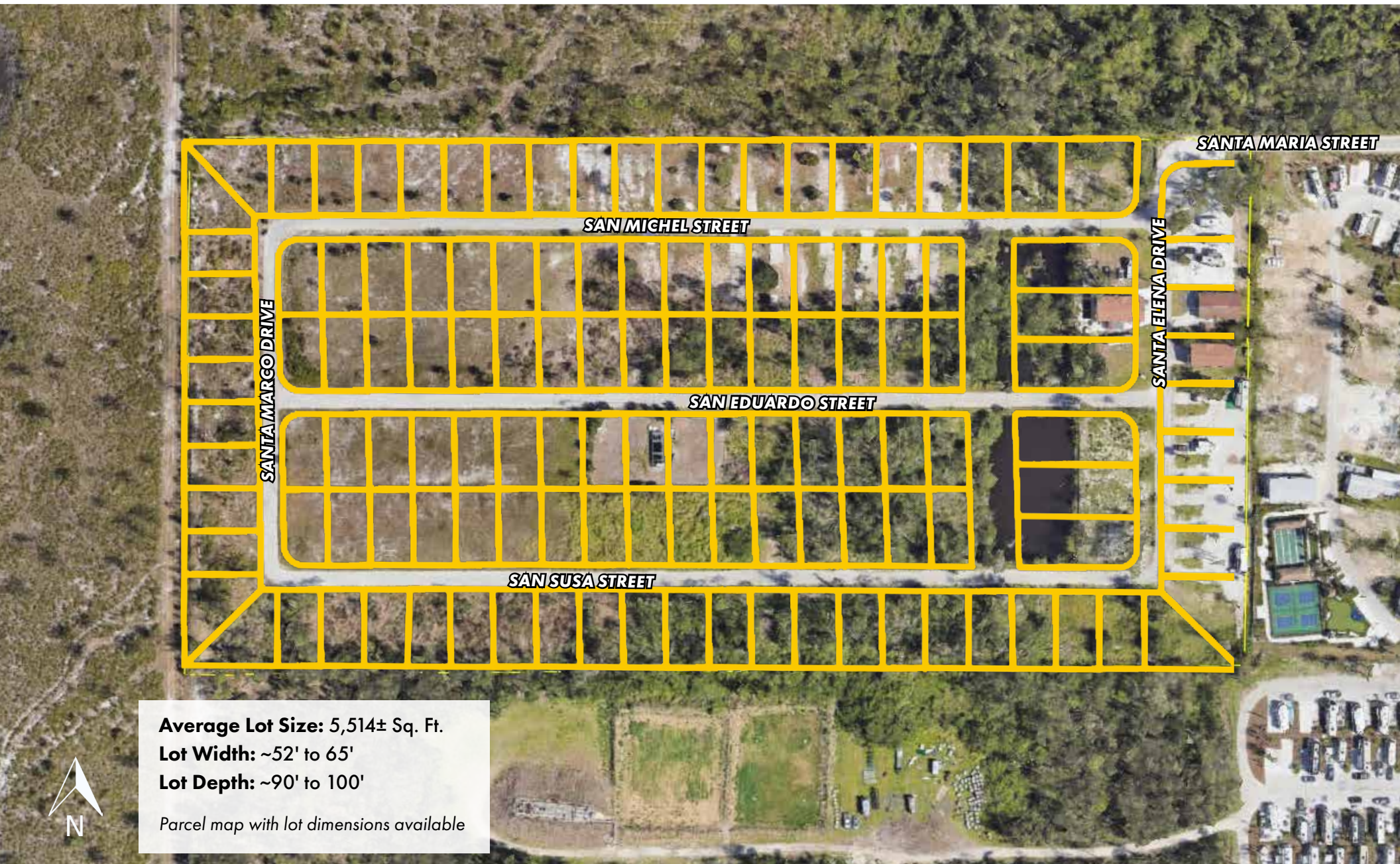

BARBARA B. MANN PERFORMING ARTS HALL

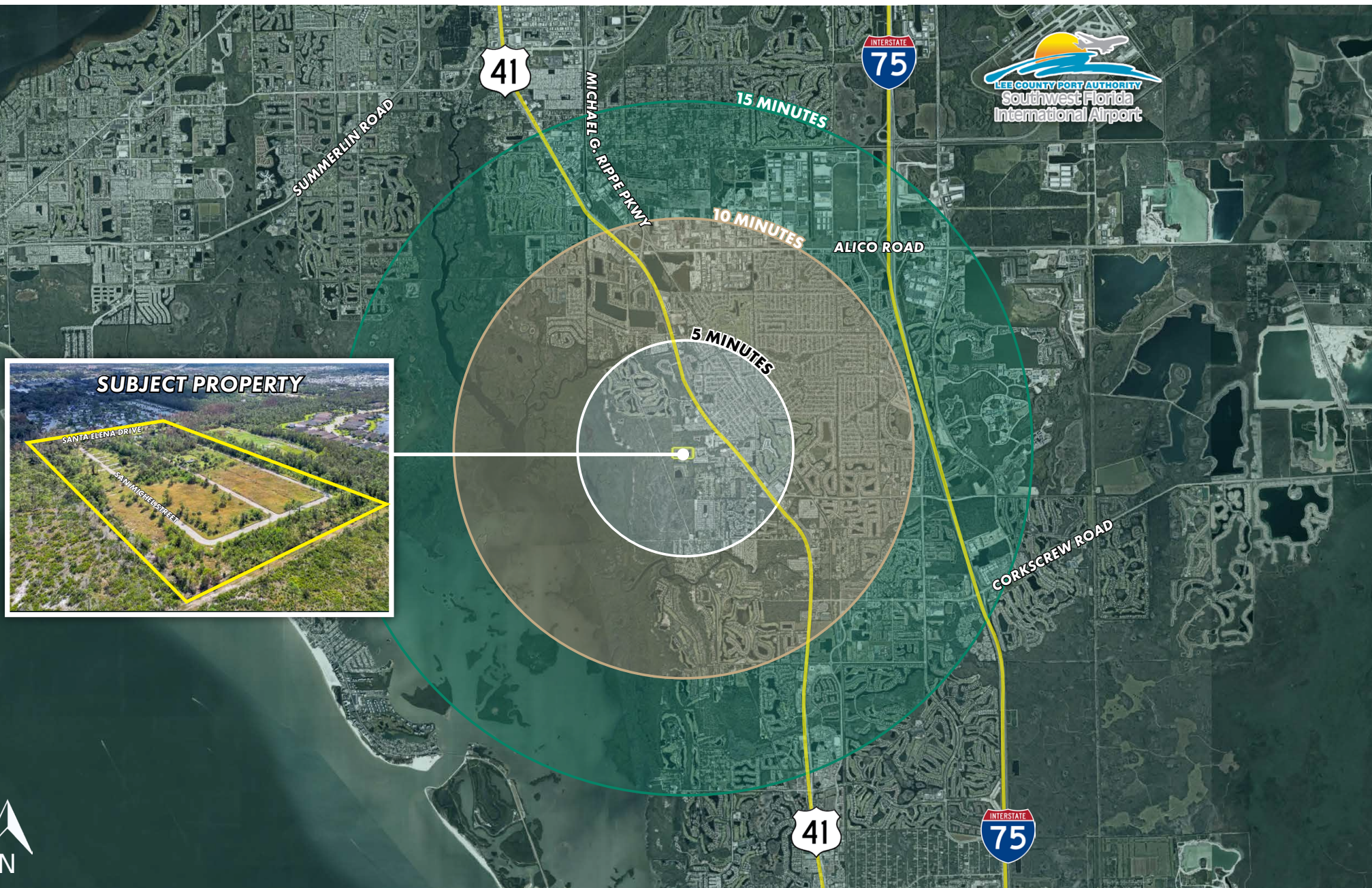
Located at FSW, Barbara B. Mann presents National Touring Broadway musicals, prominent entertainers and music concerts.



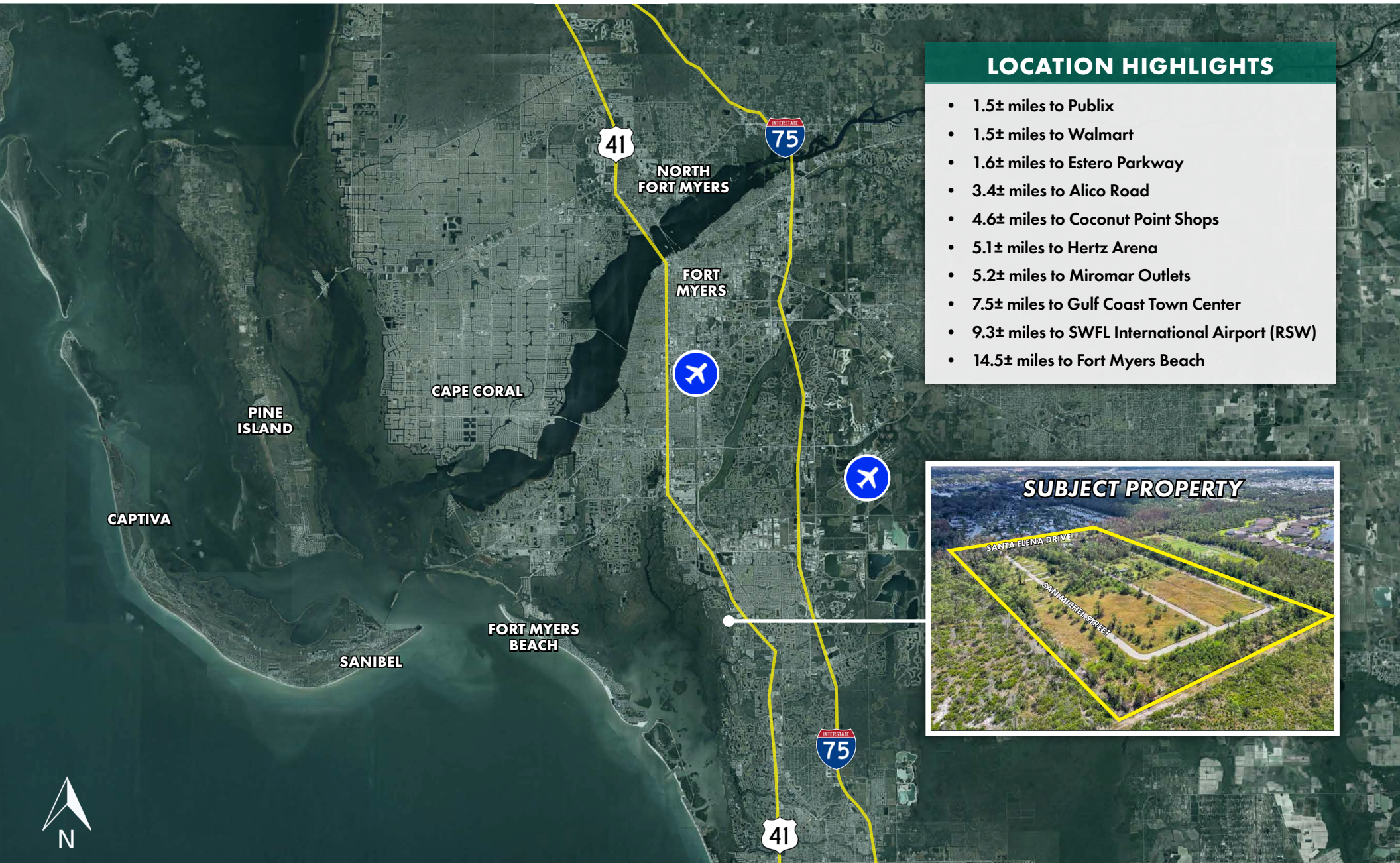
DOWNTOWN FORT MYERS
