Using a purchase price of \$2.95 million, then deducing the NPV of the 8-yr graduated Tax Abatement, the Net Effective Sales Price is \$2.2 million.

There also is an existing performing 6-unit building valued at \$1.8 million. This leaves \$450,000 allocated towards the 51 Approved Units, pricing them at \$8,800/per unit which is significantly below market value in Eastern Connecticut.

Details of Additional Benefits & Sources of Revenue

- Current potential NOI \$150K annually for 8 existing Rental Units, I unit remains unfinished
- Projected NOI estimated upon completion of the 57-unit multi-family community over \$1.2M
 annually
- Full approvals from the City of Norwich attained 1/17/2023.
- 8-year graduated tax abatement with an estimated NPV of \$750K
- Full width private Terraces & Decks with views add a minimum of \$350 a month in additional rental revenue above market rents. 40 units have this amenity adding an additional \$168K in annual revenue.
- Units have been designed to best meet a Condo Conversion.
- Amenity Center has 14 rental garages plus 14 storage space which becomes an additional annual revenue of \$58.8K
- The Amenity Center will have a membership fee which will generate an additional annual revenue estimated at \$54K.
- Buildings 1 & 2 have 5X8X8 tenant storage spaces for each tenant located at the parking level.
 These storage spaces could generate an additional \$39.7K per year.
- Impervious surfaces reduced by over 45% from original design. Site development cost savings.
- 4.2 acres has been legally withdrawn from the Villas at Riverheights Condo Association with all associated costs paid for this Land withdrawal.
