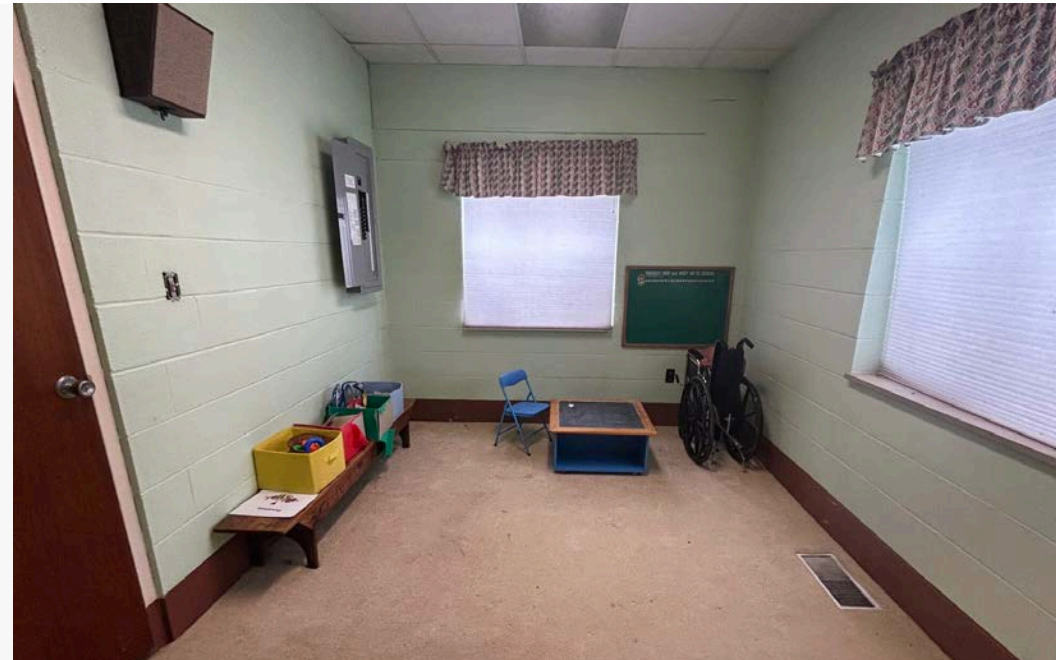

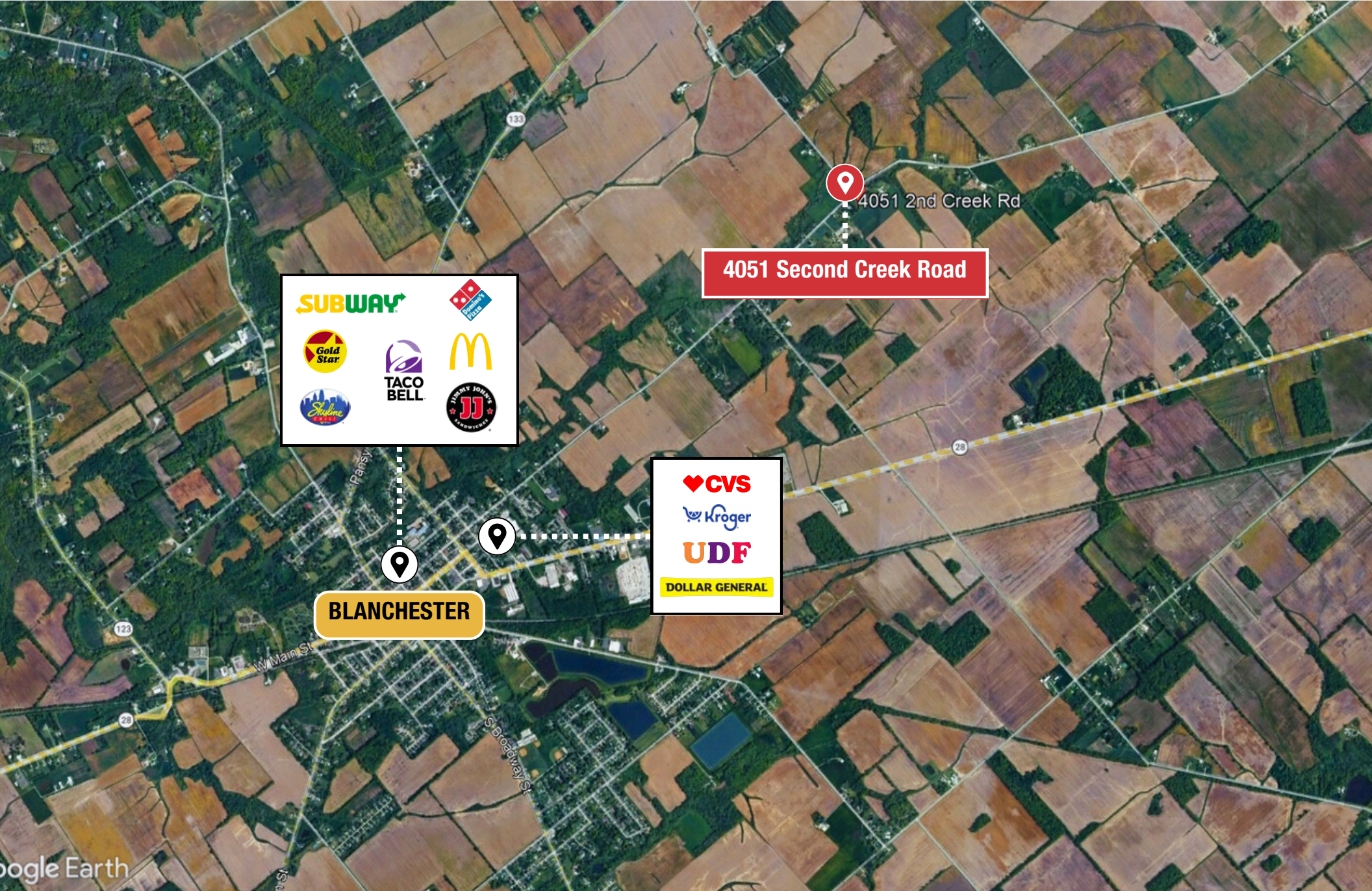

RETAILER MAP

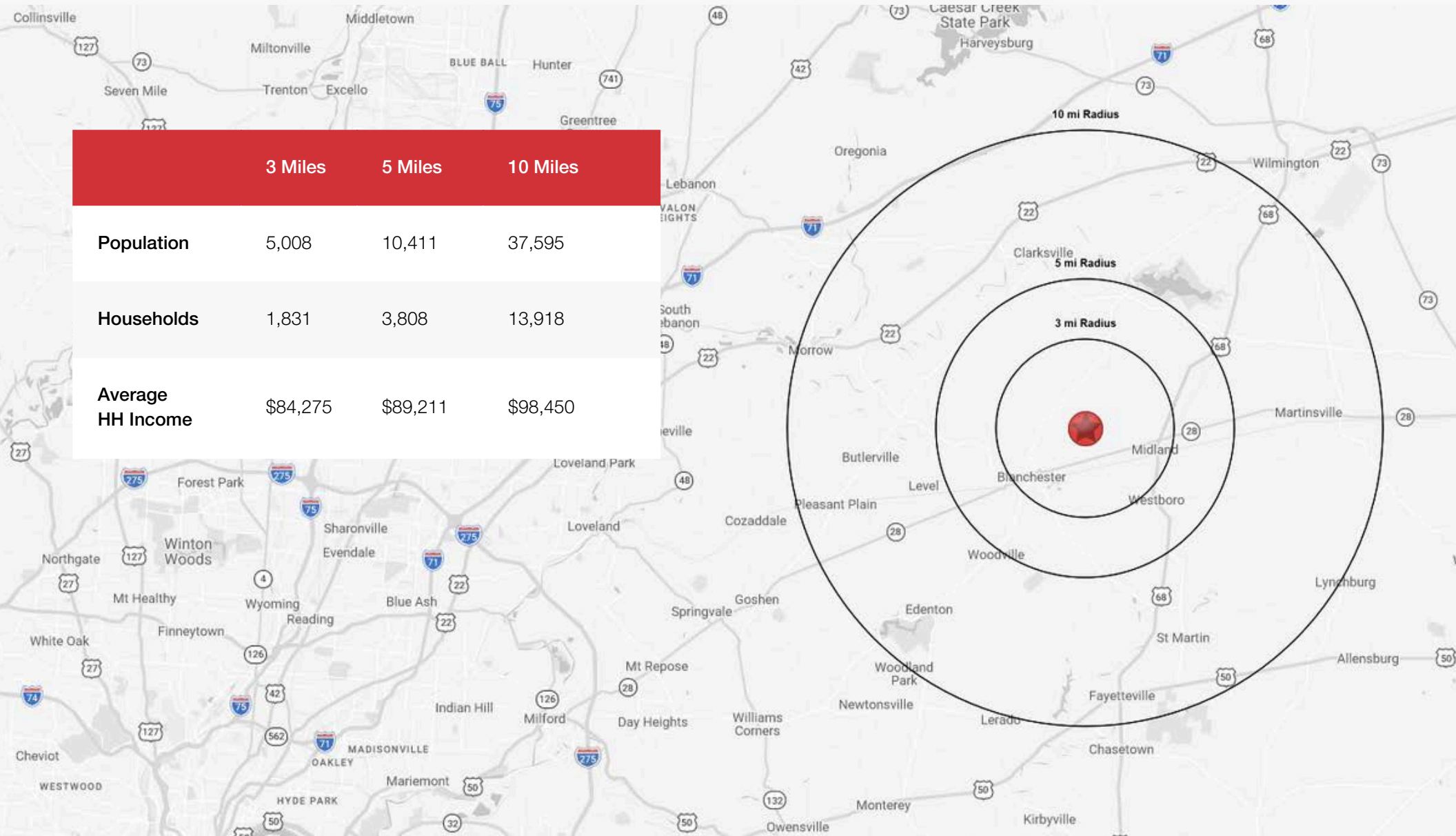
