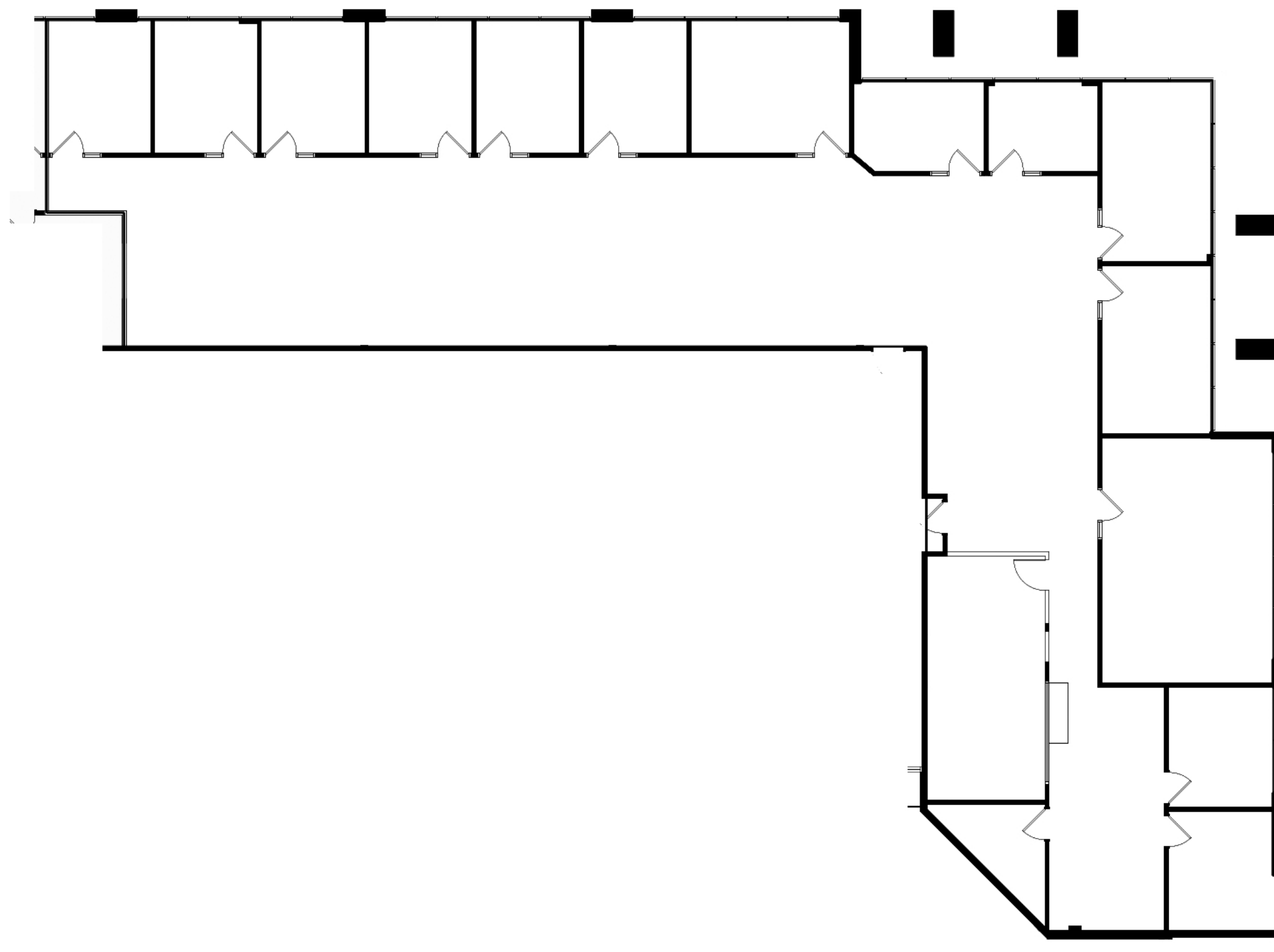

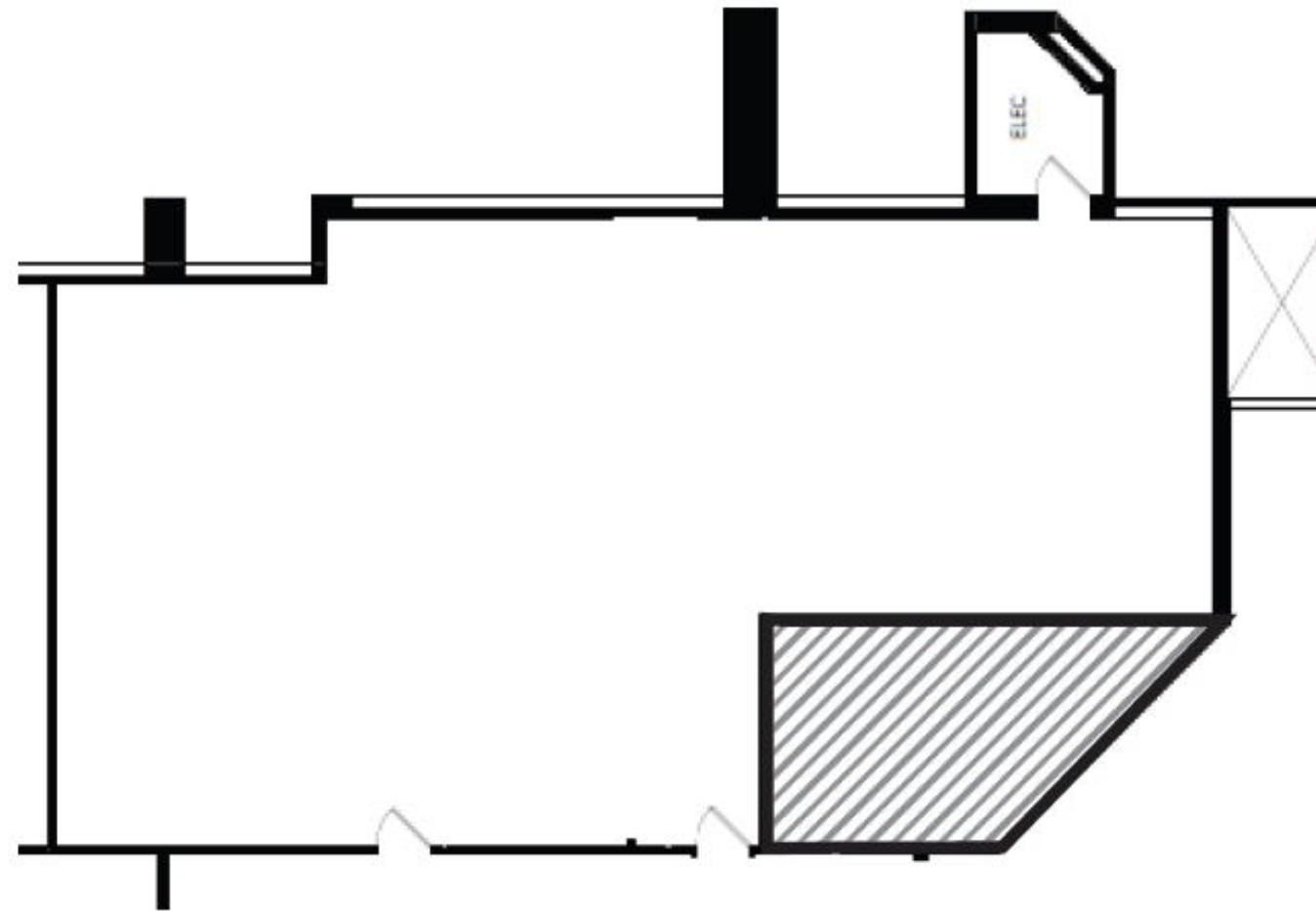

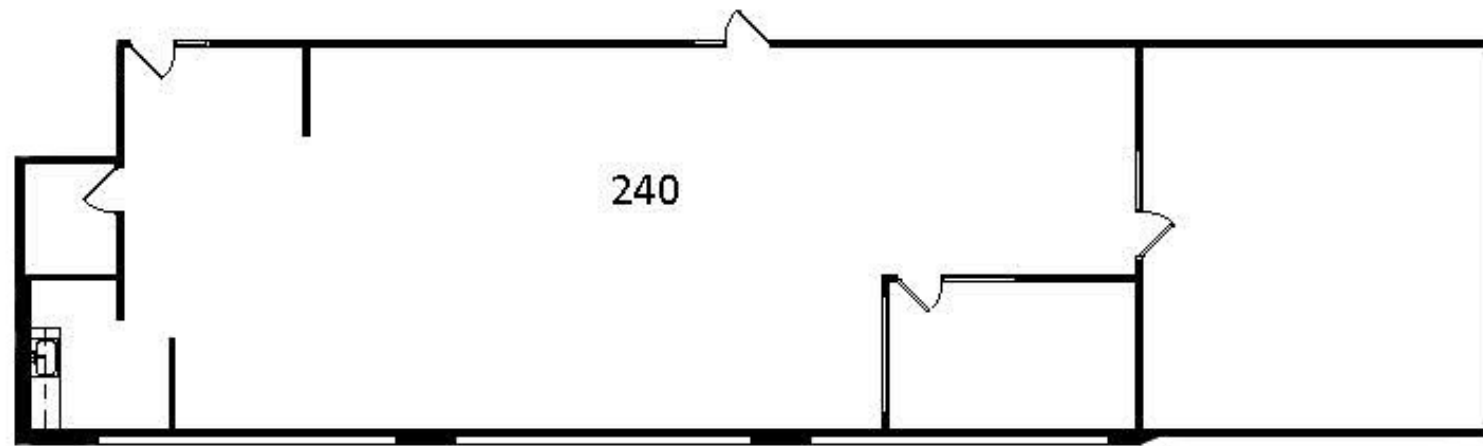


Floor Plan

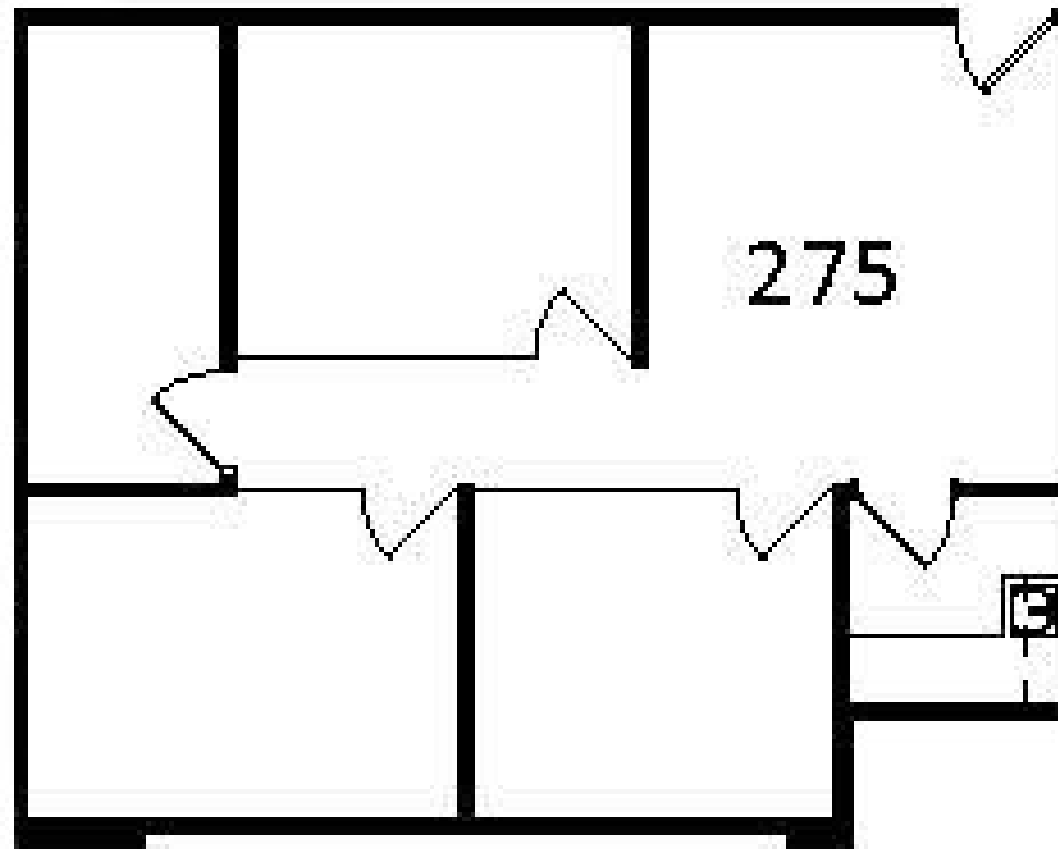
