

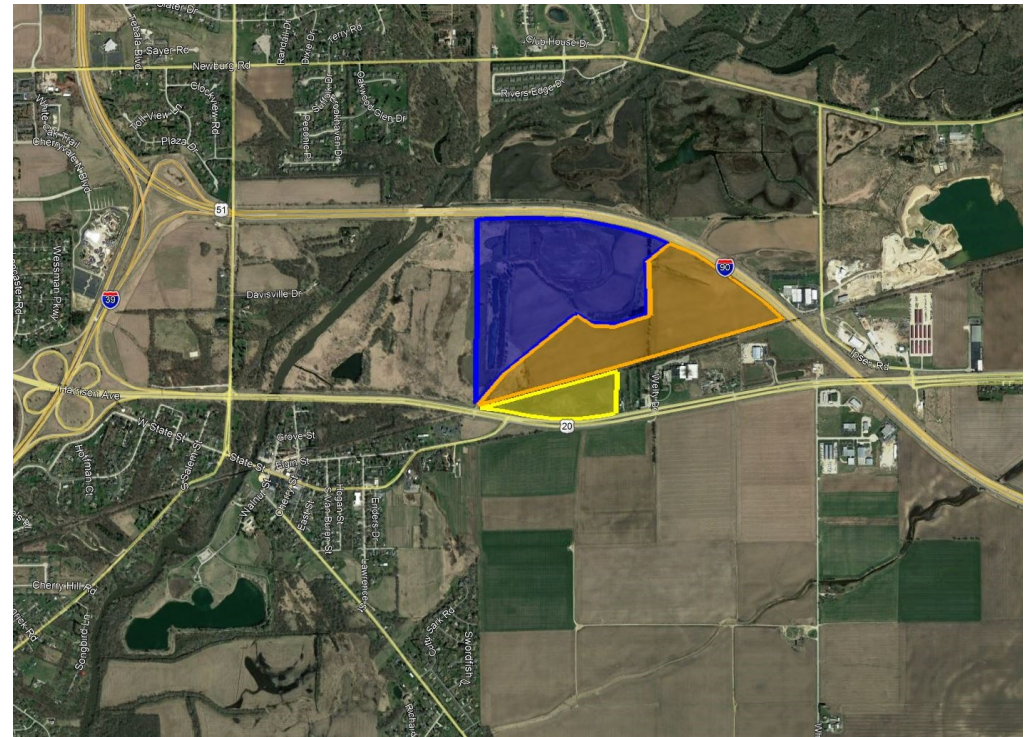

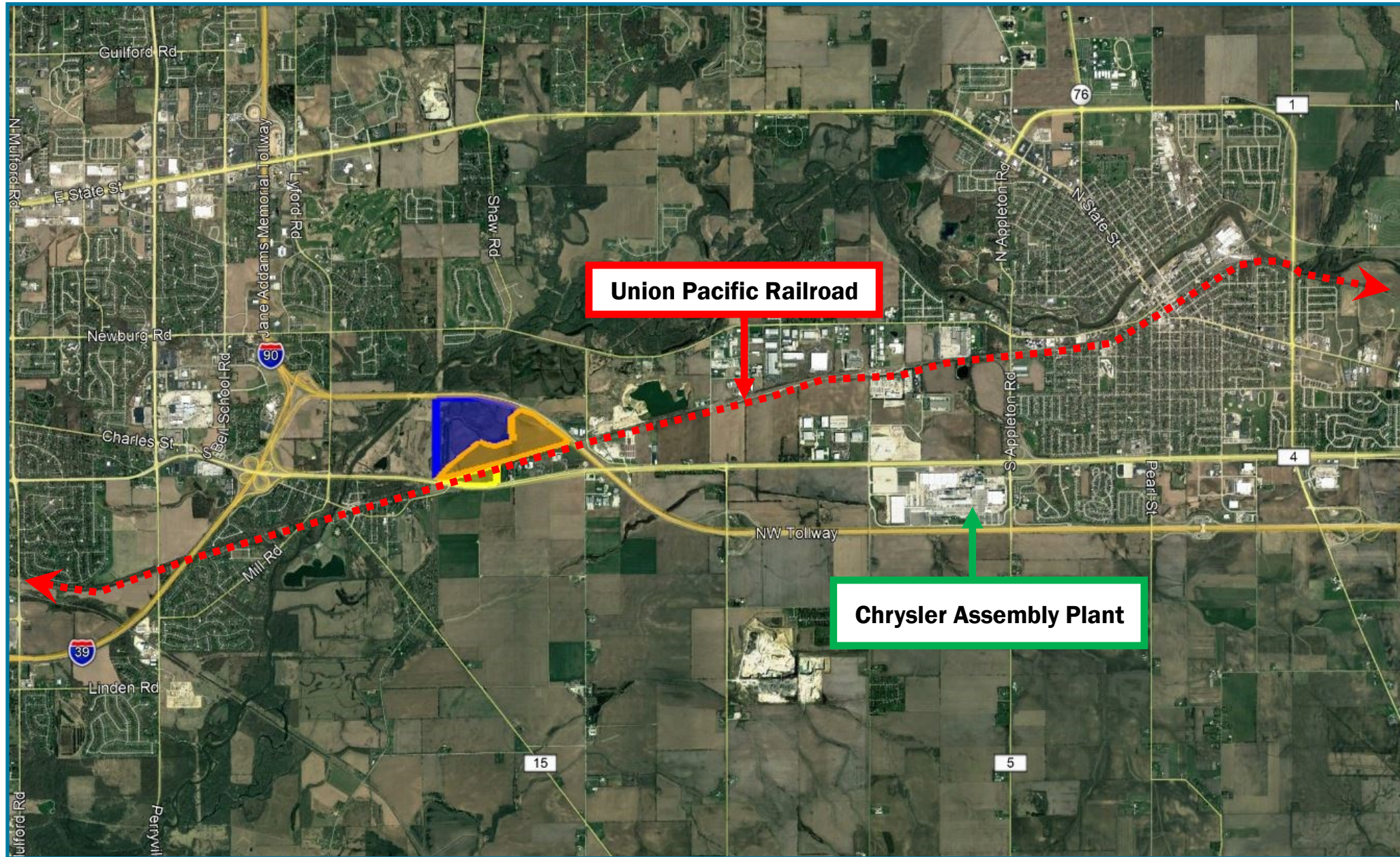

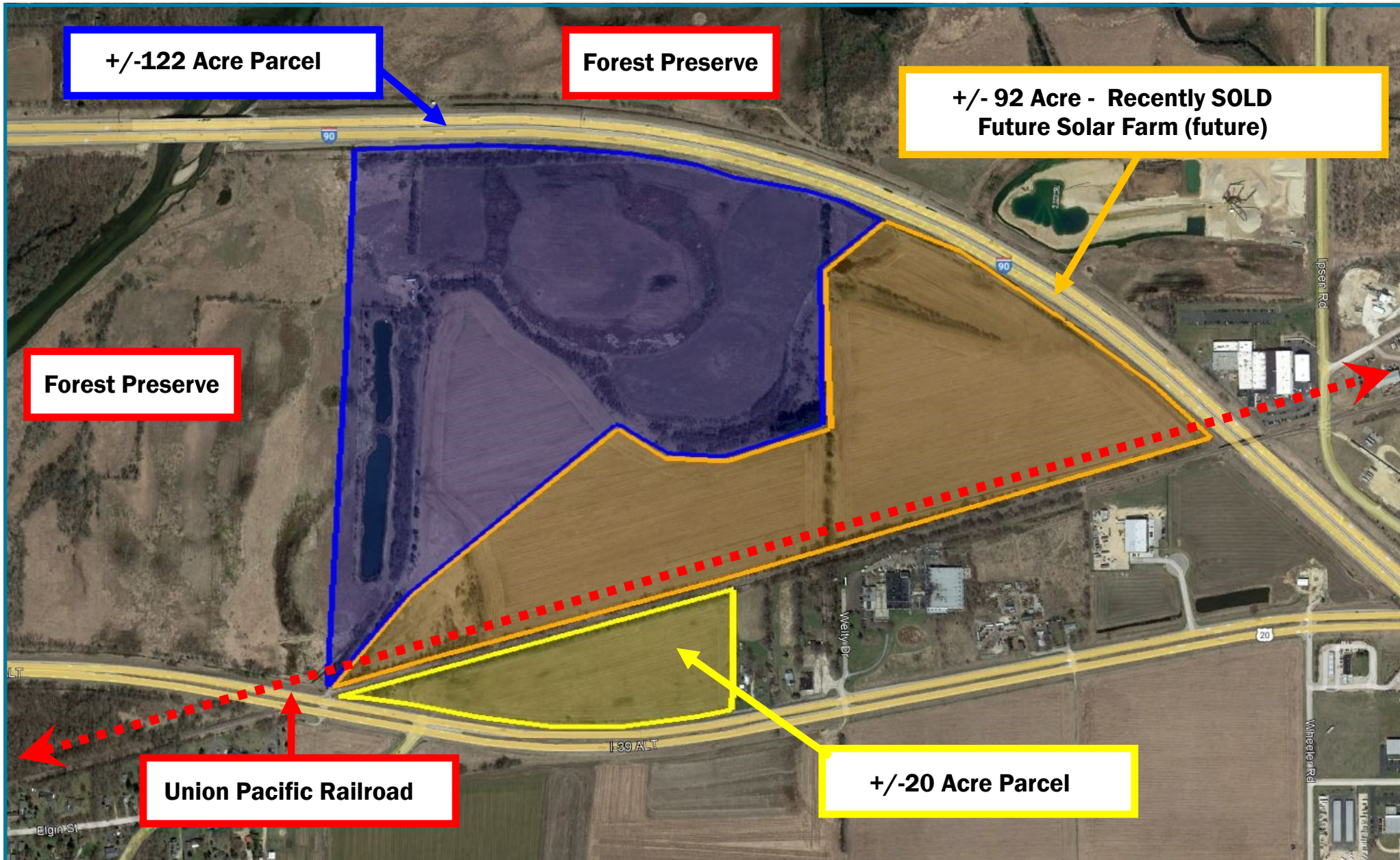

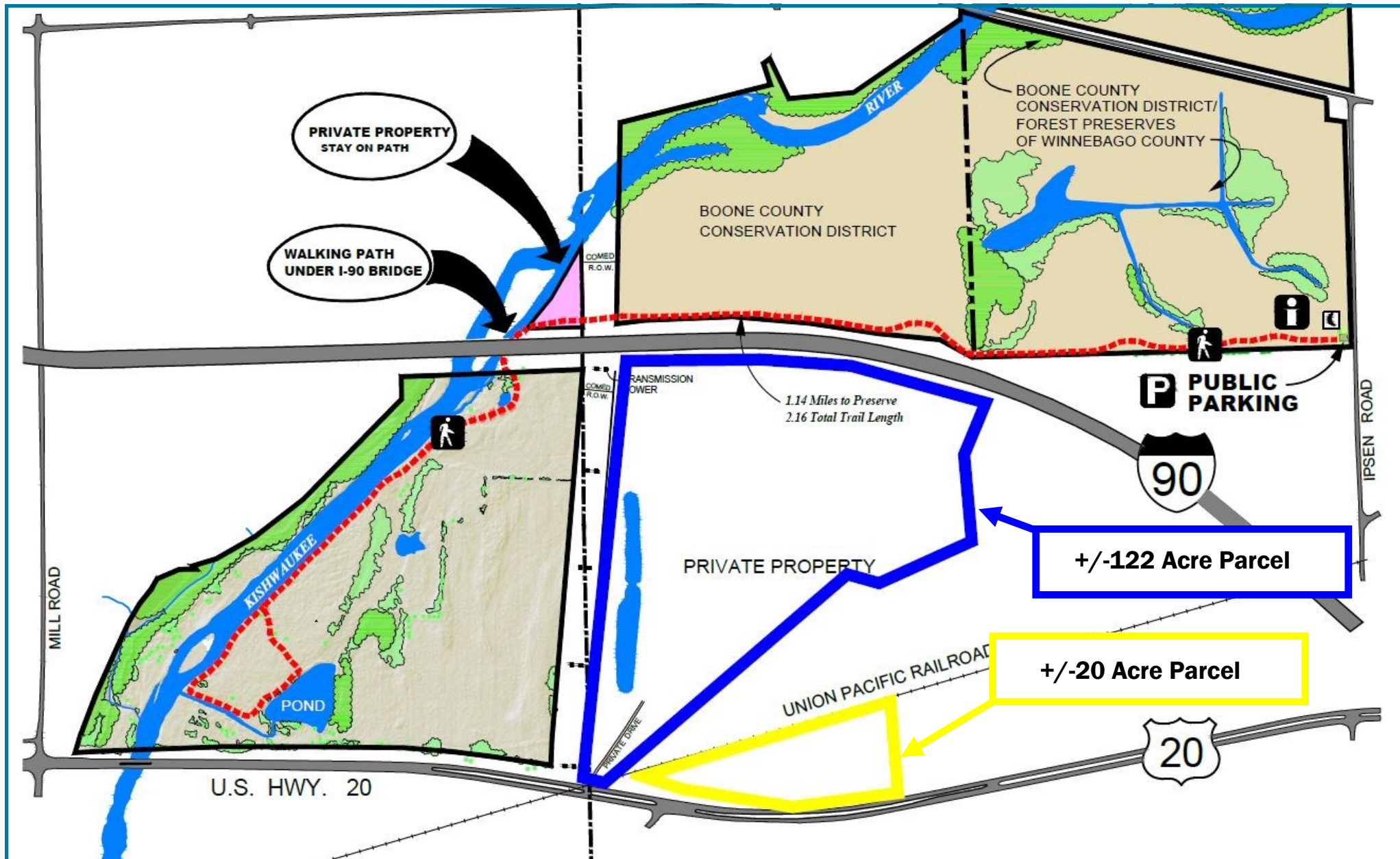

Forest Preserve

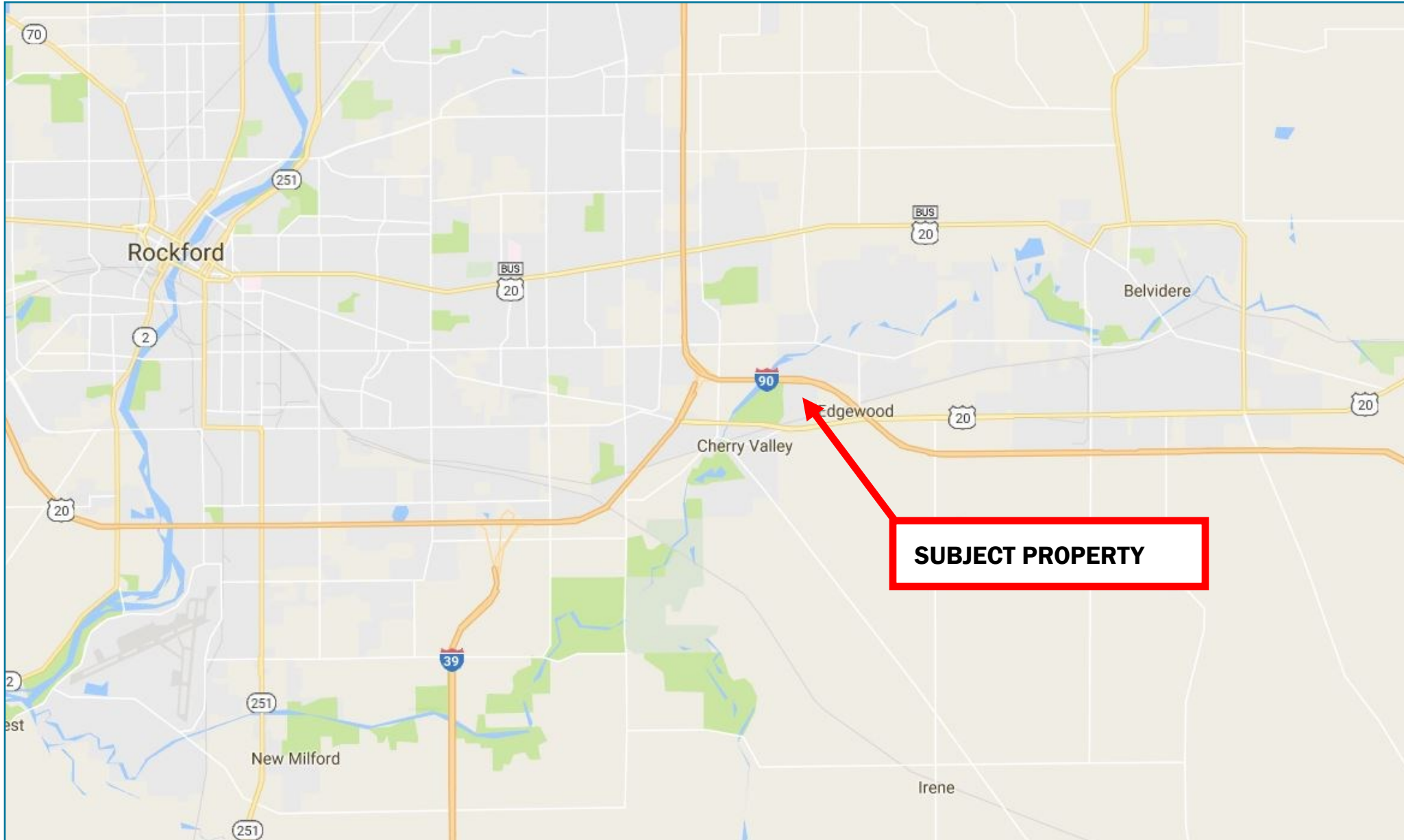

Location Map

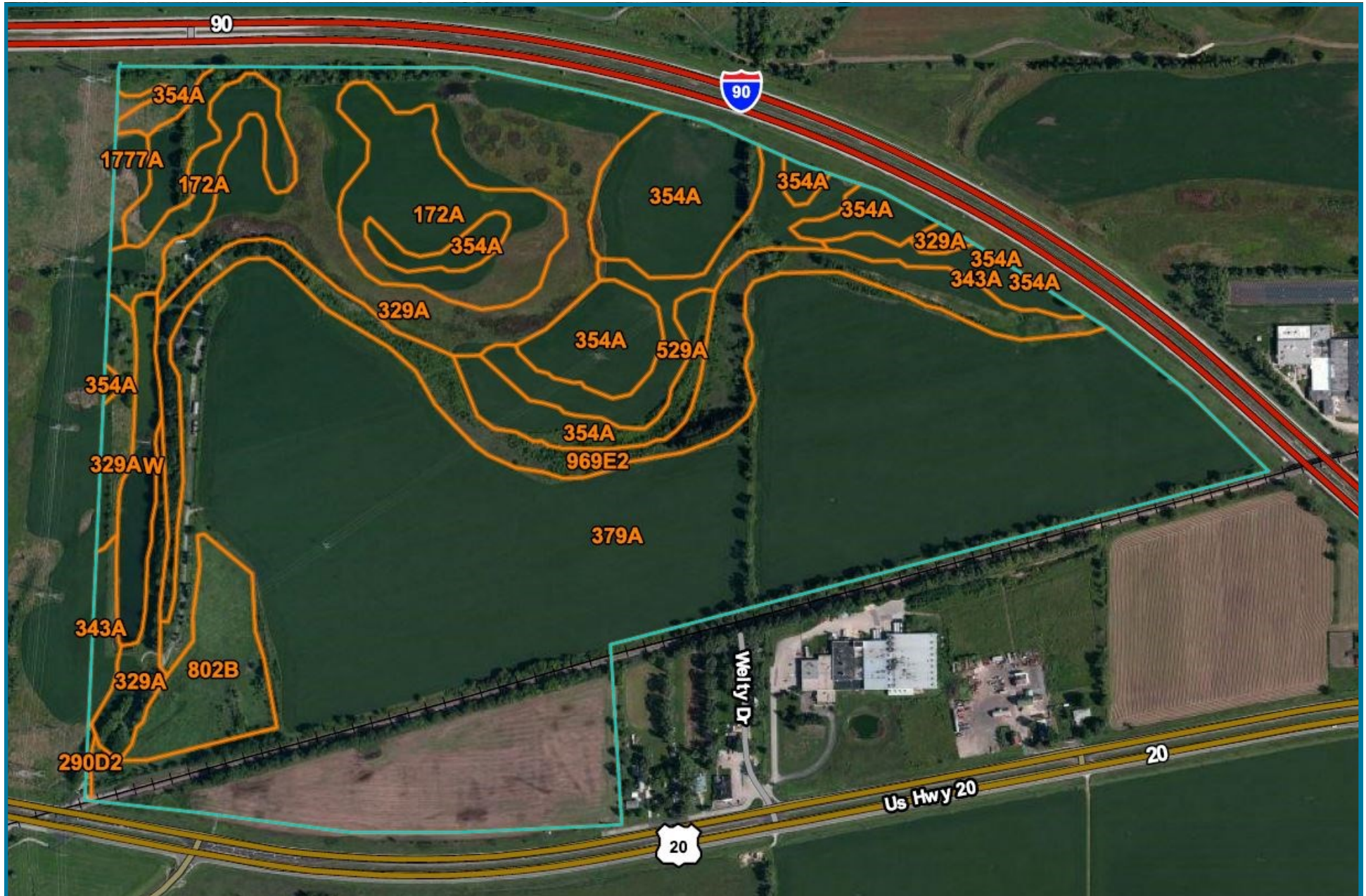
