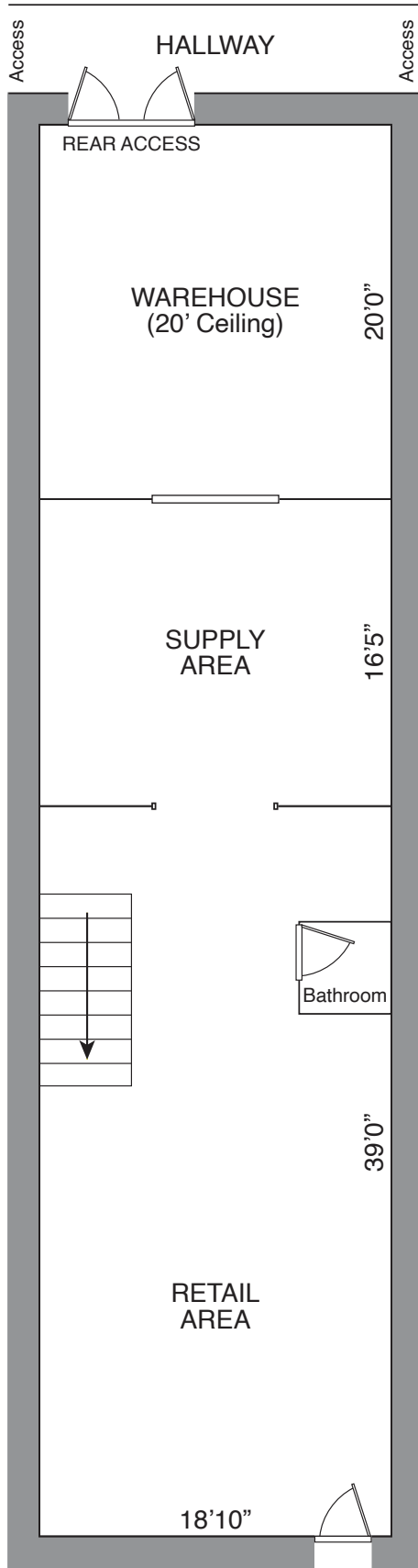

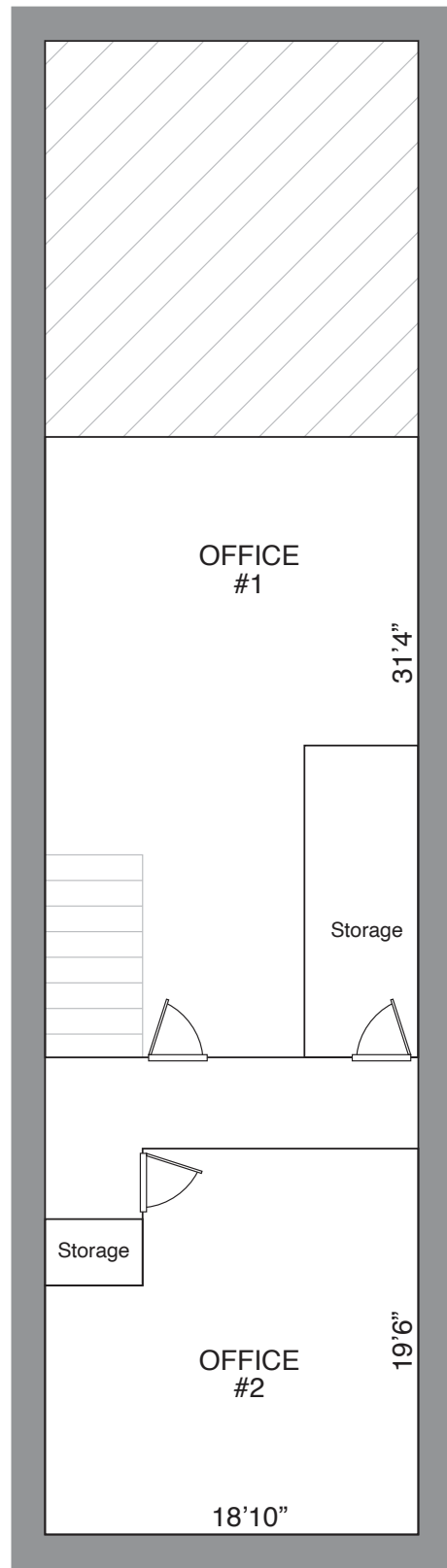

FIRST FLOOR

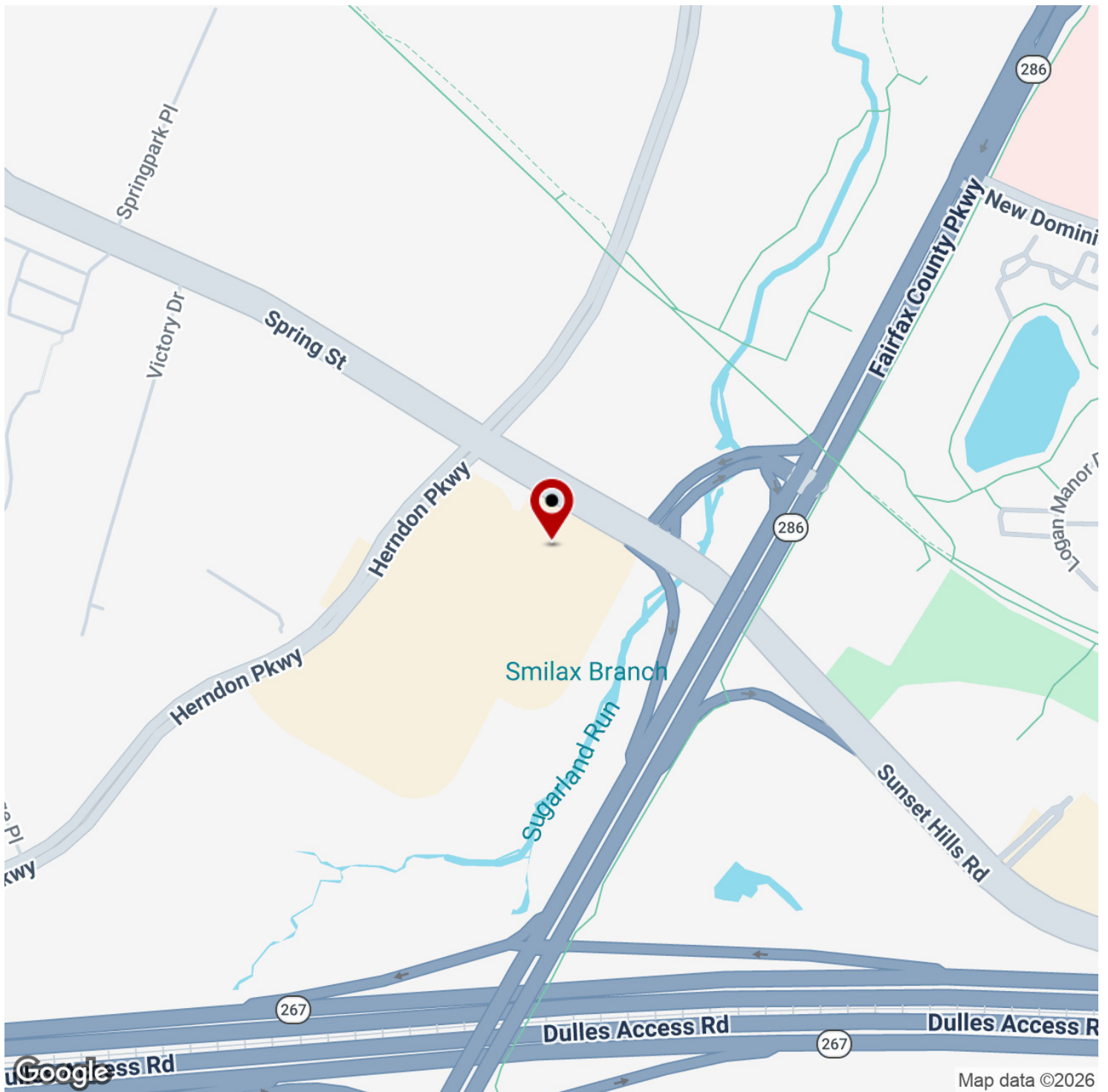


SECOND FLOOR

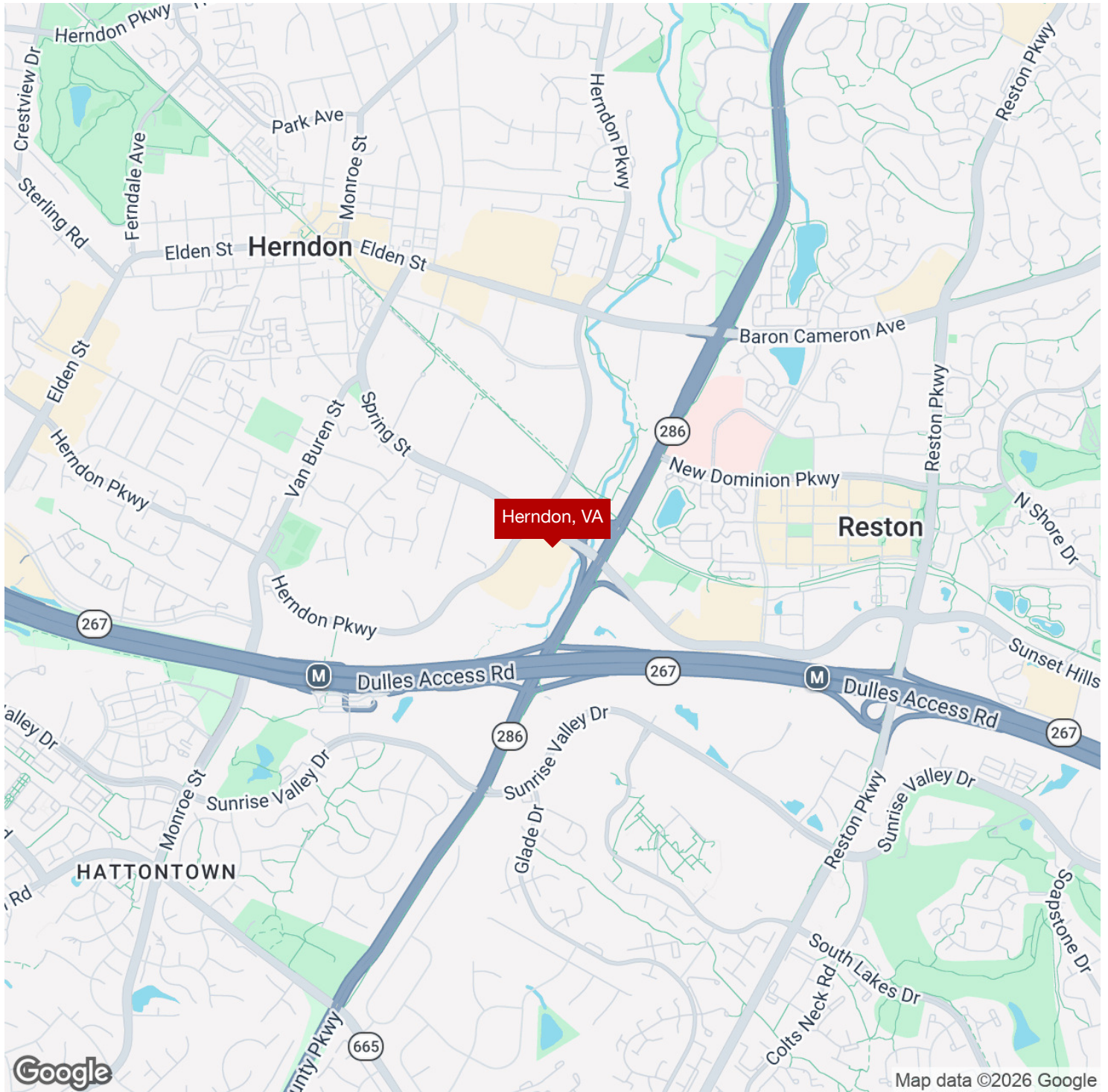

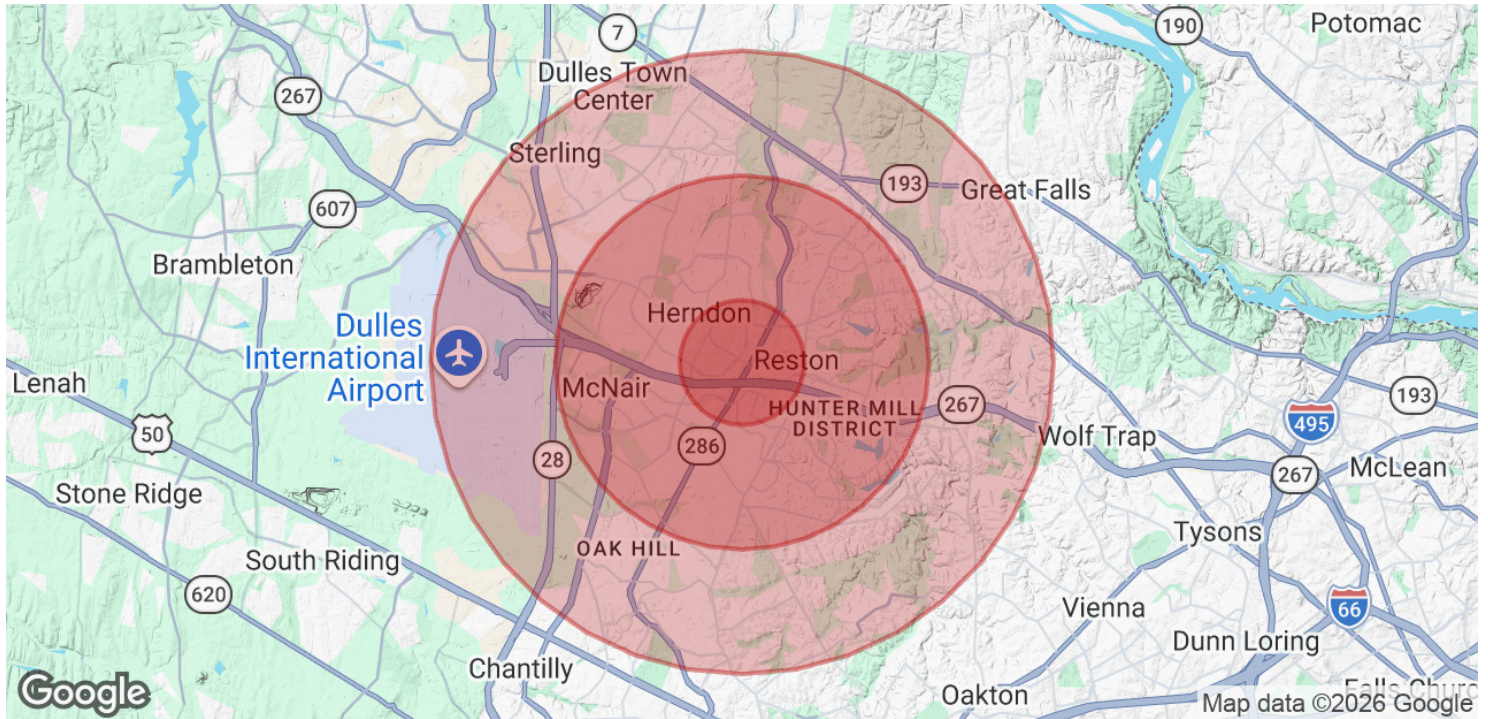
