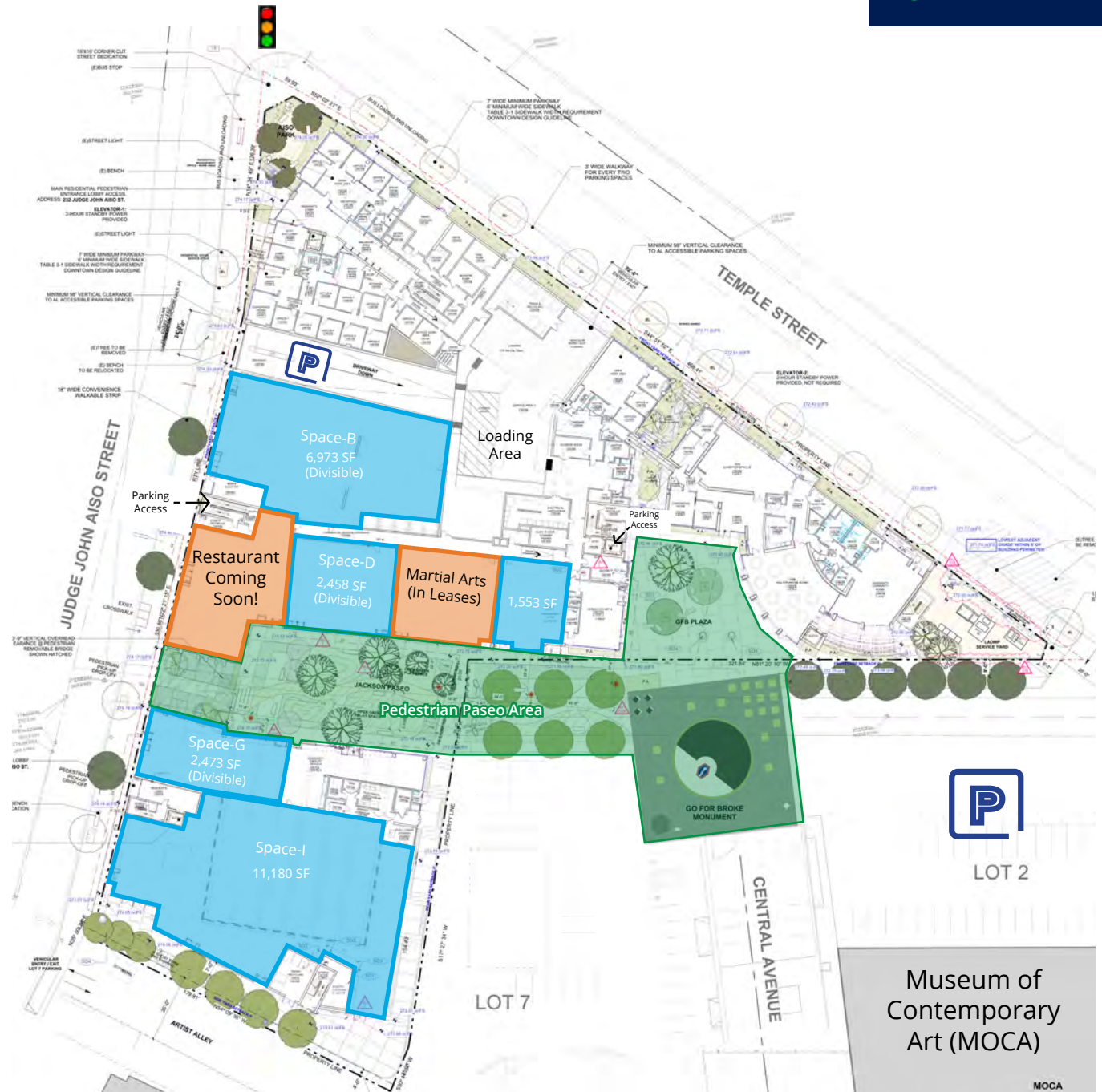

Little Tokyo is one of Los Angeles' most historic and vibrant neighborhoods, anchored by the Japanese American National Museum, MOCA Geffen, Japanese Village Plaza, and the Aratani Theatre. The district features a dynamic mix of restaurants, specialty retailers, creative office spaces, boutique hotels, and cultural institutions that attract both local patrons and destination visitors.

The location provides immediate access to the Metro A and E Lines at the Little Tokyo/Arts District Station, directly connecting the property to Downtown Los Angeles' core, the Arts District, and re-

gional transit routes. Its placement along Judge John Aiso Street—adjacent to prominent community landmarks and high-density multifamily developments—creates a built-in customer base and consistent year-round activity.

Located in the heart of Little Tokyo, The Project offers exceptional visibility and proximity to some of Downtown Los Angeles' most active cultural and commercial destinations. Positioned just steps from major pedestrian corridors and transit connections, the property benefits from consistent foot traffic, strong daytime activity, and a growing residential population.
