

How do your loans work?

We first need a loan application filled out. Once completed, we will notify you within 1-2 business days of your application status. Once approved, within 3 business days, we will hold your closing and fund your loan.

Am I eligible for your loan?

Our primary collateral is a Pennsylvania Liquor Control Board issued license, therefore, all applicants must be a licensee to qualify. Licensees must be issued one of the following licenses to qualify:

- Restaurant liquor license (R)
- Eating place retail dispenser (E)
- Distributor (D)
- Importing distributor (ID)

Can I payoff my loan early?

Of course! We do not charge any pre-payment penalties.
