

711 E Rose Street is located in South Smithfield off US Hwy 301/S Brightleaf Blvd behind a retail building and pre-owned auto dealership. The property is adjacent to a railroad line and consists of 7 buildings and is easily accessible from I-95, US 70 Hwy and I-40. The spaces are not conditioned, but provide basic warehouse storage.




