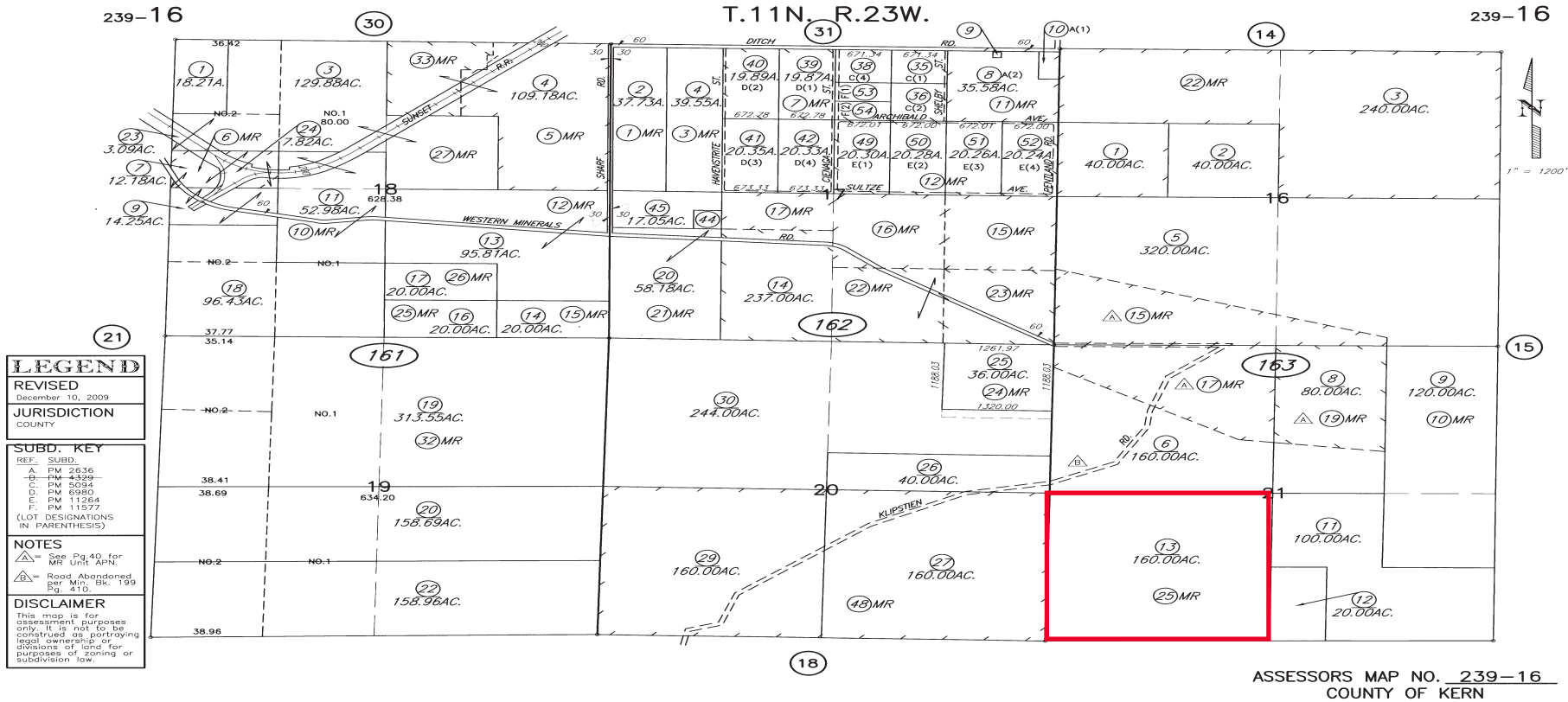

Parcel Map

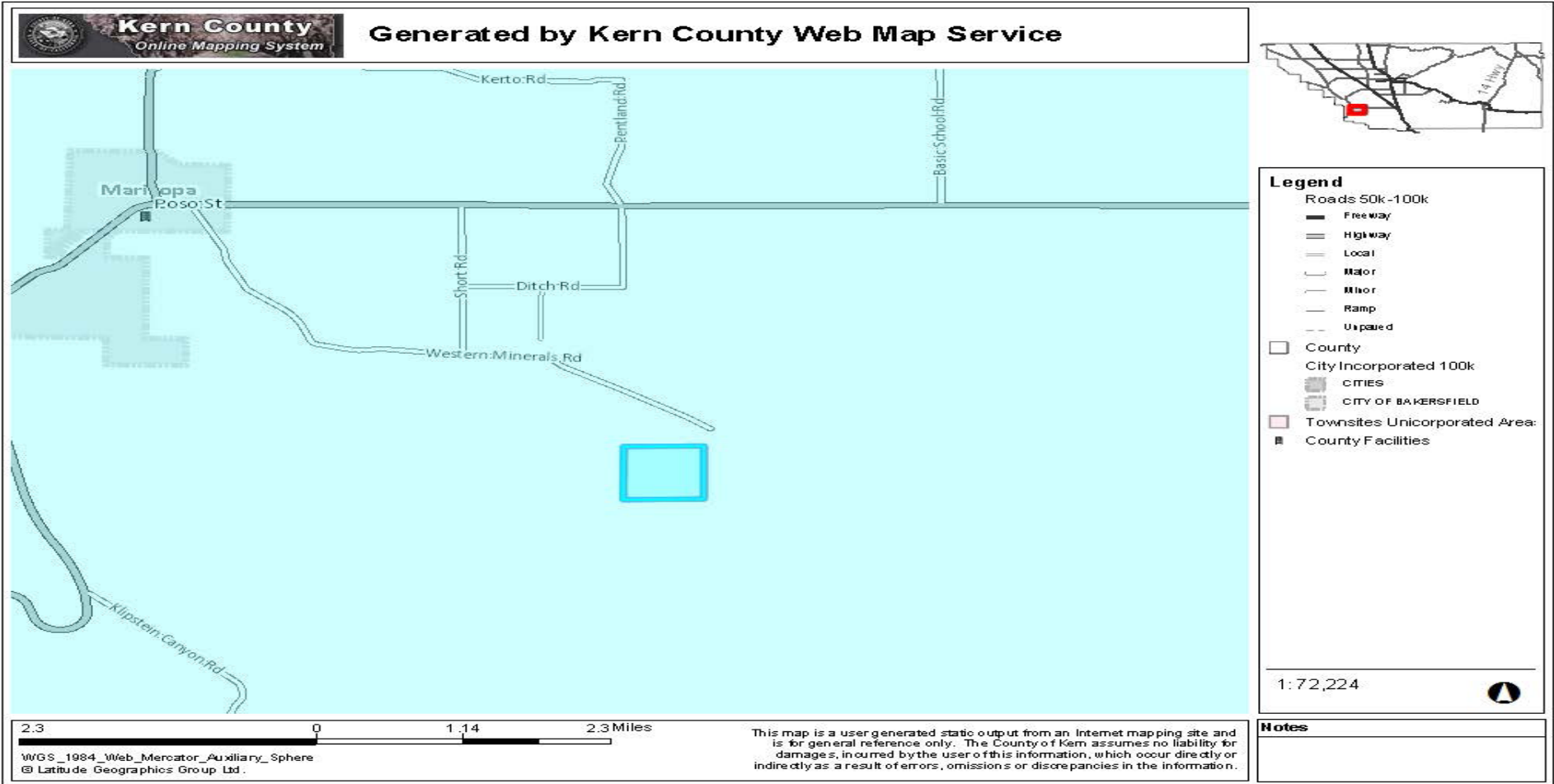
