CONCRETE MASONRY UNITS (CMU) - 8" UNLESS OTHERWISE NOTED FURRED GPDW ON CMU

ONE HOUR FIRE BARRIER (UL U419 OR U905) TWO HOUR FIRE/SMOKE BARRIER

- ALL WALLS SHALL EXTEND TO 6" ABOVE THE FINISHED CEILING OR TO FLOOR OR ROOF DECK ABOVE UNLESS NOTED OTHERWISE. SEE TYPICAL

- ALWAYS REFER TO PROVIDED DIMENSIONS. PROJECT MEASUREMENTS NOT TAKEN DIRECTLY FROM PROVIDED DIMENSIONS SUBJECT CONTRACTOR TO LIABILITY FOR ANY RESULTANT ERRORS.

- IT IS THE INTENT OF THESE DOCUMENTS TO INCLUDE INFORMATION NECESSARY FOR THE COMPLETION OF THE PROJECT. IT IS THE RESPONSIBILITY OF THE CONTRACTOR TO INQUIRE AS TO THE INTENT OF THE DRAWINGS IN AREAS THAT ARE IN QUESTION FOR MEANING AND

- CONTRACTOR IS RESPONSIBLE FOR ALL MEANS AND METHODS OF CONSTRUCTION AND SHALL CONSTRUCT WORK IN COMPLIANCE TO ALL APPLICABLE BUILDING CODES AND ORDINANCES.

- PROVIDE FIRE WATCH DURING FIELD CUTTING AND WELDING

- PROVIDE FIRE RETARDANT WOOD BLOCKING AND/OR 18 GA METAL PLATES BETWEEN STUDS AT ALL LOCATIONS REQUIRING BLOCKING IN WALL. THESE LOCATIONS INCLUDE BUT ARE NOT LIMITED TO GRAB BARS. CRASH RAILS, CABINETS, WALL HUNG SHELVES, ARTWORK, ETC.


