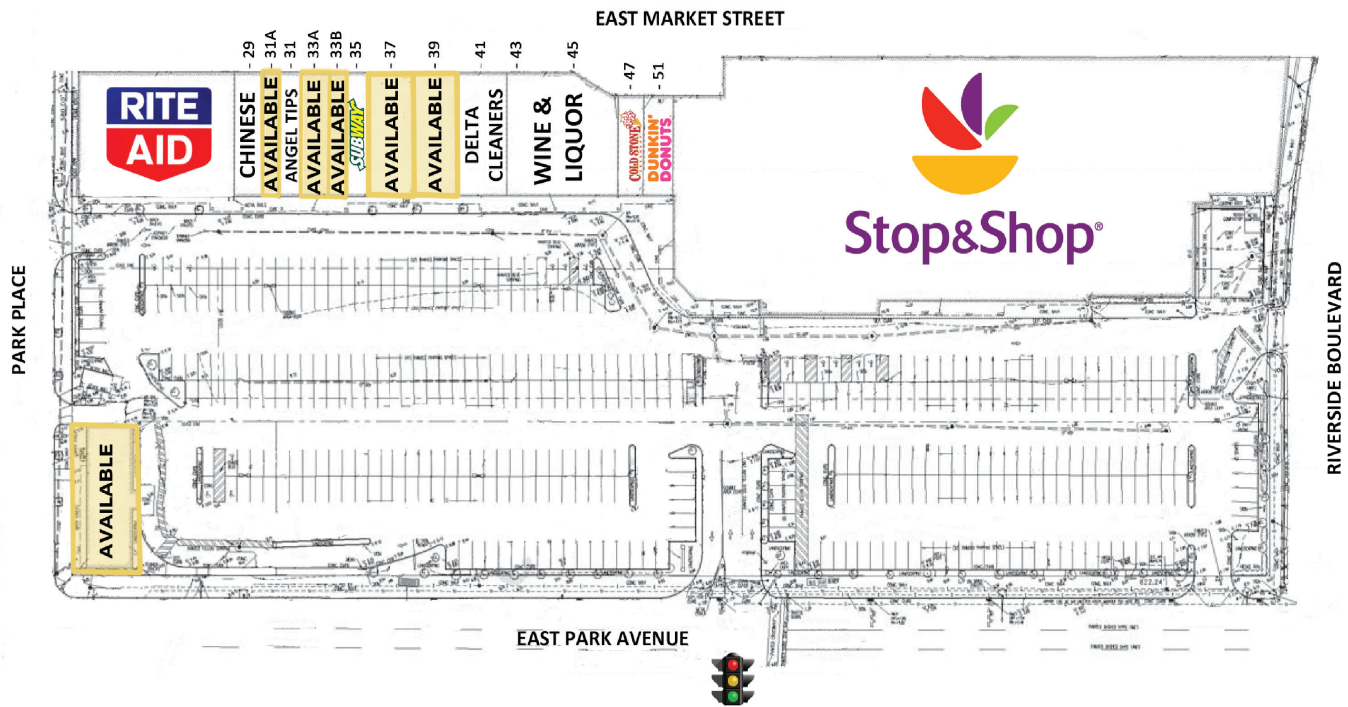

SITE PLAN

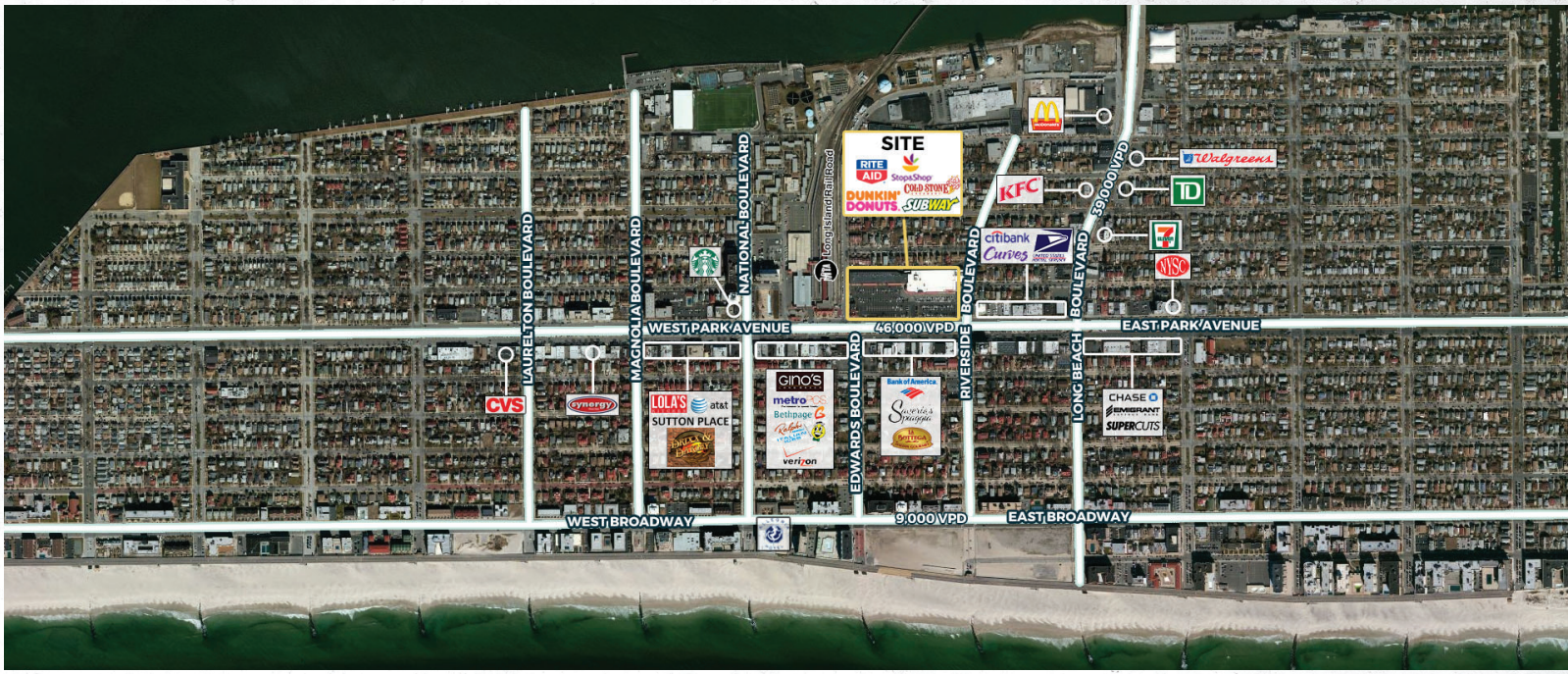
