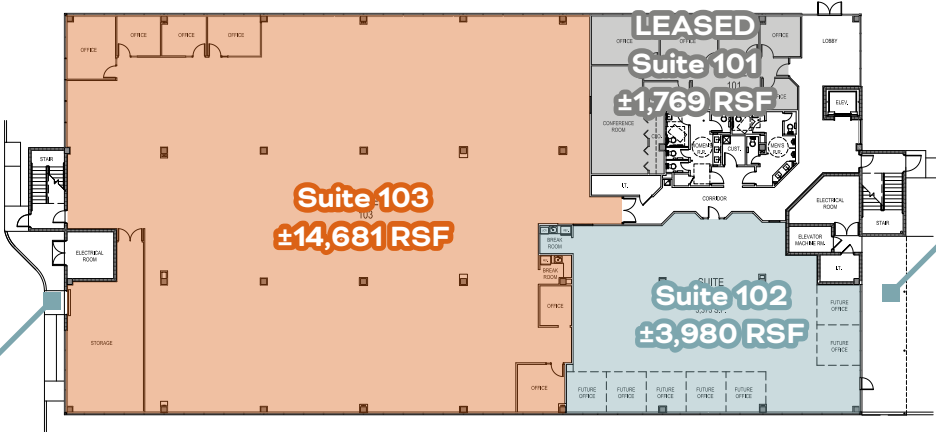

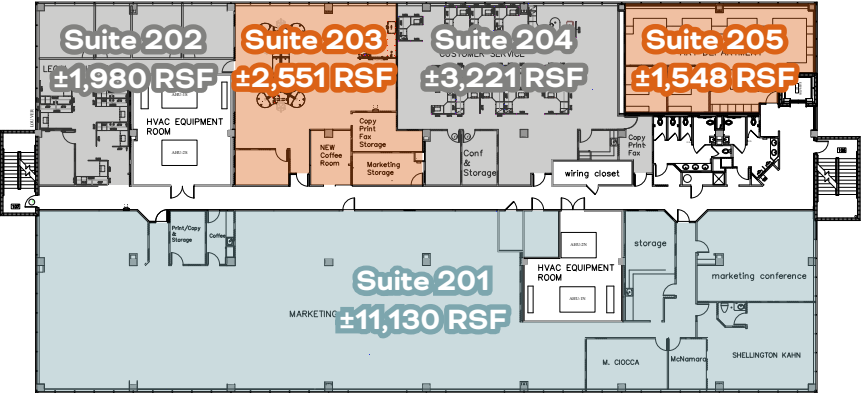

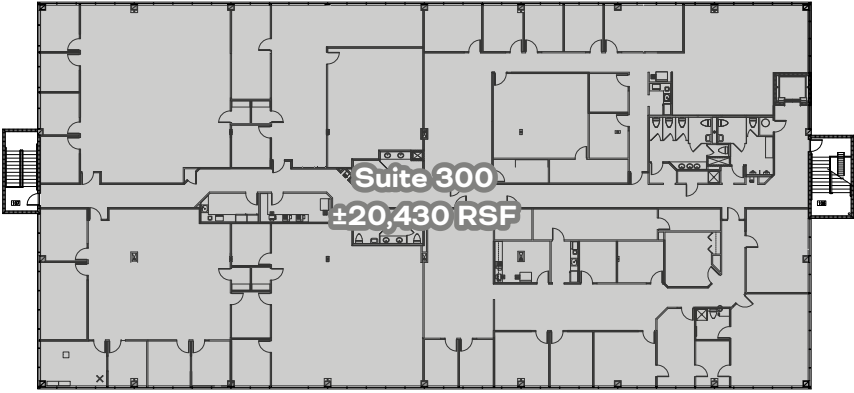


First Floor | ±20,430 SF

Covered outdoor seating

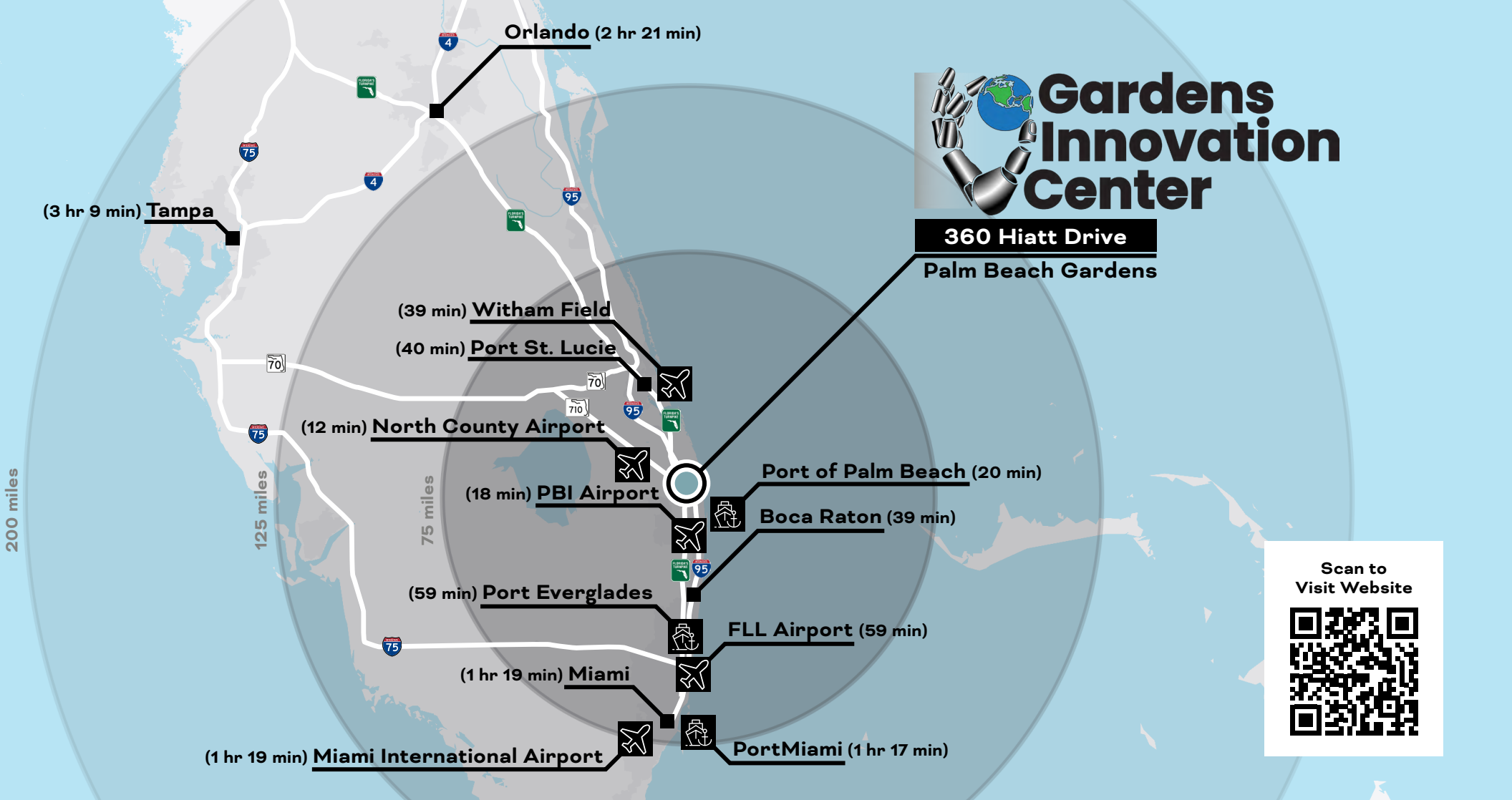


Second Floor | ±20,430 SF
