





The South Bend - Elkhart region is in a competitive position to attract and retain tech talent.

When people think of the South Bend - Elkhart region, heavy industry often comes to mind, but the area actually has a longstanding heritage of innovation and new ideas.

- The Elkhart-Goshen area was named 8th in the nation for semiconductor workforce readiness in a study completed in early 2023 by Lightcast.
- There are several local organizations and partnerships focused on fostering talent including the University of Notre Dame's Center for Civic Innovation, enFocus and Ivy Tech.
- Funded by a Lilly Endowment grant in 2019, South Bend - Elkhart is scaling and formalizing the regional innovation ecosystem with the launch of the Labs for Industry Futures and Transformation (LIFT) Initiative, and the associated iNDustry Labs at Notre Dame.



Data Center Sales Tax Exemption Program offered through the state on Indiana.

Provides a sales and use tax exemption on purchases of qualifying data center equipment and energy to operators of a qualified data center.


