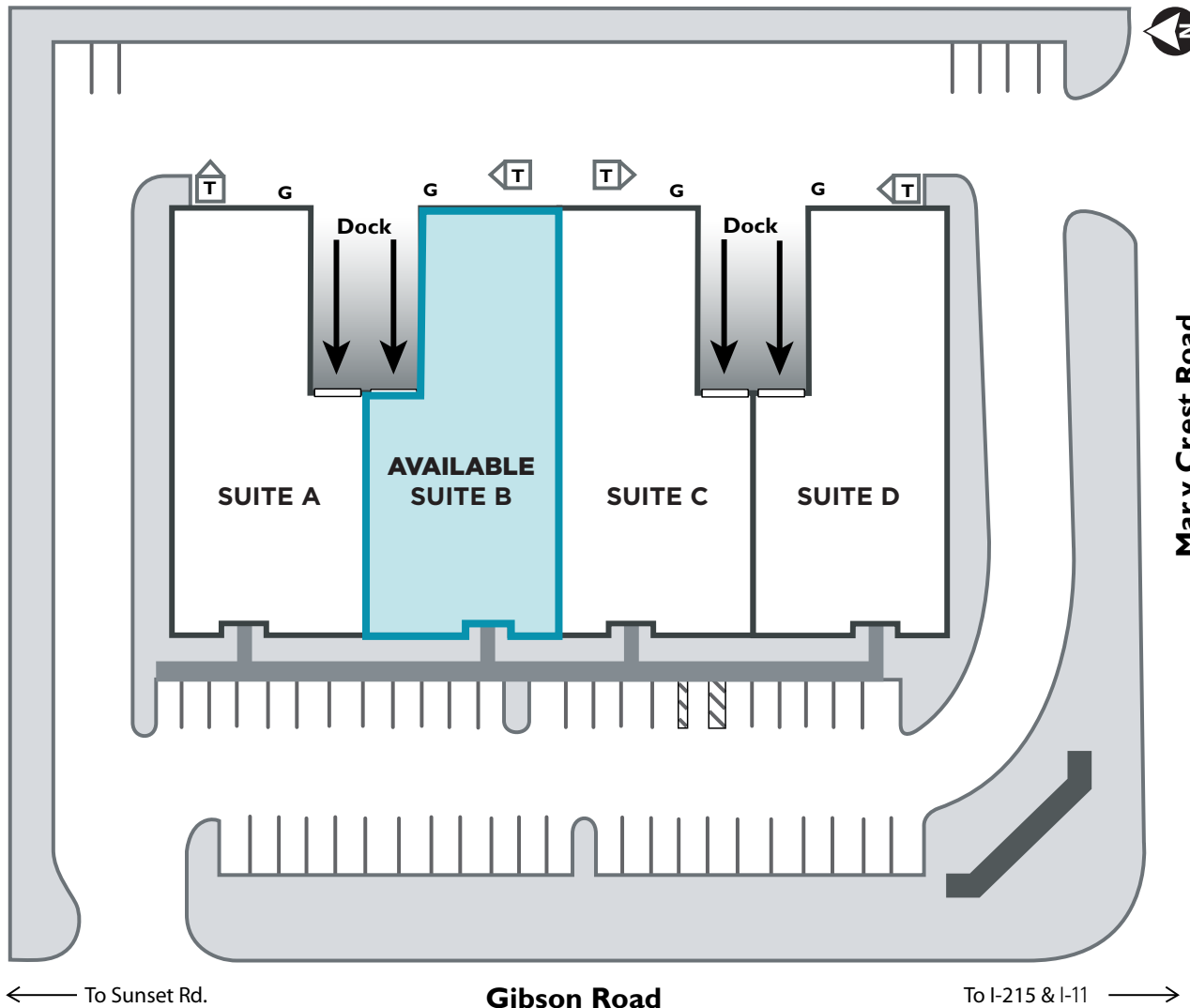

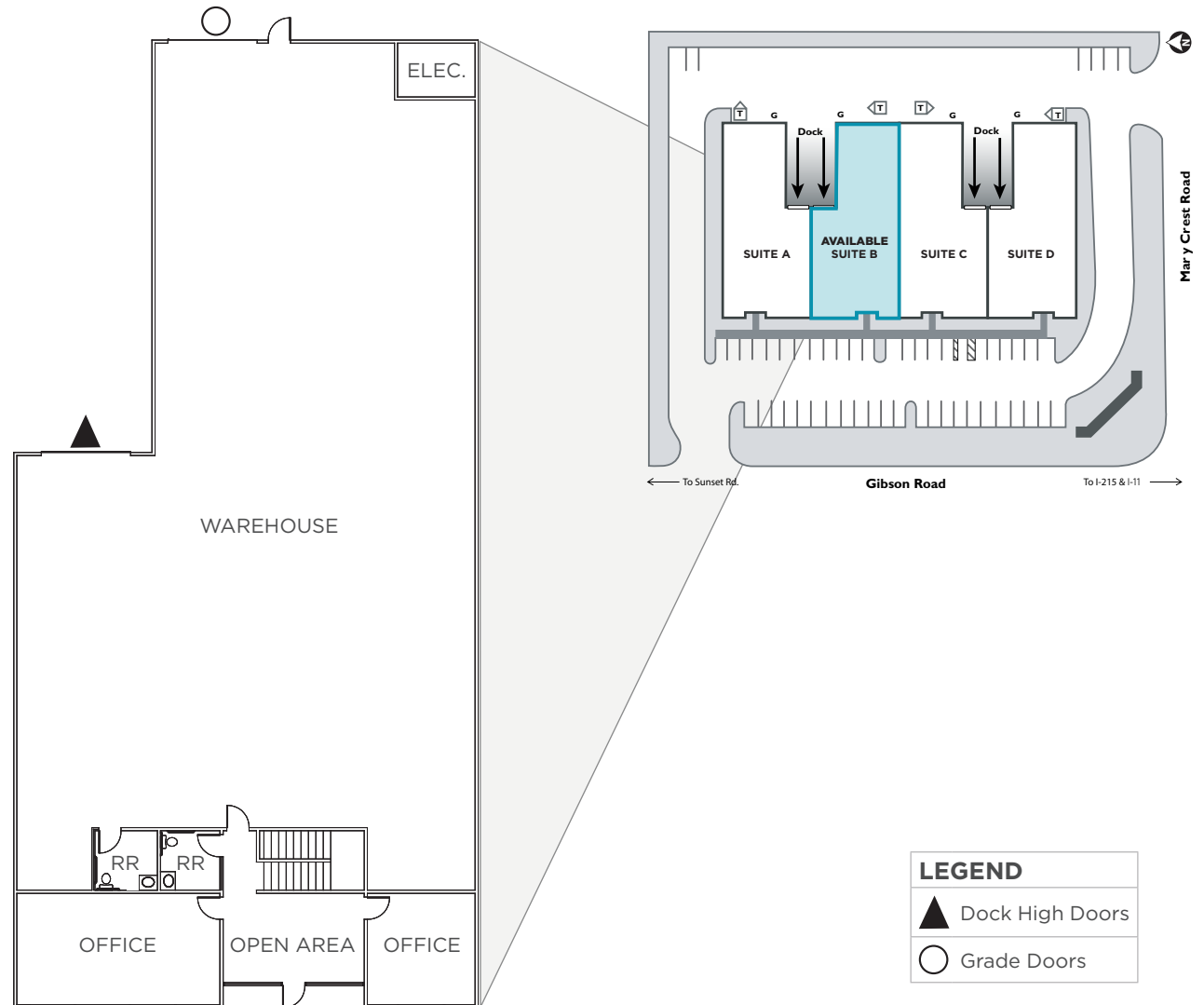

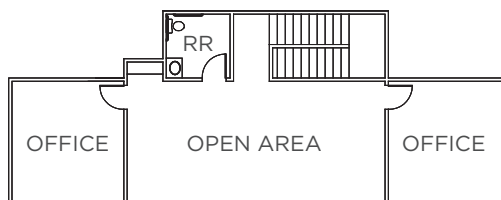

## 2ND FLOOR OFFICE LAYOUT

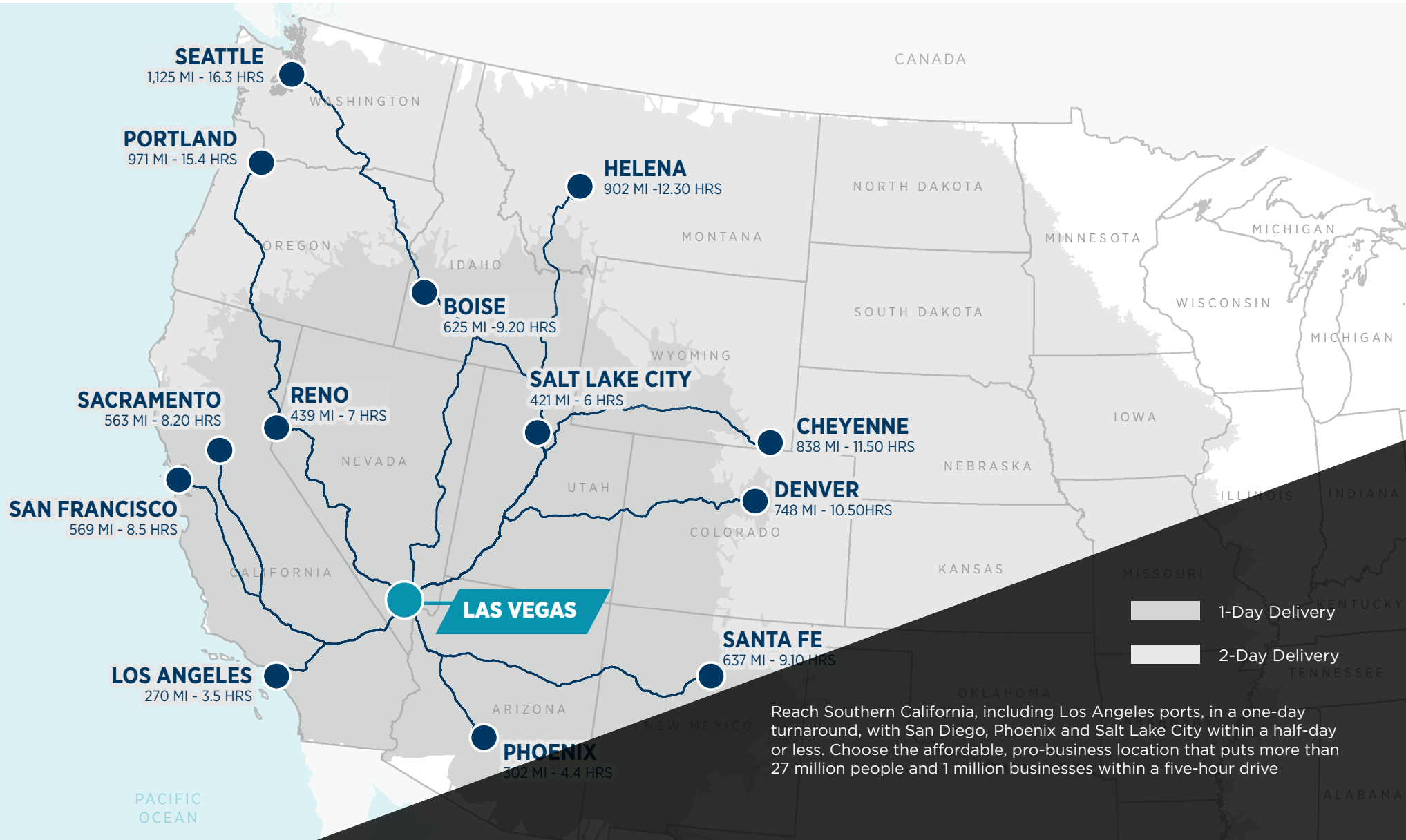
