People ask us all the time about who we are versus Valley Water. In a nutshell, they are the wholesaler for Santa Clara County (meaning they supply water to 13 different water utilities). We purchase treated water from Valley Water's three water treatment plants. In addition, Valley Water manages 333 miles of waterways or creeks in Santa Clara County. Valley Water determines the cost for both treated and groundwater every year through their rate setting process. The rates are approved by Valley Water's elected Board of Directors consisting of seven members. The water supply cost from Valley Water makes up about 40% of your bill.
