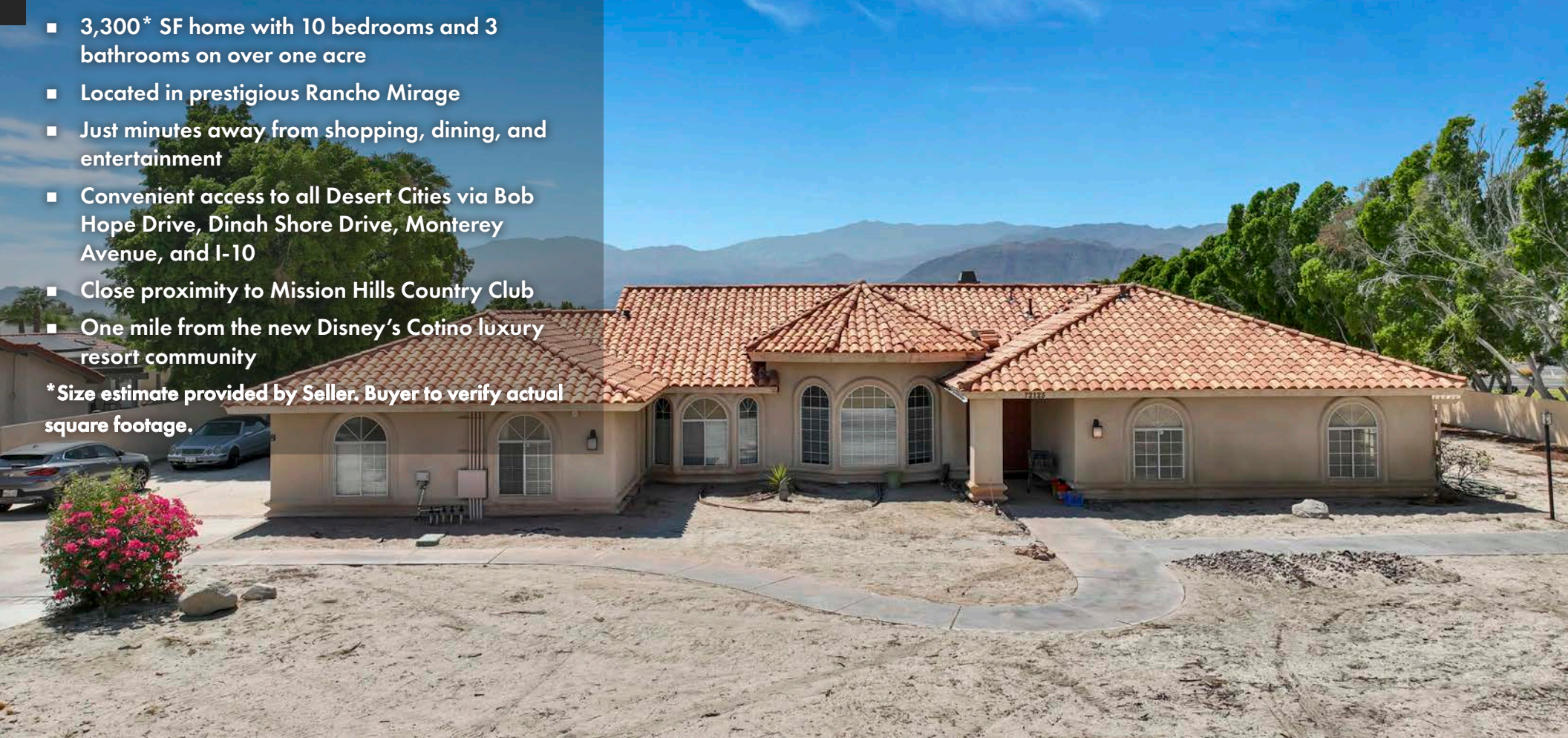

Rancho Mirage offers the perfect combination of luxury, value, and access to the finest golf, spa, and dining experiences right in the heart of the Palm Springs area.

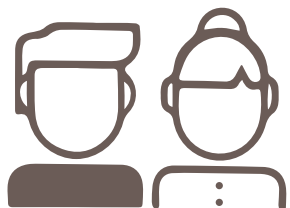
