COMMENCING AT THE NORTHEAST CORNER OF SAID SECTION 20 ALSO BEING THE NORTHWEST CORNER OF SAID SECTION 21; THENCE SOUTH 00°47'53" EAST, ALONG THE EAST LINE OF SAID SECTION 20, A DISTANCE OF 541.21 FEET TO THE SOUTHEAST CORNER OF LOT 16, BLOCK 5, PLAT OF COLUMBIA EAST 3, RECORDED IN VOLUME D OF PLATS, PAGES 102 AND 103, RECORDS OF FRANKLIN COUNTY, WASHINGTON SAID POINT ALSO BEING THE SOUTHWEST CORNER OF LOT 16 OF BINDING SITE PLAN 2011-03 RECORDED IN VOLUME 1 OF BINDING SITE PLANS, PAGE 140 RECORDS OF FRANKLIN COUNTY, WASHINGTON AND THE TRUE POINT OF BEGINNING;

THENCE NORTH 68°05'59" WEST, ALONG THE SOUTH LINE OF LOT 16 OF SAID PLAT OF COLUMBIA EAST 3, A DISTANCE OF 139.24 FEET TO THE NORTHEAST CORNER OF LOT 15 OF SAID PLAT OF COLUMBIA EAST 3; THENCE SOUTH 28°09'01" WEST ALONG THE EASTERLY LINE OF SAID LOT 15 A DISTANCE OF 372.21 FEET; TO THE SOUTHEAST CORNER OF SAID LOT 15 BEING A POINT ON THE ARC OF A NON TANGENT CURVE IN THE NORTHERLY RIGHT OF WAY OF NORTH COMMERCIAL AVENUE TURNING TO THE LEFT, HAVING A RADIUS OF 1,448.04 FEET; THE RADIUS POINT OF WHICH BEARS NORTH 28°08,52" EAST; THENCE ALONG SAID CURVE, HAVING AN ARC LENGTH OF 157.28 FEET, WITH A DELTA ANGLE OF 06°13'23", A CHORD BEARING OF SOUTH 64°57,50" EAST, AND A CHORD LENGTH OF 157.20 FEET; THENCE SOUTH 68°04'31" EAST A DISTANCE OF 132.74 FEET; THENCE NORTH 21°55'29" EAST LEAVING THE NORTHERLY RIGHT OF WAY OF SAID NORTH

COMMERCIAL AVENUE A DISTANCE OF 36.82 FEET; TO A POINT OF CURVATURE WITH A TANGENT CURVE TURNING TO THE LEFT, HAVING A RADIUS OF 200.00 FEET; THENCE ALONG SAID CURVE, HAVING AN ARC LENGTH OF 79.24 FEET, WITH A DELTA ANGLE OF 22°42′00", A CHORD BEARING OF NORTH 10°34′29" EAST, AND A CHORD LENGTH OF 78.72 FEET; THENCE NORTH 00°46′31" WEST A DISTANCE OF 158.00 FEET; TO A POINT OF CURVATURE WITH A TANGENT CURVE TURNING TO THE RIGHT, HAVING A RADIUS OF 200.00 FEET; THENCE ALONG SAID CURVE, HAVING AN ARC LENGTH OF 79.24 FEET, WITH A DELTA ANGLE OF 22°42′00", A CHORD BEARING OF NORTH 10°34′29" EAST, AND A CHORD LENGTH OF 78.72 FEET; THENCE NORTH 21°55′29" EAST A DISTANCE OF 41.67 FEET TO A POINT IN THE SOUTH LINE OF LOT 16 OF SAID BINDING SITE PLAN 2011-03; THENCE NORTH 68°05′59" WEST ALONG THE SOUTH LINE OF LOT 16 OF SAID BINDING SITE PLAN 2011-03 A DISTANCE OF 18.15 FEET TO THE TRUE POINT OF BEGINNING.
