

CONFIDENTIALITY AGREEMENT

The Informational Materials will be used solely for the purpose of the Potential Purchaser and may not be copied or duplicated without Owner's written consent. The Informational Materials may be disclosed to the Potential Purchaser's partners, employees, legal counsel and institutional lenders ("Related Parties"), solely for the purpose of evaluating the potential purchase of the Property. The Potential Purchaser understands and acknowledges that KWRBM and the Owner do not make any representations or warranty as to the accuracy or completeness of the Informational Materials and that the information used in the preparation of the Informational Materials was furnished to KWRBM by others and has not been independently verified by KWRBM and is not guaranteed as to completeness or accuracy.

The Potential Purchaser hereby indemnifies and holds harmless KWRBM and the Owner and their respective affiliates and successors and assigns against and from any loss, liability or expense, including attorney's fees, arising out of any breach of any of the terms of this agreement.

The Potential Purchaser acknowledges that the Property is being offered to Potential Purchaser only as a Principal and Potential Purchaser will not pay or receive any brokerage commission from any party in connection with this transaction.

The Potential Purchaser acknowledges that the Property has been offered for sale subject to withdrawal from the market, change in offering price, prior sale or rejection of any offer because of the terms thereof, lack of satisfactory credit references of any Potential Purchaser, or for any other reason whatsoever, without notice and without regard to race, creed, sex, religion or national origin. This agreement terminates one (1) year from the date hereof except as to written claims by Owner against Potential Purchaser prior thereto.
