REDUNDANT SYSTEMS



- 6,000 amp, 480/270 volt, three-phase, four-wire electrical system in place.
- Back-up power provided by three 1,500 KW diesel generators with a 20,000 gallon fuel tank providing 100% power to the building for 8-10 days.
- Raised flooring throughout for maximum cabling and workstation flexibility.

AREA AMENITIES



5202 Presidents Court is located just south of the City of Frederick, which is located in the center of Frederick county. The City of Frederick, Baltimore and Washington D.C. form the points of triangle connected by Interstate 270 running southeast from Frederick to Washington, Interstate 70 running east from Frederick to Baltimore and Interstate 95 running southwest from Baltimore to Washington.

The state-operated MARC commuter train provides service between the City of Frederick and Washington's Union Station. Amtrak, Baltimore/Washington International Airport (BWI), Dulles International Airport and Reagan national Airport serve the region as well.

- 5202 Presidents Court is conveniently located at the intersection of Interstates 270 and 70 which is just south of the City of Frederick.
- Proximate amenity base includes Westview Corner, Westview Promenade, Westview Village and Francis Scott Key Mall.
- The site is surrounded by several shopping centers and within walking distance to several hotels, fitness center, restaurants, retail and entertainment options.
